## I. Preliminari

Rat ir-rikors ipprezentat fit-30 ta` Jannar 2015 li jaqra hekk :-

*Illi permezz ta` ftehim datat 12 ta` Mejju 2010 is-socjeta` rikorrenti kienet giet inkarikata bhala Manager tal-bastiment MARIEKE li dak iz-zmien kien nollegjat mis-socjeta` intimata ;*

*Illi in segwitu inqalghu xi divergenzi bejn il-kontendenti li wasslu sabiex permezz ta` lodo arbitrali moghti gewwa Londra tat-30 ta` Settembru 2011 u sussegwentement dikjarat bhala ezegwibbli gewwa Spanja skont sentenza moghtija mill-Qorti ta` Valencia gewwa Spanja fis-27 ta` Lulju 2012, l-imsemmi lodo gie dikjarat ezegwibbli gewwa Spanja riferibbilment ghall-ammont ta` US\$ 353,274.89 li skont ir-rata tal-kambju vigenti tekwivali ghal € 304,881.16 ;*

*Illi in segwitu ta` arrest tal-imsemmi bastiment MARIEKE u proceduri dwar l-arrest in kwistjoni, b`sentenza tal-Qorti ta` Valencia gewwa Spanja, is-socjeta` rikorrenti giet kundannata thallas lis-socjeta` intimata s-somma ta` € 137,349.19 ;*

*Illi in vista tal-premess u wara li jigu pacuti z-zewg krediti rispettivi, s-socjeta` rikorrenti tibqa` kreditur tas-socjeta` intimata fis-somma ta` € 167,531.97, liema somma sal-lum ghadha dovuta ;*

*Illi huwa evidenti illi s-socjeta` intimata mhijiex f`qaghda li thallas il-kredituri taghha ;*

*Illi fuq kollox is-socjeta` rikorrenti ghandha x`tifhem illi s-socjeta` intimata mhijiex topera u n-negozju taghha ilu sospiz zmien ghal perjodu ta` aktar minn tnax-il xahar ;*

*Ghaldaqstant l-esponenti jitolbu lil din l-Onorabli Qorti sabiex :-*

Rat ir-risposta li pprezentaw il-kuraturi deputati fid-29 ta` Lulju 2015 fejn iddikjaraw li ma kienux edotti mill-fatti tal-kawza u ghalhekk Irriservaw li jipprezentaw risposta ulterjuri jekk ikun il-kaz.

Semghet ix-xiehda ta` Nicholas Wurth fl-udjenza tat-12 ta` Novembru 2015.

Semghet ix-xiehda ta` Michael Savona fl-udjenza tal-14 ta` Jannar 2016, u rat id-dokument li pprezenta.

Rat l-atti pprezentati mill-kuraturi deputati fit-8 ta` Frar 2016.

Rat id-digriet li tat fl-udjenza tat-22 ta` Marzu 2016 fejn halliet il-kawza ghas-sentenza ghal-lum.

Rat l-atti l-ohra tal-kawza.

## **II. Xiehda**

**Nicholas Wurth** xehed illi huwa direttur u azzjonista tas-socjeta` rikorrenti li topera bastimenti. Ir-rikorrenti hija bbazata Geneva u ghandha ufficju Amsterdam. Fix-xahar ta` April 2010, is-socjeta` ntimata ffirmat *ship management agreement* mar-rikorrenti. Din bdiet topera l-bastiment peress li s-socjeta` intimata kellha bastiment li kien fuq *bareboat charter* minghand is-sidien. Ir-rikorrenti kienet ix-*ship manager* u kellha struzzjonijiet sabiex jithallsu kontijiet skont il-kuntratt. Fix-xahar ta` Ottubru 2010, il-pagamenti waqfu u ghalhekk saret laqgha ma certu Mena, direttur tas-socjeta` intimata. Mena qal li ser ihallas il-kontijiet aktar tard. Madanakollu l-kontijiet ma thallsux u fix-xahar ta` Novembru kien hemm bilanc dovut ta` US\$ 300,000. Ghalhekk ir-rikorrenti rriżenjat minn *ship manager*. Il-ftehim kien itterminat formalment. Malli l-bastiment wasal go port Spanja, kien arrestat.

Kompla jghid illi wara l-arrest, il-bastiment kien rilaxxjat u saru proceduri ta` arbitragg go Londra. L-arbitragg kien deciz fix-xahar ta` Ottubru 2011. Fil-lodo kien ikkonfermat il-kreditu dovut lis-socjeta` rikorrenti. Id-decizjoni arbitrali kienet validata minn Qorti Spanjola.

Stqarr illi s-socjeta` ntimata hadet azzjoni legali ghal danni minhabba l-arrest tal-bastiment bl-esitu tal-azzjoni jkun likwidazzjoni favur is-socjeta` ntimata ta` €137,000. Wara tpacija bejn dak li kellha t-tiehu r-rikorrent u dak li kellha tircievi s-socjeta` ntimata baqghu dovuta lir-rikorrenti s-somma ta` €167,000. Ghalkemm is-socjeta` ntimata ntalbet thallas hija baqghet inadempjenti. Il-bilanc ta` €167,000 ghadu dovut.

Fisser illi l-bastiment MARIEKE kien proprjeta` ta` kumpannija Germaniza. Is-socjeta` intimata kienet ghamlet *bareboat hire purchase* tal-vapur. Il-ftehim intemm fix-xhur ta` Novembru jew Dicembru 2010, peress li s-socjeta` ntimata ma kenitx qeghda thallas il-kera. Il-*bareboat hire purchase* kien registrat Malta.

Sostna li s-socjeta` intimata ma ghandhiex assi ohra billi hija *shell company*. L-iskop tas-socjeta` intimata kien illi tiehu bastiment b` *bareboat contract* u ma kellha l-ebda ghan iehor. Mena u s-socjeta` ntimata kienu fi stadju iehor hadu is-*ship management* izda waqfu peress li ma kellhomx il-kwalifiki.

Qal illi l-ahhar negozju li sar mis-socjeta` intimata kien fl-ahhar tal-2010.

**Michael Savona** – Assistant Registratur tal-Bahhara u Bastimenti – Transport Malta – xehed illi s-socjeta` ntimata kellha vapur registrat fuq isimha bhala *charterer*. Il-vapur m`ghadux aktar registrat taht il-bandiera Maltija b`effett mit-28 ta` Frar 2011. Is-sid tal-vapur hija kumpannija Germaniza.

### III. Dritt

Skont il-*memorandum of association* tas-socjeta` intimata jirrizulta li s-socjeta` hija “*registered under the Merchant Shipping (Shipping Organisations - Private Companies) Regulations 2004, Legal Notice 223, and qualifying as a shipping organization in terms of Article 84Z of the Merchant Shipping Act.*”

Il-ligi applikabbli ghal dak il-kaz huwa l-**A.L. 223 tal-2004**.

### IV. Locus standi

L-eligibilita` o meno tar-rikorrenti sabiex tmexxi bl-azzjoni tal-lum hija trid titqies skont ma jghid l-**Art 100** tal-**A.L. 223 tal-2004** li jghid :-

*An application to the court (hereinafter referred to as the "winding up application") for the winding up of a company shall be made by means of an application which may be made either by the company or by any of its members or directors, or by any creditor having a debt due and unpaid in excess of twenty-three thousand and two hundred and ninety-three euros and seventy-three cents (23,293.73) or by all or any of them together or separately.*

Jirrizulta ppruvat illi r-rikorrent hija kreditur tas-socjeta` ntimata fl-ammont ta` €167,531.97.

Dan il-kreditu huwa ppruvat mid-deposizzjoni ta` Nicholas Wurth u mid-dokumenti esebiti fosthom il-lodo arbitrali moghti Londra fit-30 ta` Settembru 2011 (fol 14 et seq), id-dikjarazzjoni li l-lodo huwa ezegwibbli gewwa Spanja fis-27 ta` Lulju 2012 (fol 30 et seq) u sentenza tal-Qorti ta` Valencia gewwa Spanja tat-23 ta` Lulju 2014 (fol 35).

Ghalhekk ir-rikorrenti ghandha *locus standi* sabiex tittenta l-azzjoni.

## V. It-talbiet

Ir-rikorrenti qeghda titlob ix-xoljiment u l-istralc tas-socjeta` ntimata abbazi tar-**Reg 99(2)(a) u (4)(b) tal-A.L. 223 tal-2004**.

Id-disposizzjonijiet citati mir-rikorrenti jghidu hekk :-

(2) *In addition to the modes of dissolution ...*

(a) *a company may be dissolved and wound up by the Court when the company is unable to pay its debts ...*

(4) *For the purposes of subregulation (2)(a), a company shall be deemed to be unable to pay its debts ...*

(b) *if it is proved to the satisfaction of the court that the company is unable to pay its debts, account being taken also of contingent and prospective liabilities of the company.*

Il-Qorti tghid illi l-linja ta` guriprudenza ta` din il-Qorti dwar dawn id-disposizzjonijiet tal-Kap 386 tghodd *mutatis mutandis* ghar-Reg 99(2)(a) u 4(b) tal-A.L. 223 tal-2004. Ghalkemm il-lista hija twila, tirreferi biss ghal wahda minn dawn id-decizjonijiet, cioe` dik tal-15 ta` ta` Settembru 2014 fil-kawza "**Galleria Management Limited (C19258) v. Derby International Limited (C12482)**". A skans ta` repetizzjoni tirreferi ghad-dottrina u ghall-guriprudenza citata f`din id-decizjoni.

Ghal dawk li huma provi u risultanzi, il-kuraturi deputati li kienu mahtura sabiex jirrapprezentaw lis-socjeta` ntimata baqghu mal-linja inizjali tagghom illi baqghu mhux edotti mill-fatti tal-kaz u ghalhekk irrimettew ruhhom ghad-decizjoni tal-Qorti.

Fuq l-iskorta tal-provi akkwiziti, u fl-isfond tad-decizjonijiet tal-Qrati taghna, il-Qorti hija tal-fehma li saret il-prova tat-talbiet tar-rikorrenti sal-grad rikjest mil-ligi.

Ghalkemm il-Qorti m`ghandhiex id-dokumenti tal-kontabilita` tas-socjeta` ntimata, ghandha l-prova (a) li s-socjeta` ntimata hija midjuna mar-rikorrenti ghal ammont li jaqbez il-€167,000 (b) li m`ghandhiex assi biex thallas dan id-dejn (c) li l-bastiment *Marieke* ma kienx propjeta` taghha (d) li m`ghandhiex bastimenti ohra (e) li l-*Marieke* kien registrat fir-Registru Malti mis-socjeta` ntimata stess sat-28 ta` Frar 2011 ghaliex kellha *bareboat charter* (f) in segwitu rriverta lura ghand is-sidien u (g) is-socjeta` ntimata waqfet topera lejn l-ahhar tal-2010. Da parti tas-socjeta` intimata, ma tressqu l-ebda provi sabiex juru li ttiehdu xi mizuri sabiex jitqajjem in-negozju u l-passiv dovut jigi mhallas. Bid-dejn li ghandha li baqa` mhux imhallas ghaliex m`ghandhiex mnejn thallsu, is-socjeta` ntimata poggiet ruhha f`qaghda li ma tistax thallas id-djun taghha ghall-finijiet u effetti kollha tal-ligi. U propju ghaliex waqfet in-negozju mhux se jibqa` tama li thallas l-obbligi taghha. Wieqaf in-negozju, jieqaf id-dhul u l-esistenza stess tas-socjeta` ntimata. Ghalhekk ma hemmx triq ohra hlief li tkun xjolta u stralcjata minn din il-Qorti.
