Andrey Timoshin

Today, the 12th of August, 2016

The Court,

Having seen that the accused Andrey Timoshin, holder of Russian ID Card DB0415923.

Was charged with having on the 10th of August 2016 in the Maltese islands;

1. assaulted or resisted by violence or active force not amounting to public violence, a person lawfully charged with public duty, that is, WPS 238 Antonella Vella and WPC 60 Grace Bianco when they were in the execution of the law or of a lawful order issued by a competent authority, according to article 96 of Chapter 9 of the Laws of Malta;
2. committed slight injuries on the person of WPS238 Antonella Vella and WPC 60 Grace Bianco as certified by Dr. Stefan Camilleri MD 1771 of Floriana Health Centre
3. disobeyed the lawful order of any authority or of any person entrusted with a public service, or hindered or obstructed such person in the exercise of their duties, or duly interfered with the exercise of such duties, either by preventing other persons from doing what they are lawfully enjoined or allowed to do, or frustrating or undoing what has been lawfully done by other persons, or in any other manner whatsoever, in breach of article 338(ee) of Chapter 9 of the Laws of Malta.

4. had in his possession (otherwise than in the course of transit through Malta of the territorial waters thereof) the resin obtained from the plant Cannabis, or any other preparation of which such resin formed the base, in terms of Section 8 (a) of Chapter 101 of the Laws of Malta

Seen request by the prosecution to apply Section 533(1) of Chapter 9 of the Laws of Malta, as regards to the expenses incurred by the Court appointed Experts;

Heard guilty plea by the accused which was confirmed by the accused after been given enough time to reconsider;

Having seen that the accused is still a minor and that he pleaded guilty at the initial stages of the proceedings; and

Having seen article of the Law, i.e. Articles 96, 221 and 338(ee) of Chapter 9 of the Laws of Malta and Article 8(a) of Chapter 101 of the Laws of Malta, finds accused Andrey Timoshin guilty of all charges brought against him and by virtue of Article 28A of Chapter 9 of the Laws of Malta condemns him to three (3) months imprisonment suspended for a year and to a fine (Ammenda) of two hundred and fifty Euro (€250).

The Court orders the confiscation and destruction of the drugs exhibited (Dok JG1) in the acts.
