The Court,

Having seen the charges against Tarek Mohammed Ibrahim, of 30 years, born in Egypt on the 9<sup>th</sup> December 1971 son of Mohammed and Malka Naqim residing at No 8 flat 5 Ciantar Lane St.Julians, and holder of German Id.Card no: 193399m of having on 14<sup>th</sup> June 2002:

between 11.15 pm and 11.30pm at Sacred Heart of Jesus Square St. Julians' and at St. Julians' Police station

assaulted or resisted by violence or active force PC 533 P. Sheenan, not amounting to public violence, any person lawfully charged with a public duty when in the execution of the law or of a lawful order issued by a competent authority as per Article 96 (a) of chapter 9 of the Laws of Malta.

Furthermore during the same time, date place and circumstances reviled, threatened , or caused bodily harm to PC 533 P. Sheenan as certifeid by Dr. P. Degabriele MD of the gzira Health Centre , who is a person lawfully charged with a public duty, while in the act of discharging his duty or because of his having discharged such duty, or with the intent to intimidate or unduly influence him in the discharge of such duty, as per Article 95 of chapter 9 of the Laws of Malta.

Furthermore during the same time, date place and circumstances attempted to use force against any person with intent to insult, annoy or hurt such person i.e. Anna Grech and Pc 533 P. Sheenan as per article 339(1) (d) of Chapter 9 of the Laws of Malta.

Also during the same time, date place and circumstances caused slight bodily harm on the person of his wife Anna Grech as medically certified by Dr. P. Degabriele MD of Gzira health Centre as per section 221 (1) of Chapter 9 of the Laws of Malta.

Also during the same time, date place and circumstances wilfully disturbed the public order or the public peace as per Art 338 (dd) of chapter 9 of the Laws of Malta.

Also during the time, date place and circumstances and on the Islands of Malta on the 14<sup>th</sup> June 2002 at about 11.00pm at St. Juluian's and on several dates before made use of vehicle Hyundai of Registration Number EBD 449 without being licensed for the road and without holding any insurance policy of any kind as per Art. 18 of Chapter 9 of the Laws of Malta and Chapter 65 of the Motor Traffic Regulation.

Also that on the 20<sup>th</sup> May 2002 at about midnight, on the Islands of Malta caused slight bodily harm on the person of his wife Anna Grech as medically certified by Dr. P. Degabriele MD of Gzira health Centre as per section 221 (1) of the Laws of Malta.

Furthermore for having breached the conditions impounded by the Honourable Court issued by Magistrate Dr. Abigail Lofaro LL.D, on the 12<sup>th</sup> April 2002 which court sentence is defined as concluded.

Having seen the Attorney General's note of June 17, 2002.

Having seen that the accused did not object that his case be dealt with summarily

Having seen the documents.

Having seen that during today's sitting accused pleaded guilty.

Finds accused guilty.

Having seen section 96 (A), 221(1) of Chapter 9 and section 18 of Chapter 9 and Chapter 65 of the Laws of Malta.

Condemns accused one hundred and fifty Malta Pounds (LM150) fine (multa), warns accused to refrain from molesting PC 533 Shheehan and Anna Grech and furthermore orders accused to pay all licences and insurance policies relative to vehicle Hyundai Number EBD 449 before withdrawing same from the Police Authorities.
