Ikkunsidra l-Pulizija li nvestiga l-incident kiteb fuq ir-Road Accident Report kif gej:

l-attur qal: “ that he was driving his van on the left side of the road and when he approached the curve he found the other vehicle opposite of him and was a little bit in the middle of the street and the collision occurred;

Il-konvenut qal: “ he was driving at a normal speed but could have been a little bit in the middle of the street and as he approached he tried to stop the car but the collision occurred.”

Skond il-Pulizija li nvestiga l-incident u skond ix-xhieda ta' Domenica Portelli l-konvenut ammetta li kien, “naqra ghan-nofs tat-triq”.illi l-kawza prossima tal-incident kienet l-fatt li l-konvenut naqas li jsuq bil-mod bizzejjed u naqas li jzomm fuq in-naha tieghu tat-triq. Il-konvenut ra lill-attur distanza mhux hazina qabel il-habta u kellu d-dover izomm fuq in-naha tax-xellug u jjeqaf qabel il-habta;
