Il-Qorti:-

Rat ir-rikors promotur ippresentat fis-7 ta' April 2014 fejn ir-rikorrent, filwaqt illi ghamel referenza ghall-artikolu illi deher fil-harga ta' **Il-Mument** tal-Hadd 23 ta' Marzu 2014 intitolat '**Is-Sindku Laburista ta' San Pawl il-Bahar se jirriżenja fil-bidu ta' April**', sahaq illi dak hemm miktub kien libelluz u malafamanti fil-konfront tiegħu u kienet intiza li ttlef jew tnaqqas ir-reputazzjoni tiegħu, w ghalhekk huwa talab lill-Qorti tiddikjara tali pubblikazzjoni bhala libelluza w malafamanti filwaqt illi tikkundanna lill-intimat ihallas danni a tenur tal-Artikolu 28 tal-Kap 248.

Rat l-artikolu meritu tal-kaz odjern illi, taht it-titolu "**Is-Sindku Laburista ta' San Pawl il-Bahar se jirriżenja fil-bidu ta' April**", bir-ritratt tar-rikorrent mal-gemb, jghid is-segwenti:

*Is-Sindku Laburista ta' San Pawl il-Bahar, Mario Salerno ikkonferma ma' il-Mument li hu se jirriżenja mill-kariga ta' Sindku fl-ewwel gimgha ta' April. Mario Salerno l-bierah ha sehem fil-laqqha ghas-Sindki li saret mill-Assoċjazzjoni tal-Kunsilli Lokali u matulha hu ħabbar ukoll li kien se jirriżenja minn Sindku imma se jkompli fil-ħidma tiegħu fil-Kunsill bhala Kunsillier.*

*Hu qal li jrid li fl-ahhar sena ta' din il-legislatura tal-Kunsill Lokali ta' San Pawl il-Bahar titrawwem persuna ġdida fil-kariga ta' Sindku biex tiegħu l-esperjenza tant meħtiega. Mario Salerno qal li bhala Kunsillier se jkollu iktar ħin jiltaqa' man-nies.*

*Issa l-attenzjoni kollha għalhekk iddur fuq min se jieħu post Mario Salerno bħala Sindku f'San Pawl il-Baħar. Jidher li l-favorit hu l-Kunsillier Laburista Raymond Tabone, li ilu Kunsillier għal numru ta' snin imma qatt ma serva bħala Sindku.*

*Is-sorsi ta' il-Mument qalu li meta fl-aħħar elezzjoni, Mario Salerno, li mhux minn San Pawl, laħaq Sindku, Raymond Tabone xejn ma ħadha tajjeb. Tant li sa mill-ewwel laqgħa tal-Kunsill, deher fiċ-ċar li jeżisti diżgwid bejn Tabone u Salerno. Mario Salerno serva wkoll għal diversi snin bħala Sindku f'Hal Kirkop.*

*B'hekk, ir-rizenja ta' Mario Salerno mistennija tkun it-tielet rizenja għall-Partit Laburista fil-Kunsill ta' San Pawl il-Baħar. Fis-sentejn li għaddew, minbarra Jason Camilleri li kien irriżenja wara li ħa tender mill-Kunsill, irriżenja wkoll Carmel Hili. Issa, ma' dawn, mistenni jingħaqad Mario Salerno li se jibqa Kunsillier.*

*Mario Salerno kien involut f'investigazzjoni tad-Dipartiment tal-Gvern Lokali. Dan b'rabta ma' hlas allegatament irregolari lill Mario Salerno li hatar lilu nnifsu ricerkatur fi proġett tal-Kunsill ta' Hal Kirkop fejn kien Sindku, bl-isem ta' Litus Go finanzjat b'fondi Ewropej Hlasijiet li jaqbu t-€18,000 bejn konsulenti u spejjez ta' vjaggjar u akkomodazzjoni.*

*Fost ohrajn, id-Dipartiment tal-Gvern Lokali kien qed jistaqsi b'liema kriterji Salerno u l-ekx Segretarju tal-Kunsill ta' Hal Kirkop Ranier Busuttil inhatru ricerkatur u manager rispettivament.*

*Mario Salerno kien qal li l-Kunsill kien infurmat b'dan il-proġett u l-hatriet relatati, fil-laqgħa tad-29 ta' Marzu 2010. Fil-minuti johrog car li dan ix-xogħol kien se jsir wara l-hin tax-xogħol tal-Kunsill – xi haga li kienet konfermata minn Salerno fl-istess ittra tiegħu u għaldaqstant ir-regolamenti tal-kuntratt jesigu li f'kuntratti li jaqzu €12,500 fil-valur, ikun hemm process ta' tendering b'mill-inqas tliet offerenti.*

*Diskrepanza ohra li kienet harget hi li filwaqt li l-Kunsill kien infurmat fil-laqgħa tal-aħħar ta' Marzu 2010, l-istatements finanzjarji juri li l-pagamenti bdew ferm qabel, precizament mill-bidu tal-2010.*

*Salerno qatt ma caħad li kemm hu kif ukoll l-ekx Segretarju Ezekuttiv Ranier Busuttil thallsu doppjament tal-istess spejjez ta' vjaggjar u akkomodazzjoni, kemm mill-fondi tal-proġett allokatu għal dan il-ghan, kif ukoll mill-fondi tal-Kunsill Lokali ta' Hal Kirkop.*

*Sadattant minn sħarriġ tal-opinjoni pubblika dwar il-Kunsilli Lokali li sar f'Diċembru li għadda u li kien ipprezentat waqt il-laqgħa, jirriżulta li kien hemm tnaqqis qawwi fuq is-sodisfazzjon tan-nies dwar kif il-Kunsilli Lokali imexxu l-affarijiet.*

*Ħafna nies jaħsbu li l-Kunsilli Lokali m'għandhomx impatt qawwi fuq il-ħajja ta' kuljum u erba' minn kull għaxar persuni mhux sodisfatti mis-sistema tal-wardens. 35 fil-mija jaħsbu li l-Kunsilli Lokali jipprovdu servizz tajjeb skont il-valur tal-flus.*

*L-istħarriġ kien ipprezentat minn Marika Fsadni, Managing Director ta' M.Fsadni & Associates.*

Rat id-difiza mqajjma mill-intimat u ppresentata fit-23 ta' April 2014 fejn, filwaqt illi sahaq illi l-artikolu lamentat ma kienx jirrappresenta fatti inveritjeri u ma kienx miktub bl-iskop li jtellef jew inaqqas ir-reputazzjoni tieghu, insista illi l-artikolu kien jikkonsisti f'fatti verifikabbli u kummenti dwar kwistjonijiet fl-interess pubbliku li ghalhekk jikkonsistu f'fair comment u kritika accettabbli f'socjeta demokratika.

*Overall comment: the project was run in a smooth way without major delays and has produced the foreseen outcomes which are in accordance with the original aims and objectives. Outcomes are adapted to the needs of the target groups, are good quality and easy to understand. All aspects of the project have been performed without major weaknesses.*

*Strong points: The partnership has worked together in a stable and reliable way so that the planned outcomes could be produced as foreseen. Where deviations from original plans have been detected, these are well argued and make sense. Dissemination activities have been manifold and the different groups of stakeholders in the MED partner countries have been identified (see lists provided). These stakeholders have been contacted by the consortium actively and therefore a certain sustainability of the outcomes is expected. Additional activities, which have not been foreseen in the original application, have been integrated into the work plan according to actual detected needs and have been realised.*

*Weak points: The financial management is not always fully clear (e.g. calculation of several budget positions; shifts in the budget, which are not officially amended but still possible according to the financial rules). The Maltese partner has not been always very active in the project and had a lower commitment to the project than the other partners, but was still reliable. Exploitation activities beyond the lifetime of the project and beyond the partner countries are only in a relatively vague manner, not providing details on precise plans for specific actions*

Jirrizulta, fix-xhieda estensiva moghtija mir-rikorrent Mario Salerno, illi l-parti tal-artikolu illi dwarhu huwa hassu malafamat kien dak illi jirrigwarda r-rappurtagg li sar fih in konnessjoni mal-progett tal-Litus Go finanzjat minn fondi tal-Ewropa u li fih kien involut il-Kunsill Lokali ta' Kirkop, illi tieghu huwa kien is-Sindku.

## Ikkunsidrat

Jirrizulta illi, l-intimat, fid-difiza tieghu, qajjem l-argument illi dak illi intqal kien ibbazat fuq fatt verifikabbli u kummenti dwar kwistjonijiet fl-interess pubbliku dwar persuna pubblika li ghalhekk jikkonsistu f' *'fair comment'*.

Huwa fatt mhux kontestat illi gurnalist ghandu dritt, jekk mhux obbligu, illi jirrapporta dak li jidhirlu xieraq u korrett, u ghal dan il-ghan, il-Qorti taghmel referenza ghall principji stabbiliti fil-kawza **'Axel Springer AG vs Germany'**, deciza mill-Grand Chamber tal-Qorti Ewropeja ghad-Drittijiet tal-Bniedem fis-7 ta' Frar 2012. Il-Qorti Ewropeja ghad-Drittijiet tal-Bniedem, f'din il-kawza, ghamlet referenza ghall-principji generali li jirregolaw il-liberta' ta' l-espressjoni w il-gurnalist, kif ukoll introduciet serje ta' kriterji li kellhom jigu kkunsidrati sabiex jigi meqjus il-bilanc li ghandu jittlahaq bejn il-liberta' ta' l-espressjoni u d-dritt tal-individwu privat li jkollu r-reputazzjoni tieghu protetta, fejn qalet is-segwent:-

*78. Freedom of expression constitutes one of the essential foundations of a democratic society and one of the basic conditions for its progress and for each individual's self-fulfilment. Subject to paragraph 2 of Article 10, it is applicable not only to "information" or "ideas" that are favourably received or regarded as inoffensive or as a matter of indifference, but also to those that offend, shock or disturb. Such are the demands of pluralism, tolerance and broadmindedness without which there is no "democratic society". As set forth in Article 10, freedom of expression is subject to exceptions, which must, however, be construed strictly, and the need for any restrictions must be established convincingly.*

Dwar ir-rwol li ghandu jkollu gurnalist fil-qasam tal-liberta ta' l-espressjoni, l-Qorti ghaddiet biex ghamlet is-segwentu osservazzjonijiet:

*79. The Court has also repeatedly emphasised the essential role played by the press in a democratic society. Although the press must not overstep certain bounds, regarding in particular protection of the reputation and rights of others, its duty is nevertheless to impart – in a manner consistent with its obligations and responsibilities – information and ideas on all matters of public interest. Not only does the press have the task of imparting such information and ideas; the public also has a right to receive them. Were it otherwise, the press would be unable to play its vital role of "public watchdog".*

*80. This duty extends to the reporting and commenting on court proceedings which, provided that they do not overstep the bounds set out above, contribute to their publicity and are thus consonant with the requirement under Article 6 § 1 of the Convention that hearings be public. It is inconceivable that there can be no prior or contemporaneous discussion of the subject matter of trials, be it in specialised journals, in the general press or amongst the public at large. Not only do the media have the task of imparting*



*such information and ideas; the public also has a right to receive them. (sottolinear ta' dina l-Qorti)*

*81. Journalistic freedom also covers possible recourse to a degree of exaggeration, or even provocation. Furthermore, it is not for the Court, any more than it is for the national courts, to substitute its own views for those of the press as to what techniques of reporting should be adopted in a particular case.*

Ir-rwol importanti tal-gurnalist u d-dritt tal-liberta' ta' l-espressjoni, madanakollu, ghandha tigi bilancjata bi drittijiet u obbligi fuq l-istess gurnalist fil-qadi ta' dmirijietu, u, di fatti, il-Qorti, dwar tali doveri da' parte tal-gurnalist, tghid hekk:

*82. However, Article 10 § 2 of the Convention states that freedom of expression carries with it “duties and responsibilities”, which also apply to the media even with respect to matters of serious public concern. These duties and responsibilities are liable to assume significance when there is a question of attacking the reputation of a named individual and infringing the “rights of others”. Thus, special grounds are required before the media can be dispensed from their ordinary obligation to verify factual statements that are defamatory of private individuals. Whether such grounds exist depends in particular on the nature and degree of the defamation in question and the extent to which the media can reasonably regard their sources as reliable with respect to the allegations.*

Tenut kont ta' dawna l-konsiderazzjonijiet kif fuq spjegati, il-Qorti ghandha, hekk kif tkun qieghda tikkunsidra l-kaz quddiemha, tassikura illi jintlahaq bilanc necessarju bejn id-dritt tal-liberta' ta' l-espressjoni u id-dritt tal-protezzjoni tar-reputazzjoni, u sabiex jigi assikurat li hemm tali bilanc, il-Qorti Ewropeja ghad-Drittijiet tal-Bniedem niedet sitt kriterji importanti sabiex jigi assikurat illi, kif tghid il-Qorti, *“the right to freedom of expression is being balanced against the right to respect for private life”*.

Dawna l-kriterji kif stabbiliti huwa s-segwenti:

***(a) Contribution to a debate of general interest***

*90. An initial essential criterion is the contribution made by photos or articles in the press to a debate of general interest. The definition of what constitutes a subject of general interest will depend on the circumstances of the case. The Court nevertheless considers it useful to point out that it has recognised the existence of such an interest not only where the publication concerned political issues or crimes, but also where it concerned sporting issues or performing artists. However, the rumoured marital difficulties of a president of the Republic or the financial difficulties of a famous singer were not deemed to be matters of general interest*

***(b) How well known is the person concerned and what is the subject of the report?***

*91. The role or function of the person concerned and the nature of the activities that are the subject of the report and/or photo constitute another important criterion, related to the preceding one. In that connection a distinction has to be made between private individuals and persons acting in a public context, as political figures or public figures. Accordingly, whilst a private individual unknown to the public may claim particular protection of his or her right to private life, the same is not true of public figures. A fundamental distinction needs to be made between reporting facts capable of contributing to a debate in a democratic society, relating to politicians in the exercise of*

*their official functions for example, and reporting details of the private life of an individual who does not exercise such functions.*

*Whilst in the former case the press exercises its role of “public watchdog” in a democracy by imparting information and ideas on matters of public interest, that role appears less important in the latter case. Similarly, although in certain special circumstances the public’s right to be informed can even extend to aspects of the private life of public figures, particularly where politicians are concerned, this will not be the case – even where the persons concerned are quite well known to the public – where the published photos and accompanying commentaries relate exclusively to details of the person’s private life and have the sole aim of satisfying the curiosity of a particular readership in that respect. In the latter case, freedom of expression calls for a narrower interpretation.*

***(c) Prior conduct of the person concerned***

*92. The conduct of the person concerned prior to publication of the report or the fact that the photo and the related information have already appeared in an earlier publication are also factors to be taken into consideration. However, the mere fact of having cooperated with the press on previous occasions cannot serve as an argument for depriving the party concerned of all protection against publication of the report or photo at issue.*

***(d) Method of obtaining the information and its veracity***

*93. The way in which the information was obtained and its veracity are also important factors. Indeed, the Court has held that the safeguard afforded by Article 10 to journalists in relation to reporting on issues of general interest is subject to the proviso that they are acting in good faith and on an accurate factual basis and provide “reliable and precise” information in accordance with the ethics of journalism.*

***(e) Content, form and consequences of the publication***

*94. The way in which the photo or report are published and the manner in which the person concerned is represented in the photo or report may also be factors to be taken into consideration. The extent to which the report and photo have been disseminated may also be an important factor, depending on whether the newspaper is a national or local one, and has a large or a limited circulation.*

***(f) Severity of the sanction imposed***

*95. Lastly, the nature and severity of the sanctions imposed are also factors to be taken into account when assessing the proportionality of an interference with the exercise of the freedom of expression.*

Il-Qorti, f'dana l-istadju, dwar in-natura tal-kritika ta' persuna politika, taghmel referenza ghas - sentenza **Ligens vs Austria**, mhaddna mill-Qorti Maltin ukoll, fejn jinghad illi:-

*Freedom of the press furthermore affords the public one of the best means of discovering and forming an opinion of the ideas and attitudes of political leaders. More generally, freedom of political debate is at the very core of the concept of a democratic society which prevails throughout the Convention.*

*The limits of acceptable criticism are accordingly wider as regards a politician as such than as regards a private individual. Unlike the latter, the former inevitably and knowingly lays himself open to close scrutiny of his every word and deed by both journalists and the public at large, and he must consequently display a greater degree of tolerance. No doubt Article 10 para. 2 (art. 10-2) enables the reputation of others - that is to say, of all individuals - to be protected, and this protection extends to politicians too, even when they are not acting in their private capacity; but in such cases the requirements of such protection have to be weighed in relation to the interests of open discussion of political issues.*

*83. The Court has considered that where the right to freedom of expression is being balanced against the right to respect for private life, the relevant criteria in the balancing exercise include the following elements: contribution to a debate of general interest, how well known the person concerned is, the subject of the report, the prior conduct of the person concerned, the method of obtaining the information and its veracity, the content, form and consequences of the publication, and the severity of the sanction imposed.*
