The hotel would have no obligations, if on re applying for accommodation, rooms are not available”;

- 15.7. Illi fir-rigward tal-fattura a foll 66 l-intimat jghid li l-gruppi ma kienux ikkonfermati;
- 15.8. Illi f’dan ir-rigward issir referenza ghall-*e-mail* datata l-21 ta’ Lulju, 2008, (ara foll 268), fejn jirrizulta li la kien hemm il-kancellament allura ovvjament kien hemm il-*“booking”*;
- 15.9. Illi ghalhekk l-intimat m’ghandux ragun isostni t-tezi tieghu fir-rigward u konsegwentement, il-*“cancellation fee”* tapplika;
- 15.10. Illi jigi sottolineat li l-*“cancellation fees”* huma wkoll dovuti fuq il-grupp li kien ikkancellat f’inqas minn 14 -il gurnata minn meta jkollu jasal l-istess grupp;
- 15.11. Illi l-fatturi a foll 65, 66, 67 u 68 jirrigwardaw fatturi dwar gruppi kkancellati u ghalhekk, gialadarba s-socjeta` rikorrenti hassret il-kuntratt minhabba l-inadempjenza tal-intimat, il-*cancellation fee* hi dovuta lill-istess socjeta` rikorrenti;

16.0. Illi dwar is-*Servizzi* jinghad sintetikament is-segwent:

16.1. Illi l-intimat isostni li s-servizzi rezi mis-socjeta` rikorrenti kienu rezi hazin jew addirittura ma kienux rezi ghal kollox, (ara foll 217 u 330);

16.2. Illi min-naha taghha s-socjeta` rikorrenti taghmel referenza ghal rapport tad-Dipartiment tat-Turizmu datat it-22 t'April, 2008, li wara spezzjoni fuq ilment ricevut ikkonkluda li l-ilment kien ingustifikat, (ara foll 336);

16.3. Illi ssir referenza ghall-klawsola 6 tal-ftehim tad-29 t'April, 2008, fuq riferit li tistipula s-segwent, (ara foll 21 u 152):

“... under no circumstance will the Hotel be liable for compensation unless the Hotel admits liability in writing in respect of any claim for any breach of this Agreement alleged to have been committed by the Hotel”;

17.0. Illi finalment, fir-rigward tal-allegazzjoni tal-intimat rigwardanti l-**produzzjoni tardiva tal-fatturi**, jinghad sintetikament is-segwent:

17.1. Illi f'dan ir-rigward issir referenza ghall-klawsola numru 2 tal-ftehim in dizamina, (ara foll 21 u 152), minn fejn jirrizulta li l-partijiet ftehm li:

- “a. The client shall pay the hotel by way of deposit on account 50% of the total amount due upon arrival of each group”;
- “b. Payments of all balances due shall be made three (3) days prior to departure of each group....”;
- “c. The client accepts that failure to effect the payments within the stipulated time will entitle the hotel at its sole discretion and with immediate effect to suspend or cancel some or all services provided as per this Agreement, as well as cancel all further groups governed by this Agreement only after having sent a notice in writing to the client and to advise at least 3 days beforehand”;

17.2. Illi in vista tal-klawsola fuq riprodotta *in parte* jirrizulta li l-partijiet ftehm u dwar il-modalita` tal-pagament u fir-rigward ta' x'kellhom ikunu l-konsegwenzi tan-nuqqas ta' pagament;

17.3. Illi ghalhekk issir referenza ghall-ittra datata l-1 t'Awwissu, 2008, (ara foll 179), fejn l-intimat kien infurmat mis-socjeta` rikorrenti li din kienet qed tikkancella l-kuntratt:

“...due to the failure on your part to abide by the agreed terms of payment, our company has no option other than to invoke Clause 2(d) of the Agreement...”;

17.4. Illi in vista tal-premess, l-ilment tal-intimat meta jissottometti li l-fatturi kienu tardivi mhux gustifikat, (ara foll 438);

17.5. Illi l-ftehim dwar il-modalita` tal-pagament jirrizulta car, u allura, la darba r-rati kienu miftehma minn qabel, (ara foll 59), flimkien mal-modalita` tal-pagament, (ara foll 21), ma jirrizulta li hemm l-ebda gustifikazzjoni ghan-nuqqas tal-hlas reklamat;

18. Illi in vista tas-suespost din il-qorti hi sodisfatta li s-socjeta` rikorrenti ipprovat il-kaz taghha skont il-ligi fil-limiti fuq indikati, u konsegwentement:

DECIDE:

- 18.1. Tilqa' t-talbiet tas-socjeta` rikorrenti limitatament kif stabbilit;
- 18.2. Tirrespingi l-eccezzjonijiet rimanenti tal-intimat;
- 18.3. Tiddikjara li l-intimat Roger Degaetano kien inadempjenti fl-obbligi tieghu fil-konfront tas-socjeta` rikorrenti;
- 18.4. Tiddikjara li l-istess intimat ghandu ghalhekk jaghti l-ammont ta' sitta u tletin elf sitt mija u hamsa u ghoxrin euro u tmienja u ghoxrin centezmu, (€36,625.28), lis-socjeta` rikorrenti;
- 18.5. Tikkundanna lill-istess intimat ihallas l-ammont hekk likwidat lis-socjeta` rikorrenti;
- 18.6. Bl-ispejjez kif dedotti fl-istess rikors guramentat promotur kontra l-intimat.

DECIZJONI FINALI
