Ra r-risposta tal-konvenut fis-sens li “l-incident sehh minghajr ebda htija da parti tal-istess konvenuta”;

Ikkunsidra I-Pulizija, li nvestiga l-incident, kiteb fuq ir-Road Accident Report kif gej:

L-attur qal: “whilst driving car no. GAG 575 along Triq L-ingieret from St. Vincent De Paule Hospital towards Marsa Car no. DAR 173 was turning, changing it's direction by making a U Turn and collided into his front side”;

Il-konvenuta qalet: “whilst driving car no. DAR 173 along triq l-ingieret from the direction of Marsa, wanted to change direction by making a U Turn looked but did not see the other car coming and the collision occurred”;

Ili mill-skizz u mill-versjonijiet tal-partijiet jirrizulta li l-konvenuta ma kienetx qegħda zzomm “a proper look out.” Il-konvenuta kienet qegħda tagħmel U turn f' triq principali u kellha tassigura li setghet

tagħmel hekk mingħajr, ma tostakola l-vetturi fil-lane tagħhom. Illi fil-fatt li l-konvenuta ma ratx lil attur qabel il- habta hu indikazzjoni li ma kienetx qed izzomm, “ a proper look out”. Illi meta gara l-incident l-attur diga’ fill-lane tieghu;
