

## CIVIL COURT FIRST HALL THE HON. MADAME JUSTICE ANNA FELICE

Sitting of the 5<sup>th</sup> December, 2019

Acumum Services Limited (C57125) vs

Juris Gulbis (K.I. nru. 0167218(A), u Kuraturi Deputati sabiex jidhru ghas-socjeta' estera Viridian AG, socjeta' bl-ahhar indirizz maghruf gewwa l-Izvizzera

The Court,

Having seen the application of Acumum Services Limited wherein the said company after premissing that:

The plaintiff company offers, amongst others, professional services in relation to citizenship and residence applications; in fact, the plaintiff company rendered said services, particularly those in relation with the Malta Residency and Visa Programme (MRVP) to a certain Mickhail Dzhienbaev, Juris Gulbis and Viridian AG's client;

The plaintiff company issued a number of invoices to said Juris Gulbis and Viridian AG for the expenses incurred and the

services rendered on their instructions and on their behalf to Mickhail Dzhienbaev;

Together, the invoices issued to Juris Gulbis and Viridian AG amount to twenty thousand nine hundred forty five euros and eighteen cents (€20,945.18) representing professional services rendered and expenses/disbursements related to same;

Having been called upon to settle the said sum defendants remained non-compliant;

The debt is certain liquidated and due; in plaintiff company's belief there is no defence to the action and this cause can be decided in terms of Article 167 of Chapter 12 of the Laws of Malta;

Geraldine Noel, on behalf of the plaintiff company Acumum Services Limited (C57125), is personally aware of these facts.

For the reasons premised, the present proceedings had to be instituted and this with a request under article 167 of Chapter 12 of the Laws of Malta.

Therefore the applicant humbly requests this Honourable Court to:

- 1. Give judgement, without proceeding to trial in accordance with Article 167 of Chapter 12 of the Laws of Malta;
- 2. Order to the defendants to appear before it, on an appointed day and at a stated time to be scheduled by this Honourable Court;
- 3. Declare, for the reasons premised, that the defendants owe the plaintiff company the sum of twenty thousand nine hundred forty five euros and eighteen cents (€20,945.18), representing professional services rendered and expenses/disbursements related to same;

4. Condemn the defendants to pay the plaintiff company the sum of twenty thousand nine hundred forty five euros and eighteen cents (€20,945.18).

With costs, including that of the garnishee order filed together with this application, and interest until the sum is paid in full, against the defendants, who are being summoned in subpoena.

Having seen that both respondents after having been duly notified with the acts of the suit, failed to appear or in any way register their opposition to same;

Having seen that Acumum Services Limited's claim are justified;

The Court decides the case by acceding to the first request and gives judgement in accordance with Art. 167 of Chapter 12 of the Laws of Malta.

Abstains from taking further cognisance of the second request.

Accedes to 3<sup>rd</sup> request and declares that defendants owe plaintiff company the sum of Twenty thousand nine hundred forty five euros and eighteen cents (€20,945.18).

Condemns defendants to pay plaintiff company the sum of Twenty thousand nine hundred forty five euros and eighteen cents ( $\[ \le 20,945.18 \]$ ), with costs and interests as therein requested.

Costs are to be borne wholly by defendants.
