Huma jpprecizaw li l-intimat Michael Tippin hu sid u managing director tas-socjeta Exchange Palace LLC b'10% tal-ishma fl-imsemmija TIKKFT mentri s-socjetajiet rikorrenti huma proprjetarju ta' 90 fil-mija tal-ishma akkwistati minghand Cougar Real Estate S.A. Izidu illi l-intimat Michael Tippin ghadha informazzjoni konfidenzjali u privat b'mod qarrieqi lil terzi fosthom l-Istituto per le Opere di Religione u dan bi ksur tal-artikolu 25 tal-istess ftehim ta' joint venture li jghid hekk:

25.1 Each Quotaholder shall at all times use all reasonable efforts to keep confidential the provisions of this Agreement and any other information which it holds or may acquire from time to time in connection with the

management, operation or business of any quotaholder of the Company ("Confidential Information") and it shall procure that neither it nor its affiliates (other than any member of the Group) shall disclose any such information except:

25.1.1 to its direct and indirect shareholders, partners (or bona fide prospective shareholders or partners) or to its or their respective directors, officers, employees, managers, advisers and providers of finance;

Din il-Qorti tqis li r-rikorrenti ma gabu ebda prova li tpoggi f'dubju dawn id-dokumenti nonostante li ippremettew li huma azzjonisti ta' 90 fil-mija tal-azzjonijiet fil-joint venture u billi t-talba ghal hrug tal-mandat ta' inibizzjoni kien jirreferi specifikament ghall-obbligi kontrattwali naxxenti mill-joint venture agreement, u jidher li s-socjetajiet rikorrenti ma ghandhom ebda drittijiet prima facie kontra l-intimat fuq l-istess, ghalhekk it-talba ghal-hrug tal-mandat ma tistax tintlaqa'
