Janet Ferrigi prodotta mill-attur qalet li l-attur ried jipparkja fejn kien il-konvenut. Il-konvenut hareg u meta ipprova jidhol f'postu l-attur, il-konvenut irriversja fuq l-attur.

L-attur qal li dahal minn flok il-konvenut u waqaf il-konvenut gie bir-riverse u habat go fih.

L-attur qal li kellu hsara fuq il-mudguard tal-lemin ta' quddiem.

Ezatt wara l-incident l-partijiet hekk iddiskrivew x'gara:

L-attur "stated that as he was parked his car in front of Borg Cold Stores, Vehicle AAD375 was reversing without the driver looking with the consequence of hitting his vehicle on the front right".

Il-konvenut "stated that he was parked in front of Borg Cold Stores at an angle of about 45 degrees to the pavement, as soon as he moved forward turning his vehicle and started to reverse, vehicle HAF 385 tried to park at the exact place where he was parked with the consequence of coming behind where he was reversing".
