Rat ir-rikors guramentat tal-attur nomine tad-19 ta' Gunju, 2020 li jghid hekk:

1. illi s-socjeta attrici, boutique company indipendentli li tiprovali servizzi globali ta' investiment oltre ghal konsulenza finanzjarja u mprenditorjali, hija wahda mill-intraprizi ewlenin fis-settur tagħha fl-Ewropa fejn ilha topera b'success kbir sa mis-sena 2004. B'rızultat ta' hila, invenzjoni u promozzjoni reklamattiva, it-trade marks BEDROCK tas-socjeta attrici dwar tali servizzi kisbu reputazzjoni u avvjament konsiderevoli;

2. illi fost ohrajn, is-socjeta attrici tgawdi minn regiżazzjoni f'isimha għat-territorju tal-Unjoni Ewropea u tar-Renju Unit (din tal-ahhar parti integrali tas-sistema tal-EU trade marks sal-ahhar tas-sena 2020), tal-EU trade mark BEDROCK (kelma, numru 011482296), registrata b'effett mill-11 ta' Jannar 2013 fi klassijiet 35 u 36 rispettivament tal-Klassifikazzjoni Nternazzjonali ta' Prodotti u Servizzi taht in-Nice Agreement (kif sussegwentement emendat), dwar is-segwenti servizzi:

4. illi fil-fatt, bhala l-ewwel zewg għanijiet indikati fl-istatut societarju tagħha meta debitament irregistrata, il-kumpanija konvenuta ndikat is-segwenti:

Dr Claudette Fenech, legal advisor mar-Registratur tal-kumpaniji pprezentat Dok. CF1 kopja legali tal-file kollu tal-kumpanija Bedrock Investments Ltd C 71149.

Dr Luigi Sansone xehed li s-socjeta minnu rappresentata għandha European Union Trade Mark registrata fil-klassi 35 u 36. Is-socjeta attrici kisbet reputazzjoni mazzmien fir-Renju Unit. Il-kawza saret meta ir-Renju Unit kien għadu membru tal-Unjoni. Il-kumpanija attrici ssostni li I-kumpanija konvenuta qed ikollha *deleterious effect* fuq ir-reputazzjoni tat-trademark tagħhom u dana johrog mid-dokumenti tal-Malta Business Registry. Din il-kumpanija kienet qed tinneżżejjha barra minn Malta bl-isem BedRock Investments Limited fejn disghin fil-mija tan-negożju kien isir fl-esteru. Dan I-investiment kien f'kumpanija Portugiza u mill-audited accounts jidher li I-investiment mar hazin u I-kumpanija tinstab fi stat ta' falliment u hemm Court Liquidation Procedure (Dok. E u J). Hija kienet qed tagħmel *class 35 activity* fl-istess

klassi li fiha hija registrata s-socjeta attrici. F'Dok. L (fol. 65) hemm li l-liability tal-kumpanija kien jeccedi t-total assets b'€334,944. Jirrizulta wkoll li hemm audited accounts li għadom ma gewx ipprezentati kif jidher mill website online tal-Malta Business Registry. It-trade mark tal-kumpanija attrici mhux biss hija uzata imma akkwistat ukoll reputazzjoni. Anke kieku t-trademark ma kellhiex din ir-reputazzjoni fir-Renju Unit taht l-artikolu 9(2)(c) hemm l-artikolu 98(2)(b) li jipprovdi għal 'likelihood of confusion' ghax il-kumpanija konvenuta qed tikser id-drittijiet tas-socjeta attrici (xhieda ta' Dr Sansone).

Kontumaci

Jigi rrilevat li ghalkemm is-socjeta konvenuta hija kontumaci, dan ma jfissir li din hi xi forma ta' ammissjoni. Illi l-istitut tal-kontumacija ma jfissir abbandun tal-kontestazzjoni. Ghalkemm il-konvenuti jibqghu kontumaci, dan ma jagħtix lok ghall-prezunzjoni tal-abbandun tal-liti, għad-difett ta' eccezzjonijiet legittimi, jew għal adezjoni għad-domanda. Il-gudikant għandu jezamina jekk it-talba hix gustifikata indipendentement mill-kontumacija tal-konvenut (**Giuseppe Wismayer vs Giovanni Magro**, Kost 24/11/1934, Kollez. Vol. XXIX, P III, pg 35). Ligi

Is-socjeta attrici qed tippromwovi din il-kawza quddiem din I-Qorti bhala I-EU *trade mark court* ta' prim'istanza kompetenti f'Malta.

Id-drittijiet mogħtija taht il-Council Regulations EU 2017/1001 huma:

1. The registration of an EU trade mark shall confer on the proprietor exclusive rights therein.
2. Without prejudice to the rights of proprietors acquired before the filing date or the priority date of the EU trade mark, the proprietor of that EU trade mark shall be entitled to prevent all third parties not having his consent from using in the course of trade, in relation to goods or services, any sign where:
 - (a) the sign is identical with the EU trade mark and is used in relation to goods or services which are identical with those for which the EU trade mark is registered;
 - (b) the sign is identical with, or similar to, the EU trade mark and is used in relation to goods or services which are identical with, or similar to, the goods or services for which the EU trade mark is registered, if there exists a likelihood of confusion on the part of the public; the likelihood of confusion includes the likelihood of association between the sign and the trade mark;
 - (c) the sign is identical with, or similar to, the EU trade mark irrespective of whether it is used in relation to goods or services which are identical with, similar to or not similar to those for which the EU trade mark is registered, where the latter has a reputation in the Union and where use of that sign without due cause takes unfair advantage of, or is detrimental to, the distinctive character or the repute of the EU trade mark.

A number of elements can be taken into account when determining whether or not exists a likelihood of confusion. In **Sabel v. Puma**, the European Court of Justice lists, in a non-exhaustive way, a number of factors that are to be taken into account by the national courts in arriving at their decision on the point of likelihood of confusion, and adds that account must be taken of

all factors that are relevant in the circumstances of each individual case. These include the degree of recognition of the trade mark on the market, the degree of similarity between the sign and the trademark and between the goods and services that are labelled, as well as the possibilities to make associations with the registered trade mark.

What is assessed is whether there is a likelihood of confusion in that the public might believe that the goods or services originate from the same undertaking or from economically linked under-takings.

One must also take into account the distinctive character of the earlier mark. In particular, its reputation must be taken into account when determining whether the likelihood of confusion (**Holyoak & Torremans, Intellectual Property Law**, p 410).
