

## COURT OF MAGISTRATES (MALTA) AS A COURT OF CRIMINAL JUDICATURE

Per Magnus Mikael Andersson Swedish passport number 93628534

The Court,

After having seen the charges brought against the accused **Per Magnus Mikael Andersson** of 29 years, son of Mikael and Lena nee' Unknown, born in Sweden on the 27st of January, 1993, and currently residing at DDU, Mount Carmel Hospital, Mdina Road, Attard, and holder of Swedish passport number 93628534 **accused with having, on 11<sup>th</sup> May, 2022, at around 10:00hrs in Admission ward 2, Mount Carmel Hospital, Mdina Road, Attard:-**

1. Without intent to kill or to put the life of any person in manifest jeopardy, caused harm to the body or health of john Paul Schembri as certified by Dr. Thomas Aquilina med reg mo 4234.

The court is also being requested to provide for the security of the victim in terms of Articles 382A, 383, 384 and 385 of Chapter 9 of the Laws of Malta.

The Court is requested that when pronouncing judgement or in any subsequent order, sentence the person convicted, to the payment, wholly or in part, to the registrar, of the costs incurred in connection with the employment in the proceedings of any expert or referee, including such experts as would have been appointed in the examination of the process verbal of the inquiry, within such period and in such amount as shall be determined in the judgement or order.

Having examined all the documents forming part of the proceedings.

Having heard the accused plead guilty to all the charges brought against him, notwithstanding the fact that the Court in terms of Section 453(1) of Chapter 9 of the Laws of Malta warned him in the most solemn manner of the legal consequences of his guilty plea after having given him sufficient time within which to reconsider and withdraw his guilty plea.

## Considers

That, as a consequence of the admission of the accused of all the charges brought against him, the mentioned charges brought against the accused have been sufficiently proven.

With regards to the punishment to be inflicted against the accused, the Court took into consideration various factors, including: the nature of the charges brought against the accused, the guilty plea of the mentioned charges at an early stage of these proceedings and the conviction sheet of the accused. Moreover the Court also took note of the submissions of the defense and prosecution during the sitting of the 21st June 2022 whereby they agreed that the accused co-operated with the Police and that he was going to be deported tomorrow and that he pleaded guilty at such an early stage of the proceedings and they suggested to the Court to consider a punishment of a conditional discharge.

## Decide:

Therefore, the Court, for the above reasons and after having seen and considered Articles 214, 216, 533, 382A, 383, 384, 385 of Chapter 9 of the Laws of Malta and Article 22 of Chapter 446 of the Laws of Malta, finds the accused **Per Magnus Mikael Andersson Swedish passport number 93628534** guilty of all the charges brought against him and conditionally discharges the accused **Per Magnus Mikael Andersson Swedish passport number 93628534** under the Provisions of Section 22 (1) of Chapter 446 of the Laws of Malta on condition

that said accused **Per Magnus Mikael Andersson Swedish passport number 93628534** commits no offence during the period of two (2) years from today.

Finally the Court is giving accused **Per Magnus Mikael Andersson Swedish passport number 93628534** the explanation prescribed in Section 22(3) of Chapter 446 of the Laws of Malta.

The Court orders that in terms of Article 392A of Chapter 9 of the Laws of Malta the records of this case be duly transmitted to the Attorney General within the term prescribed by Law.
