Xhud: Ic-CD lil pulizija tajtilhom jiena ghax jien ama kontx xoghol dak iz-zmien il-kazin.

Avu: What can you tell us about a particular
episode that occurred between you and Dominic
if you are recognizing him?

Wit: I think it was beginning of October 4th I
was standing and turned around and he said
how nice is patata looks today.

Adv: And where were you serving?

Wit: Behind the bar I was serving.

Pros: Do you recognize here in this room today?

Wit: Yes yes.

Pros: Who?

Wit: Dominic Chircop the President there he is.

Court: The witness indicated the accused.

Pros: From where do you recognize him?

Wit: He is the President of the kazin where i work.

Pros: And is there particular incident you have been asked to give evidence about today?

Wit: Because what happened that day when he spoke to me.

Pros: First of all which day was it?

Wit: The 4th of October.

Pros: And what happened?

Wit: I was serving him when I turned round to put money in the cash he told me you have a very nice patata today in maltese he said it.

Pros: Do you remembe the time of accident?

Wit: Mid morning at that time I was shocked cause I didnt expect it from him you know.

Wit: I don`t know if he said something and I didn`t hear him I don`t hear everything what he says I don`t feel comfortable now you know when he said that to me now.

Pros: No more questions.
