The Court;

Seen charges against the accused Leon Talevski, holder of identity card number 253536A:

In these Islands and/or at -Omissis on the 19 th April, 2021 between 13:00hrs and 21:00hrs

Committed a non-consensual act of a sexual nature on the person of -Omissis- ID:-Omissis- u a seventeen year old minor. Art. 207; Art 202 (g) of Chapter 9 of the Laws of Malta.

Subjected –Omissis– ID: –Omissis– to any act and, or conduct with sexual connotations, including spoken words, gestures and, or the production, display or circulation of any written words, pictures, and, or any other material, where such act, words, and, or conduct is unwelcome to the victim, and could be reasonably be regarded as offensive, humiliating, degrading, and, or intimidating towards that person, which offense was committed on a person of a minor of seventeen years of age.

Art 251A (1) (e) of Chapter 9 of the laws Malta.

The Court was also requested to provide for the safety of – Omissis– in accordance with Article 383, 384, 385 of Chapter 9 of the Laws of Malta.

The Court was requested to provide for the safety of the alleged victims by issuing a Protection Order in accordance with the provisions of Article 412C of Chapter 9 of the Laws of Malta under such restrictions or prohibitions as the Court may consider necessary.

The Court was finally requested, in pronouncing judgment or in any subsequent order, sentence the aforementioned Leon Televski to the payment, wholly or in part, of the costs incurred in connection with the employment in the proceedings of any expert or referee in accordance with Article 533 of Chapter 9 of the Laws of Malta.

Heard a guilty plea by the accused for the charges brought against him, which such plea was confirmed in today's sitting after being given the opportunity to reconsider his plea.

Heard declaration of prosecution whereby the aggravating circumstances under Article 202(g) of Chapter 9 of the Laws of Malta was withdrawn;

On the above basis and after seeing Article 17(h), 207 and 251A(1)(e) of Chapter 9 of the Laws of Malta finds the accused **Leon Talevski** guilty of the charges brought against him and since second (2nd) charge was designed for the commission of the first (1st) charge puts him on a period of probation for three (3) years under Article 7 of Chapter 446 of the Laws of Malta.

Finally, explained in simple words the repercussions if such order is not complied with.
