*Triq D'Argents Msida*, detentur ta' karta ta' l-identita' Maltija nru. 178123A u cioe talli nhar il-25 ta' Gunju, 2023, ghall-habta tal-23.40hrs., fl-Imsida u/jew fil-jiem u/jew fil-gimghat ta' qabel f'Malta:

 Bil-ħsieb li jaghmel delitt wera dan il-hsieb b'atti esterni u ta bidu ghall-esekuzzjoni tad-delitt, liema delitt ma giex esegwit minhabba xi haga accidentali u 'ndipendenti mill-volonta` tiegħu, u li kieku gie esegwit kien ikun delitt ta' serq ikkwalifikat bil-post u l-hin ghad-dannu ta'Raja Ajaz Ahmed u/jew entitajiet ohra. Art. 41, 261(e)(f),269(g), 270 u 281(b) Kap. 9.

2. Insulentajt, heddidt jew inġurjajt bi kliem jew b'mod ieħor lil Khan Raja Ajaz Ahmed detentur tal-karta tal-identita bin-numru. Art.339(1)(e) Kap.9

3. F'lok pubbliku jew f'post miftuħ għall-pubbliku, kont fis-sakra b'mod li ma kontx tista' tieħu ħsieb tiegħek innifsek. Art.338(ff) Kap.9.

4. Kiser il-kundizzjonijiet tal-liberta provizorja imposti fuqu mill-Qorti tal-Maġistrati (Malta), preseduta mill-Magistrat Dr. Claire Stafrace Zammit LL. D, digriet datat 20/07/2021 f'dan li bih ingħata l-ħelsien mill-arrest taħt diversi kundizzjonijiet fosthom li ma jikkommettix reat ieħor.

5. U aktar talli irrenda ruhu recidiv ai termini tal-artikoli, 49,50 u, jew 289 tal-Kap 9 tal-ligijiet ta' Malta liema sentenzi saru definittivi u ma jistawx jinbidlu. Il-Qorti giet mitluba li tirrevoka l-helsien mill-arrest ta' l-imsemmi Isem-Aggressur u tordna larrest mill-gdid ta' l-imsemmijja imputat u, jew tordna li is-somom marbuta jgħaddu favur il-Gvern ta' Malta.

Il-Qorti giet gentilment mitluba li f'kaz ta' htija minbarra li tinflingi l-pieni stabbiliti mill-Ligi, tordna lill-imsemmija persuna sabiex thallas l-ispejjez li ghandhom x'jaqsmu mal-hatra ta' l-esperti, jekk ikun il-kaz, kif provdut fl Artikolu 533 tal-Kap. 9 tal-Ligijiet ta' Malta.

Pros: Ok Robert can you tell the Court why yoiu were summoned today?

Wit: Yes so in the evening I was coming back home with a scooter and I,

- Court: You remember the date?
- Wit: I don't remember the date.

Pros: Do you remember the time approximately?

- Wit: The time it was evening it was like 10 or 11 and I saw the car it was there was alarm in the car,
- Court: What car?
- Wit: I had seen from the begining it was between other cars and black car I was coming with the scooter coming to my garage in Msida.
- Court: You know the name of the street?
- Wit: Triq it-Torri Point Avenue and I saw the between cars one of the car got alarm and I saw then person there and I stopped try to come to see if everything was alright because in Malta I haven`t seen an alarm the cars and when I was coming I saw the guy was sitting inside the car and moving to the front seats he was coming from the back seat left one.
- Court: Do you know the car was open close what was it?

- Wit: The car was I don't know if it was before open door or closed i haven't seen because it was between the cars then,
- Court: What color was the car?
- Wit: Looks like black color looks like Mercedez some like small one something like this, then when I came closer and wanted to ask something going on then came 2 guys not tall shorter than me and they run to this car where was they tried to close the guy who was already there inside .
- Court: Are you recognizing here the man who you are saying that they was inside the car?
- Wit: Yes.
- Court: Can you show me?
- Wit: There yes.
- Court: Ix-xhud indika lil imputat.
- Wit: So then he tried to get out from the car and he can do that from one side and he start to run

from the other side and then this 2 guys caught him and I tried to hold this guy that he not gonna run then came owner of the car the big guy he was here before and he just took him hold him and moved a but out from the car and then they was talking most probably in Arabic I didn`t understand but then this guy told that he don't` wanna do nothing like he didn`t want to this and that we gonna release he is hungry that time I told you know the guy they gonna release him or something like that but then suddenly a person took out knife and said he is gonna,

- Court: Who is this person?
- Wit: That person.

Court: Ix-xhud rega indika lil imputat.

- Wit: Yes he took out a red knife it's like this Swiss knife red color you know which can open then it was this guy he took his hand the knife fall down and we put this guy on the ground.
- Pros: Sorry what was he saying to these persons whan he was holding the knife?
- Wit: He said to guy the owner that if he gonna call the police he gonna kill him.

#### Court: In what language he said that?

Wit: In English, so after that this big guy so the owner of the car was sitting over this guy hold him because he was super angry he is trying to like provoke and then other 2 guys helped to hold him until police came.

Court: You were there until the police arrived?

- Wit: Yes, and the rest was on the video the police tried to calm him down,
- Court: On the video what do you mean on the Police bodycam?
- Wit: Yeah, they tried to calm him down he didn`t come down even he was in the police car then police took my particulars details and my version, basically that`s all and yeah as well he told that he gonna kill everyone there when he comes back.
- Court: And who did he address these words to and who did he speak to?

- Wit: The owner and the 2 guys who was helping he was told that he is gonna kill them everyone there so we were holding him like that he can`t do nothing.
- Court: Did you notice anything about the meaner that you think maybe he was in a state or other?
- Wit: I can't judge the state he was but he was like super angry you know and i was not gonna leave that area and for me it was just help the person and until police gonna come so but he was like super angry behaved like trying to provoke us and emotions but you know police was there and doing their job.

- Wit: Yeah from the guy that come to my car.
- Pros: Can you tell us the date and the street thatthis incident happenend?
- Wit: The street near my house this appartment I nearly shit here somebody called me.

Pros: Can you tell me the name of the street?

Court: The address is the one on the id card can I see your Id card please?

## Wit: Yes.

- Court: Triq Dun Karm Imsida?
- Wit: Yes this the street.
- Court: And what happened the date please?
- Wit: Is like night time like 23 plus I was at home.
- Court: 23 plus what do you mean?
- Court: After 11?
- Wit: After 11 yes, so my friend call because they call me before I was coming to with your home so I make something to cook and I said come, then they call me again come down quickly, what happened and I listen some sound so I said ok I come down quickly take action the guy.
- Court: What guy?
- Wit: This one.

- Court: Ix-xhud indika lil imputat.
- Wit: So he say he is in your car, I said what are you doing in my car,
- Court: He was in the car?
- Wit: No that time he near the car then my friend he catch him like.
- Court: What's your friend's name?
- Wit: Abdul Naveed and Irfan, so one other man is now brought something like the urban guy he said don`t touch him we call the police.
- Court: So what was the man doing that you had to call the police?
- Wit: I don't know they call the police before.
- Court: You don't know what happened?
- Wit: No, I just there.
- Court: Do you remember the date when this happened?

## Wit: Exactly I don`t know the time.

Pros: But you know at least the month?

Wit: Yes the last month.

Court: You mean June or July?

Wit: No June this year last month before like 26 June because maybe 24 something like this because that time I had blue paper.

Pros: Then what happened?

Wit: So I hold him so he was like forcing please leave us I am Muslim, so I thinking I leave him but he said we call the police don't leave him the European guy Robert I said ok. Then holding him then he forceing me try other I kill you I said please.

Pros: Who said I kill you?

Wit: He the guy I don`t know his name.

- Wit: So I say he say I am Muslim I say I am muslim so please this is not good then he I don't know he had a back bag he wearing bag he just took knife maybe in pocket something his knife colour is red and he said I kill you I saw it then I hold his hand and my friend come he took his knife, then I put him down then we wait for the police.
- Court: Il-Qorti qed turi lix-xhud DOK SW 1 do you recognize this object?
- Wit: Yes.
- Court: So when you say this what is it?
- Wit: Red colour.
- Court: The red knife you were referring to?
- Wit: Yes.

Pros: And then what happened?

Wit: Then my friend took it we were waiting for the police so then he was shouting like this we

can't listen so we wait for the police to come the police come then arrest him and took our address name and everything and said I will let you know, then I go home.

Court:	Cross	examination.

Adv: So you said you were in your apartment when somebody, how were you informed about the incident happened?

Wit: Naveed call me my room partner he was with Irfan, Irfan and my friend they come back because he is a Taxi Driver he come he said we are coming to eat.

Adv: So Irfan found him near your car?

Wit: Irfan and Naveed they are together.

Adv: They are both you room mates?

Wit: No only Naveed.

Adv: Sowhy was the other what was he doing there?

Wit: He Naveed he pick him from his house he lives in Msida so they come to eat in my house I amke chicken rice so he said we are comeing to eat I said come no problem.

Court: So Irfan was going to be a guest in your house?

- Wit: Yes yes.
- Adv: So they were on the way toyour house right?
- Wit: Yes.
- Adv: Ok but when they called you what they told you that there was this man and you went down stairs right?
- Wit: Yes they called and I come down.
- Adv: Ok, so there were Irfan the other friend and this gentleman here right?
- Wit: There was a European guy,
- Court: European guy he called him.

- Adv: And who was this European guy do you know him?
- Wit: I saw him last time but he say I live here I say I am new here in June I shift here.
- WitL Orajt and when you went you found them already there the 3 and he was with the bike?
- Wit: Yeah, the parking guy saw it and I called the police as well so wait for the police.
- Adv: And the 3 of them were holding he was out of the car you said?
- Wit: No I didn`t see him inside the car, my car was open.
- Adv: Where did you see him on the pavement or in the road?
- Wit: In the road my car also parking behind the car and the car is open so then,
- Court: The car was open you said?
- Wit: Yes is open the doors are open he say I was but I didn`t took anything but I check nothing has

happened because nothing I had my fitness bag and it was still there.

- Adv: And you do not lock you car am I correct?
- Wit: It was locked but the back mirror like 2 weeks open for here because they were not working so I open in my morning but I close at night, how was open I don`t know.

- Wit: He was being held by the 3 of the men behind my car.
- Adv: So when you went down he remain they remained holding him right so he doesn't run away, so how did he at that point get out the penknife if he was being held down by the 3 people how is it possible, you said they were holding him and you didn't see anything in his hand when the 3 of them were holding him so how with the 3 of them

holding them and then you went down how did he get out the penknife?

Wit: Then I come down I hold him and Γm asking him why you do in my car? so Γm like he aggressive.

Court: You said they left him, they let him go?

- Wit: No no I hold him I said leave it so I say what he said wallah wallah I say you are muslim he said yes I said what you be muslim, muslim not doing this so he said please leave me alone I`m thinking, then guy tell me I call the police don`t let him go, I say ok then I`m holding and he talking to me and that time he took knife and I saw it in his right hand so I holding like this.
- Court: You hold him from his left side and he took it out from the right arm right hand?
- Wit: Yes, then hold him just with the right hand liek this and I call my friend heyy he has knife then they come and took it.
- Adv: So when you were holding him you were holding him with one hand how were you holding him you are a big man I mena you are a big strong man how were you holding him?

## Wit: One hand like this from his shirt.

Adv: And your friends were holding him at that time?

Wit: No.

Adv: They let him go?

Wit: But they were standing here.

Adv: They were close to you?

Wit: Yes just starting police comeing we wait for the police comeing they were waiting for the police.

Adv: And when the police came were you still holding him all of you then?

Wit: No then police came because he I took knife then I put him force with me we put him down and the we hold him he was forcing too much.

Wit: Acytually come with me my friend I come home for eating that time I coom for eating for home and at around 10.30,

- Court: What is the name of your friend?
- Wit: Muhammed Irfan.

Court: And you werew going to your home?

- Wit: No no he finished the work I collect from Valletta.
- Court: And you were going where?
- Wit: To Valletta and then I pick up him and come to my home.
- Court: And your home is where?
- Wit: Is in Msida.
- Court: Do you know the address?

Wit: 46, Maracana Court, Idon`t know the street because we are new here.

Court: Is it the same that you have on your Id card?

- Wit: No I change it.
- Court: Ok, so what happened you arrived where you did what?
- Wit: I arrived home so we come walk together,
- Court: So you parked your vehicle you were walking together to your flat?
- Wit: Yes I parked the vehicle and then I walk together so we can see our friend car is sound coming so I see this our friend car we go there so we can see inside the car and someone and somebody sitting inside it in the passenger seat so I said who are you, he said this your car? yes we our friend car so,
- Court: Who does the car belong to?
- Wit: Friend he is Ahmed Raja Ajaz.

Wit: Yes, so they will need to ... ... they will run we will catch him so he will fight with us and catch and another person turning there beside us Mr. ... so they will fight he come out also please sit down they said so he will fight he said no no I want to go please leave us leave me so he said no no they will call him, call the police, police come sorry I call our friend car Raja Ajaz,

Court: The one you live with you called him?

- Wit: Yes yes.
- Court: Is the same man he came in this hall the big guy?
- Wit: Yes yes they will coem also and catch him they will fight him with us so they was shouting I will kill you like that.
- CourtL I kill you, who said that I kill you?
- Wit: This man there.
- Court: Ix-xhud indika lil l-imputat, so this is the person you saw near your friend`s car?

Wit: Yes.

Court: And he said I will kill you?

Wit: Yes, I will kill you after that we will catch him he will fall down after that he`s like need to run so he get the knife.

Court: You saw him taking out a knife?

- Wit: Yes.
- Court: Il-Qorti urietu SW1, what colour was the knife do you remember?
- Wit: Red.

Coiurt: Do you remember this knife?

- Wit: Yes this one, they will clal him and another person is called the police, police came they will catch him this man there,
- Court: Ix-xhud indika lil imputat.

Pros: After you catch him did you look inside the car?

Wit: Yes we will see inside the car.

Pros: And did you notice something?

- Wit: Yes, because this is our friend car but that time we didn't check what is missing or what to catch him because we our self defences because he said he run.
- Court: So you saw him in the car you saw the accused in the car?

Wit: Yes he is sitting inside the car that time.

- Court: So the car was obviously open?
- Wit: They will open but I don`t know,

Pros: Who they?

Wit: This guy.

Court: Ix-xhud indika lil imputat, so you saw him in the car which was obviously open for him to get in?

Wit: Yes.

Pros: And then after you took him out did you notice something inside?

- Wit: No.

Wit: I don't know the make, colour is black.

- Court: Do you know the number of the car?
