PS 1026 B Gauci xehedet bil-procedura tal-affidavit li fil-15 ta' Awwissu, 2021 ghal habta tad-2130hrs giet infurmata li kien hemm argument bejn xi nies hdejn Tony's Kiosk Bar, Bahar ic-Caghaq fi Triq il-Blat l-Abjad. Meta marret fuq il-post tkellmet ma Arpa Lapko Irina Aleksandrovna li qalet li bejn 2100hrs u 2200 hrs kienet ma habibtha gewwa restaurant fl akwata u meta kienu ser jitlqu sabu vettura Kia Mentor IBF 119 timblukahha u li offendieta, kagunatila griehi fuq il-persuna taghha u hsara fil-vettura taghha. Wara li staqsiet fil-madwar irrizulta li persuna femminili li wara giet identifikata mill-pulzija bhalta Cassar Josloann. Minn aktar indagni l-pulizija gabret filmat tal-akkadut.

Meta Cassar Josolann giet mitkellma mil-pulzija hija qalet li l-mara barranija insulentata bil-malti u hi rispondietha lura. Hija stqarret li li giet pprovokata.

Affidavit ta' tat-Tabiba Dr Agnes Portelli fejn ikkonfermat hekk

*“Li ezaminajt lil **Irina Aleksandrovna Arpa Lapko**, bin-numru ta' identita' 322011 L, fis-16 ta' Awwissu, 2021, fl-10:30 fid-dipartiment ta' l-Emergenza ta' l-Isptar Mater Dei.*

Irina Arpa Lapko xehedet fis-seduta tal-12 ta' April, 2022 bil-lingwa Ingliza. Fuq l-incident xehedet li dak in-nhar, il-15 ta' Awwissu, 2021 kienet ma habiba taghha u mat-tfal taghhom u wara li hargu minn restaurant gewwa Bahar ic-Caghaq ghal habta tal-ghaxra ta' fil-ghaxija (10:00 pm) marru ghal karozza li kienet ipparkjata regolarment gewwa car park pubbliku. Il-vettura tax-xhud hija Mercedes Benz C Class bin-numru ta' registrazzjoni IRA 888 Ma setghatx tohrog ghaliex il-karozza kienet ibblukkata minn karozza ohra li kienet ipparkjata b' mod parallel u ghalqieha kompletament. Hi daqqet il-horn ghal xi hmistax (15) il-minuta meta giet mara li qed taghraf bhala l-imputata. Tixhed.

“Wit: she came she had another two women with her and basically I saw her before she was next to the hotdog kiosk stand and she saw me pressing the horn and she took her time about 15 minutes I was waiting and she came up and she started immediately like sort of aggressively with F words why I am pressing the horn.”

“Wit: Well I mean she said why the fuck I’ m pressing the horn, I said because you blocked my car and I need to go home and the kids I have kids one of them 3 years old my younger daughter and the second child about seven years old the Doctor’s daughter.”

“...so what happened when I thought she has to move the car because I have to go and she said why I’ m pressing the horn because you blocked me and you are breaking the law you have to move and she said you found parking and I’ m not I said but you shouldn’t be my problem because you are the one whose breaking the law and the meantime she start becoming aggressive because also the main thing she saw me a foreigner and the main she with her leg she bumped my car.

Court:She kicked your car?

Wit: yeah and I said go away from my car and there was people watching there was a lot of people watching and I said I’ m going in the car and if you don’t move I call the police and she start screaming words like you.

Adv: Tell the court the exact words she told you.

Wit: you are a fucking Russian prostitute you come her you fuck our men and then you try to say something like you know I was shocked my friend Olga she was in the car in the meantime I was very shy because the people were watching and children were in the car like I had a state of shock.”

Adv.: Apart from the shouting when you entered the car?

Wit: My car I locked the door I put on the engine and I said get out of the car now if you don't move I will reverse on you and you will be your fault because you're blocking me in the meantime there were the 2 women who were with her they tried to pull her away because she was screaming in the meantime shaking my car on the tyre like this and I couldn't call the police straight there because I was grabbing my phone my hands were shaking and I realised by battery fell off I didn't have battery on the phone Olga my friend of mine she was in a state of shock completely she was staring like this her daughter start,

Adv: And what was she doing to the car and to you who were in the car?

Wit: She was threatening me she was calling me names she was calling me Russian prostitute she was threatening me your family as Leo the car something like that and she came after me.

Adv: Did you sustain any injuries?

Wit: Then what happened her friends that woman who as with her they put her and the car she moved the car she went into her car.

Court:Who's she?

Wit: Josoloann and she moved the car I tried to get out I managed to come out from the parking space just reversed all of a sudden she blocks me second time reversed like this and she start spitting to us I didn't have glass on it was open my window she starts spitting in my face and it was COVID time were talking everybody was supposed to be with the mask she start spitting in my face in the meantime she was already screaming of the car the only thing I was telling her get away from me I have children in the car I was scared for the children as it was the second attempt when she was like blocked me with reverse and that time they start shooting the video the people because that's from that moment on video came Tik Tok in the following 2 days the whole Malta saw that video that I felt really more depressed because even I had to go to Supermarket the shop or wherever I park my car people looking at me."

"I thought she's leaving she left my friend was in the meantime she was calling the police because you know everybody's watching and already caos and all of a sudden I didn't realise because I was slowly try to reverse

the car she ran out of the car so basically she left again she stopped the car she ran to the hill and she started hitting my face through the glass physically.

Court: one moment how can she hit you through the glass?

Wit: through the window the window was open, yes the window I couldn't put up the window because I was afraid if I my car is automatic I was afraid that if I pass the button to to close the window basically it will close on her so in the meantime my children our children in the car were crying Olga in the meantime called the police she I had the report from Mater Dei because I had

So basically after 2 days first I went did the report of my injuries some bruising after 2 days my face I didn't know something got damaged my face got all swollen up and I have the pictures of it I had to go within the next 2weeks to the doctor."

Fis-seduta tas-7 ta' Marzu 2023 ix-xhud ezebit sett ta' ritratti tal-griehi li kellha mehudha minnha stess. Ir-ritratti hadithom dak in-nhar tal-incident u jumejn wara "when the swelling started to come up on my face."

Andrea Bondin, rapprezentanta ta' Gasan Mamo Insurance , xehedet fis-seduta tat-12 ta' April 2022. Rapprezentant ta'. Jikkonferma d-dokument ezebit u mmarkat Dok C li jikkonsisiti f' survey report. L-hsara skont is-survey report hija ta' € 1859.51.

PC 617 Christian Mark Ferries xehed fis-seduta tal-16 ta' Novembru, 2022. Jixhed li fis-16 ta' Awwissu, 2021 irceiva email minghand il-control room tal-pulizija li kien hemm video fuq Tik Tok qed jiccirkola ta' argument li sehh bejn zewg persuni. Dahal fuq il-profil ta' dan il-persuna li uplowdja il-video u preservah u minn hemm ghaddieh lil tad-distrett bil-filmat. Il-filmat gie ezebit u mmarkat Dok CMF.

Stephen Cachia, rapprezentant fid-Direttorat ghat-Trasport fuq l-Art fi Hdan l-Awtorita ghat-Transport f' Malta, xehed permezz ta' affidavit datat 30 ta' Jannar 2023 u ezebit mil-prosekuzzjoni fis-seduta tas- 7 ta' Marzu 2023. Jixhed li minn indagni li ghamel fir-records tal-Awtorita' irrizulta li l-vettura bin-numru ta' registrazzjoni IRA 888 tal-marka Mercedes Benz, fil-15 ta' Awwissu 2021 kienet irregistrata fuq Irina Aleksandrovna Arpa Lapko (I.D. 238447 A) u ilha hekk registrata mill-1 ta' Marzu 2018.

Dr Olha Attard xehedet fis-seduta tas-7 ta' Mejju, 2023 bil-lingwa Ingliza. Taghraf lil imputat u lil *parte civile*. Hija kienet passigiera fil-karozza tal-*parte civile*, Irina Arpa, meta gara l-incident fil-hmistax (15) ta' Awwissu tas-sena elfejn u wiehed u ghoxrin (2021). Tixhed.

“Ms Arpa’s car is a white Mercedes and it was blocked by another silver vehicle we were looking for the owner of the veivhle for quite a while we were hooding for about 10 minutes like we attracted a lot of attention but

no one was coming and then eventually the owner of the vehicle came and actually instead of apologizing and keeping us waiting for so long she was quite arrogant.”

Ix-xhud taghraf lil imputata bhala s-sid tal-vettura li kienet qed tinblukahom.

Meta waslet l-imputata bdiet tghajjat bil-Malti, ix-xhud fehemet x' inhi tghid ghaliex ilha tnax il-sena hawn Malta. L-imputata bdiet tuzaha 'swear words' u “and then she said like foreigners why don't you go to your country and Ms Arpa said I' m Maltese as well which triggered the further verbal insulting from this madam . . .”

Meta qalu lil imputata li ser jcemplu l-pulzija, l-imputata rvellat u fi kliem ix-xhud.

“after the mention the police this madam she totally lost it like she drove back with the same car clocking our door and we couldn't even open the door of the car the verbal insults carried on and at some point she started physically attacking Ms Arpa.

Adv. Explain exactly the incident relating to the physical attack please?

Wit: She was fisting her face and we had kids she was screaming non stop like aaaaahhhh and didn't know what to do to help my friend or to call the police it took me a few seconds to dial the police I was in such a shock and Ms Arpa had her smaller child who was with her and the child just froze in terror.”

The children were at the back of the car.

Adv: Taking you back to the fisting accident could you kindly explain exactly what happened what did you do exactly?

Wit: So she came out of the car she was outside Ms Arpa's car the windows were down and she started grabbing buy ger hair and fisting.

Adv: And where was Ms Arpa at that time?

Wit: She was in the driver's seat she couldn't leave the car she was afraid to close the window not to damage madam's arms you know so she couldn't close it and I mean it took a few minutes because people were trying to intervene."

L-imputata fix-xhieda taghha tixhed li hija giet ipprovokata mill-*parte civile* ghaliex din offendieta u ukoll qalet li irwiet idejn it-tifla mandakollu ma tressqu ebda' provi fuq dan allavolja l-Qorti hija propensa temminha meta tghid li kien hemm xi tghajjir minn naha tal-parte civile li kienet ilha ddoqq il-horn biex tohrog mill-parking ghal madwar ghaxar minuti. “Mill-banda l-oħra jekk il-prosekuzzjoni kienet qed tipprospetta r-reat ravvizat bl-artiklu 251B tal-Kodici Kriminali dan kien jinnecesita` li tigi pruvata l- “imgieba” u cioe` “a course of conduct”. “Illi l-imputat jinsab akkuzat ukoll bir-reat ta’l-hekk imsejjah “harassment” bil-vjolenza kif previst fl-artikolu 251B tal-Kapitolu 9. Illi f’sentenza mogħtija mill-Qorti ta’l-Appell Kriminali fl-ismijiet il-Pulizija vs Raymond Parnis (per Prim’Imħallef Vincent DeGaetano 24/04/2009), il-Qorti tat definizzjoni ezawrjenti ta’ dak li jikkostitwixxi il-harassment taħt dina id-disposizzjoni tal-ligi. Il-Qorti ta’l-Appell fis-sentenza tagħha fil-fatt tissottolinja l-fatt illi l-kelma “imgieba” fit-test tal-ligi timplika “a course of conduct” u mhux xi incident wiehed izolat.”

Fis- sentenza Il-Pulizija vs Joseph Brincat ¹intqal illi:-
