Xhud: The first week jekk niftakar sew at around 12 o`clock.

Avu: Ma gara xejn mela u fejn sehh l-incident?

Xhud: The scene bdiet fin-nizla t`Alla u ommu jiena kont niezel in-nizla t`Alla u ommu kif qbizt l-ewwel roundabout kien hemm karozza kienet ghadejja nahseb xi 40 km per hour 50 km per hour jiena gejt warajha.

Avu: Inti qed issuq xiex?
