Having seen the charges brought against:

Yahya Khallouf of 22 years, born in Italy on the 04th of August 2001, father's name Mohammed and mother's name Aicha nee Khallouf, residing in V Hotel, Ross street, St Julian's and holder of Italian id card number CA01752GY.

And

Eva Codermatz of 19 years, born in Italy on the 01st of February 2005, father's name Tancredi and mother's name Martina nee Venuto, residing in 35 Petunia, Tamal Street, St Julian's and holder of id card number 0165211A.

that in these islands on the 2nd of April 2024 at around 01:30am and in the previous time in Triq ir-Ross, St.Julians and/or in the vicinity :

- 1) Reviled, threatened or caused a bodily harm to PS1030 Clint Theuma and/or PC 987 Daniel Sultana and/or PC878 Damian Saliba Howgate, as

persons charged with a public duty, whilst in the act of discharging such duty or because of having discharged such duty.

- 2) Also for having, on the same dates, during the same times, at the same places and in the same circumstances even though in a state of intoxication, publicly uttered any obscene or indecent words, or made obscene acts or gestures, or in any other manner not otherwise provided, offended against public morality, propriety or decency.
- 3) Also for having, on the same dates, during the same times, at the same places and in the same circumstances disobeyed the lawful orders of any authority or of person entrusted with a public service, or hindered or obstructed such persons in the exercise of their duties.
- 4) Also for having, on the same dates, during the same times, at the same places and in the same circumstances wilfully disturbed the public good order or the public peace

Yahya Khallouf alone that on the same date, place, time and circumstances-

- 5) Committed slight bodily harm on the persons of PS1030 Clint Theuma as certified by Dr. Ryan Falzon Med reg no 4320 of Floriana Health Centre;

Eva Codermantz alone that on the same date, place, time and circumstances-

- 6) Refused to give, or untruthfully gave to any public officer or any other person entrusted with a public service in the actual exercise of his duties, his name, surname, address and other particulars

The prosecution on the 3/4/2024 withdrew the first charge regarding Eva Codermatz

Eva Codermatz & Yahya Khallouf registered an admission of the charges brought against them after being duely cautioned

Having Seen Art. 95 of Chpt 9 of the Laws of Malta Art 338 (bb), 338 (ee), 338 (dd), Art 338 (g) of Chpt 9 of the Laws of Malta Art. 221 of Chpt 9 of the Laws of Malta

Considerations of this court

Both accused registered an admission at a very early stage of the proceedings

Decide

The court after having seen Art. 95 of Chpt 9 of the Laws of Malta Art 338 (bb), 338 (ee), 338 (dd), Art 338 (g) of Chpt 9 of the Laws of Malta Art. 221 of Chpt 9 of the Laws of Malta finds

1) Eva Codermatz guilty of all charges and conditionally discharges her for a period of six(6) months as per article 22(1) of chap 446 of the laws of Malta

2)Yahya Khallouf guilty of all charges and fines him eight hundred euro (800) payable in one year.
