### Il-Pulizija

-vs-Dishan Darmanin, detentur tal-Karta tal-Identità nru. 117196M; Omissis,

Omissis 1

Il-Qorti,

Rat l-imputazzjonijiet miģjuba fil-konfront tal-imputati **Dishan Darmanin**, **Omissis u Omissis 1**;

Nhar 17.09.2022 għall-ħabta ta' 04:40hrs ġewwa Triq Elija Zammit, San Ġiljan u f'dawn il-Gżejjer Maltin:

- 1. Volontarjament qalu kliem oxxen li jikkonsisti f'dagħa fil-pubbliku.
- 2. Insulentaw, heddew jew inġurjaw bi kliem jew b'mod ieħor lil Ndubisi Chukunyere.
- 3. Volontarjament kisru il-bon ordni jew il-paċi pubblika b'għajjat u storbju.

- 4. Għamlu inġurji jew theddid mhux imsemmijin band` oħra fil-Kodiċi kriminali jew, jekk kienu ipprovokati, inġurjaw b'mod li ħarġu l-barra millimiti tal-provokazzjoni.
- 5. Hebbew għal Ndubisi Chukunyere u kkaġunawlu offiża ta' natura ħafifa skont kif iċċertifikat minn Dr. Michaela Farrugia, Med no. 4890.

Il-Qorti ģiet mitluba sabiex f'każ ta' ħtija tipprovdi għas-sigurtà' ta' Ndubisi Chukunyere skont l-Artikolu 383 tal-kodiċi Kriminali.

Illi din il-kawża giet assenjata lil din il-Qorti kif preseduta fl-"Assenjazzjonijiet ta' Kawża" mogħti mis-S.T.O. Prim Imħallef Mark Chetcuti fit-2 ta' Frar, 2024;

Illi l-ewwel seduta minn din il-Qorti kif preseduta saret fid-9 ta' Lulju, 2024;

Rat l-atti w id-dokumenti kollha;

Semghet ix-xhieda;

Semghet it-trattazzjoni finali tal-partijiet;

Ikkunsidrat,

Illi **Matthew Ikeehukwu Nwaokenye** xehed li kemm hu kif ukoll l-parte leża ġew aggrediti meta l-imputat kien qal biss "hello" lil tfajla:

"The witness: I say respectfully we stay outside and we saw this lady,

The Court: Outside the Gentlemen's Club, yes,

The witness: We saw this lady walk past and my friend say hello to her. And the

next thing the men there they ... ... on him, say, "Why are you talking to her?!" The next thing they start hitting him, I try to separate them, one of them came behind me and grabbed my hand.

The Court: And before you said that it was Dishan who was aggressive first

towards Chukunyere.

*The witness: Chukenyere.* 

*The Court:* And then you went to separate them,

The witness: I was going to separate them, but someone came behind me,

The Court: someone came behind you at that point and grabbed you from your

neck.

The witness: And grabbed me from my neck.

The Court: All right. And you are absolutely sure that all Mr Chukunyere said

was, "Hello!"

The witness: Was "Hello!" ... ... just said "Hello!" and that is it.

*Pros:* At what time was this?

The witness: I think it should be around, if I am not mistaken, something to five or

after four. Because I remember then the clock, the business close by

four, we were outside...

*Pros:* And would I be correct to say that it was Mr Chukunyere who first

hit one of the gentlemen here?

The witness: No, no, no! He did not hit any of them.

Pros: You confirm that under oath. The witness: He did not hit any of them."

**Melissa Maimour Mentor Diawara** xehdet kif fil-lejl in kwistjoni, hi kienet mal-familja tal-imputat ġewwa Paceville u kif għaddiet minn quddiem Ndubisi Chukunyere, il-parti leża:

The witness: I passed, he was looking at me like with an insistent look at first...

The Court: With an insistent look.

The witness: Yes. And then he made a comment about my posterior...something

about my ... ... and everything... About grab my ass..... I then when I ask him like "What did you say!" and everything, he like blew me a kiss and... He blew me a kiss. ..... He was trying to find like ... ... provocation, I do not know what he was trying to do, but I was

with my boyfriend, so...

*The Court: Of course. And then?* 

The witness: So then it is how it starts because ... ... I went to Dishan to tell him

what happened, .....[Dishan] went to spoke to him and the guy starts

swearing and getting aggressive and that is how it started.

*The Court:* Who started the fight, so?

*The witness: I do not remember but I know that -*

The Court: No, but you said... who was talking aggressive?

*The witness:* The guy.

The Court: The guy, when Dishan went on to him, the guy was aggressive?

The witness: Yes, and he was swearing then in Maltese ......

*The Court: Sorry?* 

The witness: He was swearing even in Maltese, you know, he is a black guy like me

and he was, kind of provocation.

The Court: He was swearing in Maltese.

*The witness:* Yes.

The Court: What was he saying? The witness: I do not remember.

The Court: You do not remember, all right. Ok. Any questions?

Pros: So Melissa, do you remember who hit who first, who was the one to

*hit someone first?* 

The witness: I do not remember but for me the guy start swearing and when they

try to approach him he made the first... that is how I saw the things.

*I do not know exactly.* 

The Court: So when Dishan tried to approach him, what did you say?

The witness: When Dishan tried to approach him, they were talking, when the guy

start to getting aggressive, Dishan tried to approach him and the guy

hit him. I do not know which one hit who first, I cannot be... No, I mean swearing maybe, but I do not speak, no I do not speak Maltese.

.....

Defence: So how did you realize that was Mr Chukunyere was saying are

actually swear words?

The witness: Because I was living in Malta during three years, I know what is

swearing like, ... things like that.

The Court: So he said that word, so he said the first one, all right, I got it; the

second?

The witness: I do not remember which word he used, that is why I do not want to

*state* ... ...

The Court: All right, all right, so you know a couple of swear words.

*The witness:* Yes, that is what...

Defence: No. Just one final question, Madam. You were saying that you do not

recall what words were said.

*The witness:* Yes.

Defence: But then you recalled that Mr Chukunyere passed some comments

about your behind.

*The witness:* Yes.

Defence: Which version is the real version?

The Court: No, no, no! She said she does not remember what words were uttered

as regards the swear words; we have to be very careful.... She said something on the lines that "grab your ass," something like that.

Defence: After saying that she does not recall what words were said.

The Court: Madam, before you said you do not exactly remember the words, the

comment, Mr Chukunyere made about your posterior,

The witness: yes,

The Court: But the general drift of it, what was it?

*The witness:* It was about my posterior, that is what I said.

The Court: Yes, about your posterior. But what about your posterior? It looks like

a peach? Jien naf!

The witness: No, like he made a comment bigger about my posterior, like something

about ... or something like that, I do not remember. I know that what it was, now today I cannot tell you what I... I mean... I do not

know...

The Court: It is a comment about your posterior. People do not go down passing

comments about posteriors! So I hope.

Defence: Just one final question. When allegedly Mr Chukunyere said these

words to you, were you walking with someone else or on your own?

The Court: When he made this comment, you were with the rest of them or you

were alone?

The witness: I was with the rest of them.

The Court: So you passed by... How close were you to Dishan and the others?

Very close?

The witness: I was walking a bit in the back, but yes I was close to them. .... Not

that far, I mean I just walk to him, like I stop ask the guy, "What did you say?!" and I went back to Dishan, so I was with them, I was not

alone.

Il-Qorti eżaminat il-filmat esibit, Dok.CD, minn fejn jirriżulta li sa minn xi hin wara 1-04:20hrs jidher Chukunyere flimkien ma raģel iehor jitkellmu bi kwiethom fuq taraģ fi qrib ħafna ta Club. Fil-ħin li qattaw hemm diversi kienu l-individwi li waqfu jitkellmu magħhom. Meta saru 04:36:28 jidher grupp ġuvintur u tfajliet b'waħda liebsa shorts abjad miexja wara żewġt ġuvintur. Tidher idur lejn id-direzzjoni fejn hemm Chukunyere u sieħbu u sekondi wara dak li jidher hu Dishan Darmanin jagħti s-salt ghal fuq l-istess Chukunyere. Fl-istess ħin qed jiġi aggredit sieħeb Chukunyere, tant li Chukunyere jipprova jgħinu u jferqu minn ma Darmanin u sħabu. Ma jista' jibqa' ebda dubbju li kien Darmanin li aggredixxa lil Chukunyere (04:36hrs) fejn anke meta jaqa lura mal-art (04:37:11) jibqa' jaqla daqqiet ta sieq minn għand Darmanin li kien liebes shorts twil bajdani. Dan ikompli jballatlu sakemm jaslu l-pulizija (04:37:29) li kellhom jużaw forza biex jrażżnu lil Darmanin u sħabu.

Fid-dawl tal-provi miġjuba, issib li l-imputat tassew wettaq ġrieħi ta' natura ħafifa iżda ta' importanza żgħira fuq il-parte leża.

Għalhekk ġew pruvati t-tielet u l-ħames imputazzjonijiet. Fir-rigward tal-imputazzjonijiet l-oħra l-Qorti qed tillibera lill-imputat minnhom fuq nuqqas ta' provi.

#### Piena

Fir-rigward tal-piena l-Qorti qieset in-natura tal-imputazzjonijiet li qed issib ħtija dwarhom, taċ-ċirkostanzi tal-każ fejn jidher li l-imputat aggredixxa lil Chukunyere wara li ttantalu t-tfajla, ghalkemm dan ma jiskużaħx minn aġir selvaġġ li ma għandux postu f´soċjetà ċivilizzata fejn tirrenja l-liġi u fejn lordni pubblika għandha dejjem tiġi mħarsa. Dak li qed jimmillita favur li l-imputat ma jingħatax piena karċerarja hu unikament il-fatt li dan instab ħati ta′ offiżi t′importanza żgħira. Madanakollu l-Qorti ser tapplika d-dispożizzjoni tal-Artikolu 15A tal-Kodiċi Kriminali.

### Decide

Għaldaqstant wara li rat l-artikoli 17, 31, 214, 215, 221(3) u 338(dd) tal-Kodiċi Kriminali, filwaqt li ssib lill-imputat ħati tat-tielet u tal-ħames imputazzjoni, tilliberah mill-kumplament u tikkundannah għal **xahrejn priġunerija** li bl-applikazzjoni tal-artikolu 28A tal-Kodiċi Kriminali qed jiġu sospiżi ghal <u>sena</u> (1) millum.

Inoltre a tenur tal-Artikolu 15A tal-Kodiċi Kriminali qed tordna lill-imputat sabiex jikkumpensa lil Ndubisi Chukunyere fl-ammont ta' <u>tlett mitt ewro</u> (€300) għall-offiżi kaġunati minnu.

Il-Qorti spjegat lill-ħati l-konsegwenzi jekk jikkommetti reat iehor waqt il-perjodu operattiv ta' din is-sentenza.

Ai termini tal-Artikolu 382A tal-Kodići Kriminali qed tohrogʻ Ordni ta' Trazzin fil-konfront tal-imputat a favur ta' Ndubisi Chukunyere ghal sena millum.
