2. U b'nuqqas ta' hsieb u bi traskuragni jew b'nuqqas ta' hila fl-arti jew professjoni jew b'nuqqas ta' tharis tar-regolamenti,

Pros: Ms. Kessler you hd an accident?

Wit: Yes.

Pros: Can you explain what happened exactly?

Wit: Yes, I was walking my dog at around 7:00 PM.

Pros: We need the date, the time and the location?

Xhud: OK. It was the 4th of June 2022 around 7:00 PM at the roundabout right in front of the Bulebel Industrial.

Pros: Which locality?

Wit: The Bulebel Industrial and I was waiting at the pedestrian crossing to cross the street, which is split in two so you go over the first, then there's a middle aisle and then for the next part of the road and I was waiting on the first part with my dog there was a car that came rushing by, so waited and then the second car that was coming was coming slower and consistently slowing down, and I thought I made eye contact with the driver, so I started because she was slowing down I started walking and then it happened really fast I noticed that I realised that she wasn't going to stop so I pulled my dog behind me and the car hit me and I fell and broke my hand.

Pros: How long does it take you to recover?

Wit: To recover, I don't really know what counts as recover, like when, when they?

Court: Was it more than a month?

Wit: Yes.

Pros: You mentioned as she the driver was a she do you remember her?

Xhud: Yes.

Pros: Can you point it out?

Wit: Yes there.

Qorti: Ix-xhud indikat lil imputat.

Pros: I will show you a sketch and maybe you can illustrate in which part of the zebra cross you were and from which direction to which direction you were going?

Wit: So this is to Zabbar.

Pros: Can you please write it down an arrow with your initials?
From which direction?

Qorti: Is that a zebra crossing or Pelican lines? Are the lights that regulate people crossing or is just a simple zebra crossing?

Wit: It's just a simple zebra crossing. So I was walking that way.

Pros: You were halfway?

Wit: Yeah, I was really halfway, pretty much exactly.

Pros: No further questions your honour.

Adv: Crossn examination, So you told us that you were walking with your dog and can you tell us the breed of your dog, please?

Wit: Ohh, she's a mixed breed, but kind of like Australian Cattle Dog Healthy.

Adv: OK, so would I be right in stating that it's not a small dog?

Wit: No. It's not.

Adv: It's a big dog. Shou?

Xhud: Yeah.

Adv: Am I right in stating as well that part of the injuries that you suffered according to the medical certificate as well you had injuries on your knees?

Wit: Yes, yes.

Adv: And you told us that it was in the evening when the accident happened at 7:00 pm?

Wit: Yes but bright daylight in June.

Adv: Would I be right in stating as well that before you started crossing the zebra crossing, at no point in time did you saw or make any eye contact with the driver?

Wit: Ohh, she was a couple of meters away crossing yeah.

Adv: And she was driving rather slowly you said you thought she was?

Wit: Yes she came at the normal speed and she was already slowing down because right after the crossing is also the roundabout.

Adv: So the speed were the speed of the vehicle was rather low?

Wit: Yeah.

Adv: Would I be right in stating that it was almost going into almost stationary?

Wit: No.

Adv: OK, very low, but not stationary?

Wit: No.

Adv: Jien m`ghandix izjed domandi.

Avu: Mela ara sinjura inti smajt il-Marija Kessler tixhed dwar l-incident l-ewwel nies dakinhar tal- incident inti minn fejn kont ghadek kif gejja jekk jogħgbok?

Xhud: Jien tlaqt mix-xogħol u kont sejra d dar imma kelli għażgla ta' xejn.

Avu: U tinforma nara li l-qorti xogħol x`tagħmel jekk jogħġgbok?

Xhud: Jiena naħdem bħala support worker ili nsuq 40 sena u qatt ma kelli dawn l-affarijiet.

Avu: U is-support worker ix-xogħol tiegħek x`jinvolvi?

- Xhud: Tip ta` Care Worker imma iktar intensive u anki insuq il-klijenti waqt ix-xoghol.
- Avu: U l-klijenti tiegħek allura jkunu nies?
- Xhud: Diżabbi.
- Avu: Nies diżabbi issa mela għedtilna li kont lestejt mix-xogħol kont sejra d dar u ma kellek għażiex ta' xejn it-traffiku kif kien dakħinhar li seħħi l-inċident jew ftit qabel ma seħħi l-inċident?
- Xhud: It-traffiku kien għaddej b'mod normali imbagħad x'ħin konna qed noqorbu lejn iż-żebra crossing islowja u jiena slowjajt ukoll.
- Qorti: Għaliex islowjajt sinjura?
- Xhud: Għax isslowja it-traffic.
- Avu: Imbagħad din Marija Kessler rajtha ma rajthiex?
- Xhud: Din rajtha ġejja fuq il-bankina fid-direzzjoni lejja face to face nharsu lejn xulxin rajtha ġejja baqgħet ġejja x'ħin waslet ħdejn iz-żebra crossing ma għamlet l-ebda indikazzjoni li se taqsam u qabdet u qasmet f'daqqa.
- Avu: U spjegat li kellha l-kelb magħha inti x'rajt dan il-kelb?
- Xhud: Jiena rajt il-kelb bħal jiġibidha fil-fatt meta seħħi l-impatt hija niżlet mal-art u fl-opinjoni tiegħi deherli li ġibidha il-kelb u niżlet ġħarkupptejha fl-art u idejha tax-xellugu l-karozza kienet fuq il-lemin.

- Avu: Issa spjegalna naqra mela lilha rajtha ġejja minn fuq il-bankina fid-direzzjoni opposta,
- Qorti: Għaddiet xi karozza qabel minn fuq iż-zebra crossing qabel ma qasmet hi?
- Xhud: Għaddiet karozza qabel imma ma niftakarx eżatti fi x'ħin I mean.
- Qorti: Ghax kemm ix-xhud qalet li hi kienet qed tistenna fuq iż-żebra crossing tistenna karozza tgħaddi mbagħad ġejt int, għalhekk qed insaqsik.
- Xhud: Jiena rajtha ġejja lilha u wasalna fuq iż-zebra,
- Qorti: Għaliex qed tghid ahna ghax kelelk il xi haddiehor miegħek?
- Xhud: Le jiġifieri jiena u hi wasalna fl-istess ħin fuq fuq l-istess punt fejn sar l-inċident.
- Qorti: Jiġifieri qed teskludi li ghaddiet karozza qablek li din kellha tieqaf biex tgħaddi li s-sinjura kellha tieqaf biex tgħaddi l-karozza l-oħra hdejn iz-żebra crossing?
- Xhud: Jiena jidhirli li jiena u l-vittma wasalna 2 fl-istess ħin fuq dak il-punt li sar l-inċident. Fl-istess ħin tal-inċident.
- Avu: U allura spjegalna naqra mela inti għedt islowa bil-mod ġħax kien hemm it-traffiku quddiemek is-sinjorina l-oħra li kellha l-kelb rajtha fuq il-bankina tajjeb imbagħad x'ġara il-qorti qed tgħidilha wasalna fl-istess ħin l-istess post tal-impatt spjega naqra inti?

Xhud: Hi kienet miexja dehret li se tibqa' miexja fid-direzzjoni li kienet ġejja fiha u f'daqqa waħda daret u qasmet, jiġifieri kienet tidher li ħa tibqa' miexja ma kinitx tidher l-ebda indikazzjoni li se taqsam.

Avu: Jiena m'għandix iżjed domandi.

Pros: Inti semmejt diversi drabi slowja t-traffic. għalfejn slowja t-traffic?

Xhud: Kienet qed toqrob ħafna roundabout viċin ħafna.

Pros: Apparti r-roundabout x'hemm appartu roundabout. Hemm iz-zebra crossing?

Xhud: Iva.

Pros: Liema direzzjoni inti semmejt li inti u l-parti civile wasltu flimkien liema direzzjoni kienet miexja mela għaddejja?

Xhud: Hi kienet miexja gejja minn naħa tar-roundabout lil hawn u jiena mixja lejn ir-roundabout.

Qorti: L-iskizz jurik the point of impact.

- Pros: Inti ghedt kieent miexja naha ohra allura kif sabet ruhha f'nofs iz-zebra cross, inti ghadek kif ghedt li hsibt li kienet miexja naha ohra.
- Qorti: Kienet qed tigi minn faċċata whatever hasbet li ha tibqa' għaddejja u f'daqqa wahda hi taħseb li gibidha l-kelb marret għall fuq iż-zebra crossing.
- Xhud: U ezatti kif wasalna f'dan il-punt ħdejn xulxin qabdet u qasmet hi.
- Pros: Allura il-karozza li kien hemm qablek għalfejn waqfet?
- Avu: Waqfitx il-karozza lanqas ix-xhud ma qalilniex.
- Qorti: Il-karozza ta qabel ix-xhud qalet jiena waqqafha ma stajtx naqsam ghax il-karozza ta qabel baqet ghadejja minn quddiem ma cediliex meta rajt is-sinjura jiena ġarist lejha rajha tisslowja u fhimt li fehmet li jiena ha naqsam piu o meno in suċċint dik hi issa x'inhi l-istorja eżatt mhux ha nghid issa ovvja jien imma l-provi hekk. Qishom speċi ta' zewg veržjonijiet.
- Pros: M'għandhiex mistoqsijiet.
- Avu: Ara sinjura meta nżilt inti hawn jirriżulta li inti nżilt minn fuq il-vettura tiegħek u ovvjament stennejtu il-pulizija tigi fuq il-post inti lil din is-sinjura ghedtilha xi ġaġa x'hin inżid minn fuq il-karozza?
- Xhud: Irrabjajt magħha għax qed tilqa' billi żebra crossing ma tistax taqbad u tiddeċiedi li taqsam mingħajr indikazzjoni ta' xejn mingħajr ma rajt lill karozza wieqfa jew so on.
- Avu: Jigifieri inzilt u għajjat magħha dak il-ħin?

Xhud: Iva iva irrabjajt ħafna għax ġasditni l-ewwel nett. Imma ħafna.

Avu: M'għandix izjed domandi.
