Having heard the prosecution arraign under arrest **Katariina Hanna Marjatta Ryttonen, 27 years, born in Sweden, on the 19/12/1996, holder of Swedish Passport Number 36726709.**

Having heard submissions by the Prosecution on the European Arrest Warrant and having seen the Certificate of the Attorney General in terms of Legal Notice 320 of 2004;

Having heard submissions by Dr. Martin Fenech for the requested person **Katariina Hanna Marjatta Ryttonen;**

Having seen all the documents exhibited in these proceedings;

Having heard the requested person **Katariina Hanna Marjatta Ryttonen** confirm that the person referred to in the European Arrest Warrant forming the merits of these proceedings, is indeed herself;

In terms of Article 10 of Legal Notice 320 of 2004, decides that the person appearing before it, that is **Katariina Hanna Marjatta Ryttonen**, is the person in respect of whom the European Arrest Warrant forming the merits of these proceedings was issued by the Public Prosecutor in Finland;

In terms of Article 11 of Legal Notice 320 of 2004, having informed the requested person, **Katariina Hanna Marjatta Ryttonen**, of the contents of the European Arrest Warrant issued against her and having given her the required information about consent as provided in para. (2) of the same article;

Having explained the provisions of Article 43 of Legal Notice 320 of 2004 to **Katariina Hanna Marjatta Ryttonen**;

Having heard the requested person, **Katariina Hanna Marjatta Ryttonen**, consent to her return to Finland;

Having seen that the provisions of Article 43 of Legal Notice 320 of 2004 have been complied with;
