Karim Cordina (K.I: 501872M) u b'digriet datat 5 ta' Novembru 2014 ġie kjamat fil-kawża Sacha Muscat Inglott li b'digriet tat-30 ta' Jannar 2023 Dr Mario Caruana u PL Silvana Vella ġew mahtura bhala Kuraturi Deputati ghall-assenti Sacha Muscat Inglott.

### Il-Qorti:-

1. Rat ir-rikors datat 8 ta' Lulju 2014 li permezz tiegħu r-riktorrenti talbu s-segwenti:
  1. Illi l-esponenti dahlet f'negożju mal-intimat li kien jikkonsisti f'xiri bl-ingrossa ta' prodotti tax-xorb u l-ikel fosthom kafe, cikkulati u soft drinks mingħand grossista fl-Italja, liema prodotti kienu jinbiegħu b'qliegħ fiss mill-intimat lil terzi persuni;
  2. Illi l-intimat fil-bidu tas-sena 2013 kien fiehem lill-esponenti illi huwa kien ilu jagħmel dan it-tip ta' negozju, u l-qliegħ kien wieħed tajjeb u b'rata fissa. Illi l-intimat għalhekk kien offra lill-esponenti qliegħ fiss fuq dak il-kapital li hi xtaqet tinvesti miegħu għax-xiri u bejgħ ta' din il-merkanzija bl-ingrossa. L-intimata saħansitra qabel li jiffirma kuntratti ma' kull ħlas ta' kapital mir-riktorrenti, li fihom ftiehem ir-rata ta' qliegħ li kellu jitħallas

*mill-bejgħ tal-merkanzija kif ukoll id-data li fiha kellu jitħallas lura l-kapital flimkien mal-qliegħ. Ĝew iffirmati ukoll ċekkijiet mill-intimat lir-rikorrenti li jikkorrispondu mal-ħlasijiet li kellhom isiru f'dati fissi, tant kienet ġiet aċċertata dwar is-serjeta' tan-negozju mill-intimat;*

3. Illi l-esponenti, kif tispjega f'aktar dettal fl-affidavit tagħha anness bħala "Dok A", kienet ħarġet l-ewwel kapital minn flusha personali sabiex isir dan in-negozju mal-intimat, u wara ftit ir-rikorrenti l-oħra, li huma ħabib Ingliz tar-rikorrenti Karina Borg Olivier kif ukoll il-ġenituri tagħha u ħuha, ħallsu somom ukoll bħala kapital lill-intimat sabiex isir dan in-negozju ta' xiri u bejgħ bl-ingrossa, kif jirriżulta mill-affidavits annessi ta' Kathleen Borg Olivier u Nikolai Borg Olivier (bħala Dok B u Dok C rispettivament);
4. Illi fil-fatt l-intimat iffirma tmien (8) ftehim mal-esponenti li kienet qed tirrapreżenta lir-rikorrenti kollha (kopji annessi u mmarkati Dok D sa Dok K), u saħansitra l-intimat min jeddu iffırma post dated cheques li jikkombaċjaw ma kull ftehim u li kellhom id-data ta' meta kellu jsir il-ħlas lir-rikorrenti;
5. Illi l-ewwel ħlas kellu jsir fl-1 ta' Ĝunju 2013 permezz ta' żewġ pagamenti, wieħed tas-somma ta' tnejn u ħamsin elf, mitejn u disghin Euro (€52,290.00) u l-ieħor ta' disgha u erbgħin elf, mitejn u ħamsa u sebghin Euro (€49,275.00), kif jidher mill-kopji taċ-ċekkijiet hawn meħmuża u mmarkati Dok L u Dok M, liema ċekkijiet madanakollu ma ssarfux u ġew referred to drawer.
6. Illi l-pagamenti l-oħra kellhom isiru: fl-24 ta' Lulju 2013 għas-somma ta' sebghha u erbgħin elf, disgha mijha u ħamsa u għoxrin Euro (€47,925.00); fl-10 ta' Awissu 2013 għas-somma ta' ħmistax-il-elf, sitt mijha u ħamsa u sebghin Euro (€15,675.00); żewġ pagamenti fil-15 ta' Settembru 2013 għas-somom ta' ħamsa u tletin elf, sitt mijha u tlieta u disghin Euro u għoxrin ċenteżmu (€25,693.20) u erbgħin elf u sitt mitt Euro (€40,600.00); fl-1 ta' Ottubru 2013 għas-somma ta' mijha u għaxart' elef, sitt mijha u tlettixx il-Euro (€110,613.00); u l-aħħar pagament kellu jsir fis-17 ta' Ottubru 2013 għas-somma ta' wieħed u għoxrin elf, tlett mijha u tletin Euro (€21,330.00);
7. Illi s-somma kumplessiva għalhekk dovuta mill-intimat lir-rikorrenti hija dik ta' tlett mijha u tlieta u sebghin elf, erbgħha mijha u Euro (€ 373,401.00), li minnhom għadu ma tkallu xejn;
8. Illi għalkemm interpellat diversi drabi sabiex jaddivjeni għall-ħlas tas-somma minnu dovuta, li kienu saħansitra jinkludu abbozz ta' kostituzzjoni ta' debitu li madanakollu l-intimat baqa' ma ffirmax, l-intimat baqa' inadempjenti mingħajr ebda raġuni valida fil-liġi;
9. Illi għalhekk kellha issir din il-kawża;

10. Illi dan l-ammont dovut mill-intimat lill-esponenti hu dejn, cert, likwidu u dovut u fil-fehma tal-esponenti, l-konvenut m'għandu l-ebda eċċeżżjoni x'jissolleva kontra l-pagament tad-dejn imsemmi;

11. Illi għalhekk ježistu l-elementi kollha rikjesti mill-liġi a tenur tal-Artikoli 167 et seq sa 170 tal-Kap. 12 tal-Ligijiet ta' Malta sabiex il-kawża tiġi deċiża bid-dispensa tas-smigħ;

Għaldaqstant l-esponenti umilment titlob illi dina l-Onorabbli Qorti jogħġogħba tiddeċiedi l-kawża skond it-talba bid-dispensa tas-smigħ a tenur tal-Artikoli 167 et seq sa 170 tal-Kap. 12 tal-Ligijiet ta' Malta, u taħt dawk il-provvedimenti li jidrilha xieraq:

1. Tiddikjara illi l-intimat huwa debitur tal-esponenti fis-somma ta' tlett mijja u tlieti u sebgħin elf, erbgħa mijja u Euro (€ 373,401.00) dovuta kif fuq ingħad, bl-interessi relattivi mid-data tal-iskadenza għall-ħlas skond kull ftehim sad-data tal-pagament effettiv;
2. Tikkundanna lill-intimat iħallas dan id-debitu, bl-ispejjeż tal-preżenti inkluż dawk tal-Mandat ta' Sekwestru kawtelatorju.

L-intimat huwa minn issa ngunt għas-subizzjoni.

2. Rat illi fil-31 ta' Ottubru 2014 l-intimat Karim Cordina laqa' għal dak mitlub billi qajjem is-segwenti difiżza:

1. Preliminarjament, in-nullita tal-proċeduri odjerni stante li r-rikors ġuramentat ġie preżentat meta r-rikorrenti li qed tidher fisimha propju u kif ukoll għan-nom ta' terzi kienet assenti minn Malta u residenti l-Ingilterra; dana ai termini tal-Artikolu 189 Titolu IV tal-Ewwel Taqsima tat-Tieni Ktieb tal-Kap 16;
2. Illi mingħajr preġudizzju għall-ewwel eċċeżżjoni, ir-rikorrenti ma tistax tidher bħala rappreżentanta ta' persuni residenti Malta kif inħuma Dr Alexander u martu Kathleen Borg Olivier u binhom Nicolai Borg Olivier għaliex dawn iridu jidhru fuq l-atti di sentu;
3. Illi mingħajr preġudizzju għas-suespost u fil-mertu, għal dak li jirrigwarda l-capital mghoddxi lill-eċċipjenti, it-talbiet attriċi għandhom jiġu miċħuda għaliex, fattwalment u legalment, mhux minnu illi kien sar negozju bejn il-partijiet imma kemm ir-rikorrenti u kemm l-intimat kienu vittmi ta' skema frawdolenti mwettqa minn certu Sacha Muscat Inglott li ħajjarhom jinvestu miegħu u rċieva il-flus mingħand il-partijiet sabiex jiġu nvestiti pero wara rrizulta li kien tilifhom f'l-ogħob tal-azzard.
4. Illi qiegħed jiġi preżentat kontestwalment rikors sabiex jiġi kkjamat fil-kawża dan Sacha Muscat Inglott;
5. Illi r-rikorrenti kienet taf eżattament fejn sejrin il-flus u assumiet l-istess riskji li assuma l-eċċipjenti. L-iskritturi li huma palesament infantili delettanteski saru sabiex tingħata sembjanza ta' negozju għall-iskema fejn jiġi nvestiti pero wara rrizulta li kien tilifhom f'l-ogħob tal-azzard.

*ġew miftiehma mgħaxijiet ta' bejn ġamsa u tletin fil-mija [35%] u ġamsa u erbgħin fil-mija [45%] profitti fi tlett [3] xhur medja ta' mijha u erbgħin fil-mija [140%] fis-sena.*

6. *Illi kif intavolati, it-talbiet għandhom jiġu miċħuda għaliex jinkludi ħlas ta' mgħaxijiet imsejħa profitti garantiti, li jeċċedu dak permess mill-liġi.*
7. *Salv eċċeżzjonijiet oħra permissibbli mil-liġi.*

11. Rat illi b'digriet datat 12 ta' April 2021, il-Qorti tal-Appell laqgħet ir-rikors għal-leġġitħimazzjoni tal-atti f'isem Alexander u Kathleen konjuġi Borg Olivier u Karina Borg Olivier, bħala eredi ta' Nicolai Borg Olivier.
12. Rat illi fis-7 ta' Marzu 2022 l-intimat intavola rikors sabiex jiġu maħtura kuraturi deputati sabiex jirrapreżentaw lill-assenti Sacha Muscat Inglott.
13. Rat illi d-digriet tal-20 ta' Mejju 2022, il-Qorti laqgħet it-talba għall-ħatra tal-kuraturi.
14. Rat illi fit-30 ta' Jannar 2023 Dr Mario Caruana u PL Silvana Vella ġew maħtura bħala Kuraturi Deputati għall-assenti Sacha Muscat Inglott.

41. Jirriżulta illi r-rikorrenti Karina Borg Olivier kienet xtaqet tinvesti fin-negozju li l-konvenut Karim Cordina kienet qiegħed jagħmel, liema negozju kien jikkonsisti f'xiri bl-ingrossa ta' prodotti tax-xorb u l-ikel fosthom kafe', cikkulati u soft drinks mingħand grossista fl-Italja.
42. Jirriżulta illi r-rikorrenti Karina Borg Olivier, kif ukoll familjari u ħbieb tagħha kienu ġarġi somom ta' flus li nghataw lil Karim Cordina sabiex isir dan in-negozju ta' xiri u bejgħ bl-ingrossa.

43. Jirriżulta illi bejn l-intimat Karim Cordina u r-rikorrenti Karina Borg Olivier gew iffirmati tmien (8) skritturi. F'kull ftehim ġie mniżżej is-somma illi Karina Borg Olivier kien qed taqbel li tinvesti u li "*This investment will be used as a bridge loan for the use of parallel trading*". In oltre, f'kull ftehim ġiet indikata s-somma illi Karina Borg Olivier kienu ser tiehu lura u d-data ta' meta din is-somma ser tingħatalha.
44. Jirriżulta wkoll illi l-ħlas kellu jingħata lil Karina Borg Olivier permezz ta' ċekk post dated maħruġ mill-intimat Karim Cordina fid-data ta' meta kellha titħallas lura s-somma maqbula.
45. Jirriżulta illi fl-1 ta' Ġunju 2013 inhargu żewġ ċekkijiet iffirmati mill-konvenut Karim Cordina: wieħed fl-ammont ta' tnejn u ħamsin elf, mitejn u disghin Euro (€52,290) u ieħor fl-ammont ta' disgha u erbgħin elf, mitejn u ħamsa u sebgħin Euro (€49,275), liema ċekkijiet ma ssarfux u ġew referred to drawer.
46. Jirriżulta mir-rikors promutur, illi s-somma komplexiva dovuta mill-intimat lir-rikorrenti hija ta' tlett mijha u tlieta u sebgħin elf, erbgħha mijha u wieħed Euro (€373,401) iżda l-intimat baqa inadempjenti.
47. Jirriżulta illi l-intimat Karim Cordina jsostni illi huwa vittma daqs l-atturi għaliex il-flus ġew investiti mal-kjamat in kawża Sacha Muscat Inglott qarraq b'kulhadd inkluż bih u berbaq il-flus fuq il-vizzji tiegħu. Għaldaqstant, huwa Sacha Muscat Inglott li għandu jirrispondi għall-pretensjonijiet tar-rikorrenti.

## Ikkunsidrat

### L-ewwel żewġ eċċeazzjonijiet sollevati mill-intimat Karim Cordina

48. Fir-risposta ġuramentata tiegħu l-intimat Karim Cordina eċċepixxa n-nullita' tal-proċeduri odjerni stante li r-rikors ġuramentat meta r-rikorrenti li qed tidher f'isimha propriju u kif ukoll għan-nom ta' terzi kienet assenti minn Malta u residenti l-Ingilterra dana ai termini tal-Artikolu 180(1)(a) tal-Kap 12 tal-Ligijiet ta' Malta u illi r-rikorrenti ma tistax tidher bħala rappreżentanta ta' persuni residenti Malta kif inħuma Dr Alexander u martu Kathleen Borg Olivier u binhom Nicolai Borg Olivier għaliex dawn iridu jidhru fuq l-atti di sentu.
49. Il-Qorti tosserva illi in vista ta' dawn iż-żewġ eċċeazzjonijiet, din il-Qorti kif diversament presjeduta kienet fl-1 ta' Dicembru 2015 tat-sentenza *in parte* fejn akkoljiet l-ewwel żewġ eċċeazzjonijiet preliminary u ddikjarat li l-proċedura odjerna hija nulla.
50. Illi minn din is-sentenza *in parte*, r-rikorrenti intavolaw appell u l-appell ġie deċiż fl-1 ta' Dicembru 2021. Illi l-Onorabbli Qorti tal-Appell ikkonfermat is-sentenza appellata in kwantu ġiet milquġha t-tieni eċċeazzjoni u filwaqt li ddikjarat li ma hemmx nullita' konsegwenzi għall-eċċeazzjoni mogħtija ornat li fl-okkju tal-kawża issir il-korrezzjoni meħtieġa biex jirrifletti li l-atturi kollha bl-eċċeazzjoni ta' Nicolas Papaioannou qed jaġixxu f'isimhom. In oltre, fis-sentenza tagħha l-Qorti tal-Appell ġassret is-sentenza fil-kumplament, ċahdet l-ewwel eċċeazzjoni u bagħtet l-atti lura lill-Ewwel Qorti sabiex tordna l-prosegwiment tal-kawża.
51. Għaldaqstant stante illi l-ewwel żewġ eċċeazzjonijiet tal-intimat Karim Cordina kienu digħi' ġew trattati, din il-Qorti ser tiproċedi billi tistħarreg il-mertu.

## Meritu tal-każ

52. Il-Qorti ser tibda fl-analizi tagħha dwar il-mertu, billi tagħmel referenza għall-affidavit tar-rikorrenti Karina Borg Olivier fejn hija tispjega illi:

*“Karim Cordina told me that he was already involved in this parallel trading and that the business involved purchasing in bulk from the grossisti in Italy and sell on to wholesalers at fixed healthy profits. These profits would increase if he had the capital to acquire larger stocks of merchandise. He told me that he had always been paid on time and would therefore guarantee the timelines and the amounts and if any payments were late he would charge interest that he in turn would pass onto me.*

...

*Trusting this business venture as a healthy one, I myself convinced third parties to trust me to invest their money on their behalf in this bulk buying business. These were my parents, my brother and friends from London where I live.*

...

*Karim would then proceed to purchase stocks of merchandise and pay the bulk buyer (grossista) directly. With each deal he sent me a signed agreement and even signed corresponding post dated cheques that matured on the due date of payment.*

*Karim agreed, in writing, to repay the investment that myself, my family and some friends from London made, together with the profits we had agreed upon, within three (3) to four (4) months maximum and the returns were the original amount plus the agreed profit, which ranged in amounts depending on each sale.”*

(fol 9-10)

53. Illi dan jinsab ukoll ikkonfermat fl-affidavits ta' Catherine sive Kathleen Borg Olivier kif ukoll ta' Nicolai Borg Olivier. Illi fl-affidavit ta' Kathleen Borg Olivier hija ssostni illi :

*“Ngħid ukoll illi għalkemm ġallasna xi flus direttament lil Karim Cordina, il-kuntratti iffīrmathom it-tifla tiegħi Karina Borg Olivier miegħu u c-ċekkijiet ġarġu f'isimha. Nippreċiża ukoll illi binti tgħix Londra, u għalhekk kien iktar sempliċi li fl-assenza tagħha niltaqgħu ma' Karim Cordina jiena u ibni direttament”.*

(fol 17).

54. Magħdud ma' dan, fl-affidavit ta' Nicolai Borg Olivier huwa jsemmi illi:

*"In order to safeguard our repayments, my sister signed agreements with Karim Cordina, who even covered each repayment with a post-dated cheque in order to guarantee the repayment.*

...

*My sister was keeping an account of all the payments my family including herself had made with Karim, and they signed agreements covering each sum invested. These agreements included a pay-by date, and where even covered by post dated cheques drawn on the corresponding amount of each agreement."*

(fol 19-20)

55. Illi l-Qorti tosserva illi f'kull wieħed minn dawn it-tlett affidavits appena citati, ssir referenza għall-ftehim, ossia, skrittura, illi r-rikorrenti Karina Borg Olivier għamlet mal-intimat Karim Cordina. Illi b'kollo saru tmien skritturi.
56. Illi dawn l-iskritturi jinsabu eżebiti in atti a fol 22-29 tal-proċess. Il-Qorti tinnota illi dawn l-iskritturi saru bejn ir-rikorrenti Karina Borg Olivier u Karim Cordina, fejn f'kull wieħed minn dan il-ftehim hemm imniżżla s-somma illi Karina Borg Olivier qiegħda tgħaddi lill-intimat kif ukoll is-somma li Karim Cordina ser jgħaddi lura permezz ta' cheque lill-istess Karina Borg Olivier u d-data ta' meta ser isir il-ħlas.
57. Illi l-Qorti ser tislet l-informazzjoni hawn fuq imsemmija mill-ftehim eżebiti u tirriproduċiha permezz ta' tabella (fol 22-29):

58. B'hekk, skont dawn it-tmien (8) skritturi, t-total tal-kapital li ġie mghoddi mill-attriċi Karina Borg Olivier lill-konvenut Karim Cordina kien jammonta għal mitejn, sebġha u sittin elf, erbgħa mijha u ħamsa u għoxrin Euro (€ 267,425).

59. Illi kif jidher mill-qari tar-risposta ġuramentata tal-konvenut Karim Cordina, huwa jsostni illi huwa ma għandu xejn x'jagħti lill-atturi ġħaliex huwa vittma bħalhom ta' skema frawdolenti orkestrata mill-kjamat in kawża Sacha Muscat Inglott. Illi fl-affidavit tiegħu, l-konvenut Karim Cordina jgħid:

*“Karina kienet taf sa mill-bidunett illi jien ma kontx involut fl-investimenti in kwestjoni iżda kont semplicelement sejjer ngħaddi l-flus lil Sacha Muscat Inglott, kif fl-aħħar mill-aħħar, għamilt bi flus stess.*

...

*Karina kienet taf li l-problema kienet Sacha tant li infurmatni illi kienet qiegħda tikkorispondi miegħu direttament u tipprova tpogġilu pressjoni sabiex iħallas lura l-flus.*

*B'xorti hażina, x'hin rat li ma rnexxilhiex, sabitha konvenjenti illi ddur fuqi u tipprendi li nkun jien illi nhallasha lura, anke jekk jien kont vittma tal-querq ta' Sacha. Mhux biss qed tipprendi li nhallasha lura l-ammonti li għaddietli biex ninvestilha (€ 180,282 minnhom thallset lura € 3500) iżda talli qed tistenna illi jien inhallasha wkoll il-profitt fazulli li kien weghħdna”.*

60. Il-Qorti ser tgħaddi sabiex tagħmel referenza għax-xhieda in kontro-eżami kemm tal-attriċi Karina Borg Olivier kif ukoll tal-konvenut Karim Cordina ġħaliex il-Qorti tqis illi din ix-xhieda għanda piż probattiv kbir.

61. Illi fix-xhieda tagħha in kontro-eżami l-attriċi Karina Borg Olivier isostni kif ġej:

*“The Witness :*

*Karim spoke to me. Then he ... he discussed this other opportunity that he had that sounded great with ... you know ... you put money forward and get great returns. And he explained that it was completely safe and it was guaranteed and all the money was secure.*

*Dr Joseph Camilleri :*

*OK. In paragraph 6, you state that your many questions and fears were reassured by the defendant who provided you with agreements.*

*The Witness :*

*Correct.*

*Dr Joseph Camilleri :*

*Now you specify that these agreements covered the money you invested with him. Now were did the so called agreements entered into prior to your investing the money or after you invested it.*

*The Witness :*

*They were signed before the money was given. There was one agreement for every deal. There were eight (8) deals and there were post dated checks that*

*were given and signed by Karim to guarantee both the investment and the interest that was being proposed.*

...

*Dr Joseph Camilleri :*

*OK, now ... when you discussed this particular investment, I suggest to you that Karim had already indicated to you that he would invest these funds with a certain Sasha Muscat Inglott?*

*The Witness :*

*No, he told me he was working with Trusted Business Associates and that the money was secure.*

*Dr Joseph Camilleri :*

*When did you first hear about the name Sasha Muscat Inglott?*

*The Witness :*

*I heard of the full name Sasha Muscat Inglott the first time when the money went missing and I went into shock. Because I never had any ...*

*Dr Joseph Camilleri :*

*But would it be correct to state that you were aware that Karim was investing with somebody else?*

*The Witness :*

*I was aware that there were other people involved, but my agreements are only with Karim, so he ... who he speaks and what he does was up to him. I trusted him and the agreements are with him and the post dated cheques are signed by him.*

*Dr Joseph Camilleri :*

*Now, we agree ... it's not contested that you paid substantial amounts to Karim Cordina?*

*The Witness :*

*Correct.*

*Dr Joseph Camilleri :*

*And in terms of the agreement, you were expecting a return on investment of a considerable amount?*

*The Witness :*

*Correct.*

*Dr Joseph Camilleri :*

*Five per cent (5 %), forty two per cent (42 %), forty five per cent (45 %). Emm ... didn't you think that you should check who these third parties were?*

*The Witness :*

*I ... I ... I've known Karim. I've known his family and if ... if ... I work on my word, if someone gives me their word, I trust it. So I didn't go further. Now looking back, yeah, I mean, I'm ... I'm ten (10) years on, I would do things differently.*

*The Court :*

*And am I correct to say that the agreements are these which the Court is showing over there which are ... which are in pages 22, etcetera ... and ... and I have a series of agreements which started on the 20th of February '13 ...*

*The Witness :*

*Correct.*

*The Court :*

*And keep on going through.*

*The Witness :*

*Correct.*

*...*

*Dr Joseph Camilleri :*

*Jekk tista' tixhed ix-xhud ... ghall-korrettezza. Were any amounts from ... of what you invested paid back and who paid you back?*

*The Witness :*

*Of the amount given there was ... after he had gone missing, there was money in transfer and that got returned back and that was three thousand euros (€3000) and then there was a further five hundred (500) paid and that was paid by Sasha.*

*The Court :*

*Sasha Muscat Inglott?*

*The Witness :*

*Sasha Muscat Inglott.*

*Dr Joseph Camilleri :*

*You just stated that there was a payment made by Sasha Muscat Inglott ...*

*The Witness :*

*Ehe ...*

*Dr Joseph Camilleri :*

*And am I correct to state that you had direct contact with him about the repayment of these funds?*

*The Witness :*

*So yes, I chased Karim for updates and to find out what had happened. Karim attempted to get information from the numerous sources, mainly being Sasha Muscat Inglott ... the situation got too stressful for Karim. He then provided a doctor's note from his doctor's stating that the stress was going to affect his aneurysm and that he could no longer be involved and that I would need to speak to Sasha directly. So I started to try to speak to Sasha directly. And Sasha promised payment and that he would make good. After ages he made the one payment of five hundred (500) and then it all stopped.*

*The Court :*  
*Five hundred (500)?*

*The Witness :*  
*Five hundred euros (500) ... yeah. And then ... and then it stopped."*

*"The Court :*  
*So the Court is showing you these ... these eight (8) agreements that I have ... that I have in front of me ...*

*The Witness :*  
*Yes I made those.*

*The Court :*  
*You know about them.*

*The Witness :*  
*Yeah, absolutely.*

*The Court :*  
*There is one ... emm ... these are in pages 22 till 29 ok ... They date from the 20th of February till the 17th of June of 2013. And am I to understand that they are signed by you underneath here? Is this your signature?*

*The Witness :*  
*Yes ... yes ...*

*Dr Edward Debono :*  
*And that's Karina's signature?*

*The Court :*  
*And underneath...*

*The Witness :*  
*I don't know. Ask her.*

*Dr Edward Debono :*

*No, no, no. I mean did she sign it in front of you?*

*The Witness :*

*No. No.*

*Dr Edward Debono :*

*In your presence?*

*The Witness :*

*No, because no ... because we never ...*

*...*

*Dr Edward Debono :*

*On the various dates there are there ... which are stipulated in the agreements you gave her post dated cheques and that the cheques are signed off ... from your account and signed by you?*

*The Witness :*

*Yes, they are.*

*Dr Edward Debono :*

*OK. And the signature on the cheques is yours?*

*The Witness :*

*Absolutely, absolutely.*

*The Court :*

*So the cheques ... though the Court is showing you two cheques cause I ... I only have two cheques.*

*The Witness :*

*They're only those cheques ...*

*...*

*Dr Edward Debono :*

*OK, the scam came out from Sasha?*

*The Witness :*

*For sure ... and he scammed other people after us. So that's why he's no longer in Malta.*

*Dr Edward Debono :*

*Who spoke to Sasha?*

*The Witness :*

*I did.*

*Dr Edward Debono :*

*You did.*

*The Witness :*  
*For sure.*

*Dr Edward Debono :*  
*And Karina only spoke to you, correct?*

*The Witness :*  
*For sure. Yeah.*

*Dr Edward Debono :*  
*So the relationship for this deal was between you and Karina and nobody else.*

*The Witness :*  
*No, that's it. But no, it was between me and her, but there was the third. There was Sasha. Without him this would never have happened.*

*Dr Edward Debono :*  
*And then ... and Sasha, but ... Karina never spoke to Sasha. She only spoke to you, she said.*

*The Witness :*  
*I don't know. I don't know who she spoke to.*

*Dr Edward Debono :*  
*She spoke to you. Yeah, she gave the money to you.*

*The Witness :*  
*For sure. Yeah.*

*You wrote the cheques to her?*

63. *"Dr Edward Debono :*

*Were they passed on to you, those amounts?*

*The Witness :*

*No, not ... no ... not those amounts, no. Much less one ... minus the percentage ...*

*Dr Edward Debono :*

*Minus interest.*

*The Witness :*

*Sorry, minus interest. Yes.*

66. Għaldaqstant, il-Qorti tqis illi r-responsabilita' tal-konvenut Karim Cordina hija waħda ċara. Huwa stess jammetti illi kien konsapevoli bl-iskritturi a fol 22-29, jammetti li hu ffirma l-istess skritturi, jammetti illi l-flus ingħaddew mingħand l-attriċi Karina Borg Olivier direttament għal għandu u saħansitra ġew eżebiti in atti żewġ (2) ċekkijiet pagabbli lill-attriċi maħruġa u ffirmati minnu mill-kont tal-istess konvenut.
67. Il-fatt illi l-intimat Cordina jikkontendi illi huwa kien vittma ta' raġġiri ta' parte tal-kjamat in kawża Muscat Inglott huma irrilevanti għall-proċeduri odjerni, u ċertament r-rikorrenti ma għandha tbagħti ebda konsegwenza għal kwalsiasi raġġiri illi Cordina jista' jikkontendi illi sarulu da' parte ta' Muscat Inglott. Dik hija kwistjoni prettament bejn Cordina u Muscat Inglott, u ċertament mhux meritu tal-proċeduri odjerni.
68. Illi b'hekk il-Qorti tqis illi s-somma mogħtija mill-attriċi kif dokumentat fit-tmien skritturi in kwistjoni għandha titħallas lura mill-konvenut u dan biss relativ għall-kapital illi ġie mghoddi minn Karina Borg Olivier għal għand l-intimat Cordina. Illi kif digħi aċċennat dan jammonta għal mitejn sebgha u sittin elf, erbgħha mijja u ħamsa u għoxrin Euro (€ 267,425).
69. Il-Qorti tosserva illi kif isostni l-istess attriċi kemm fl-affidavit tagħha kif ukoll fix-xhieda tagħha in kontro-eżami, hija giet mogħtija lura s-somma ta' tlett elef u ħames mitt €Euro (€3500). Għaldaqstant, il-Qorti tqis illi din is-somma għandha titnaqqas minn dak illi l-konvenut għandu jħallas lill-attriċi.
70. Illi b'hekk, fid-dawl ta' dan kollu, l-konvenut Karim Cordina għandu jħallas lill-attriċi Karina Borg Olivier s-somma ta' mitejn, tlieta u sittin elf, disgħha mijja u ħamsa u għoxrin Euro (€ 263,925).
