Xhud: Jannar 12 ta` 2023.

Pros: L-accident hemm sar?

Xhud: L-accident sar jekk tippermettuli bil-biro DOK C1.

Pros: C3 fejn jiftakar li kien ezattament meta gara l-incident?

Xhud: Huwa qed jgħid illi kien qiegħed jistenna biex id-dawl jiġi aħdar u li huwa C3.

Pros: Il-karozza jiftakarha li laqtitu?

Qorti: Jigifieri l-karozza telgħet fuq il-bankina?

Xhud: Iva qed naraf il-karozza d-dokument huwa C8.

Qorti: U kif laqtitu l-karozza u telghet fuq il-bankina kif ghax fuq il-bankina qed nifhem?

Xhud: Huwa qed jghid li meta raha il-karozza gejja huwa gie blackout raha dalma.

Qorti: Minhabba li wegga imma jigifieri?

Xhud: Huwa qe isssostni li kellu blackout.

Qorti: U ma jafx kif gara l-incident?

Pros: Ha nagħmillek referenza għal xi ritratti. C2 hawnhekk qed tirreferi nti?

Xhud: Mhiniex nara l-pelican crossing imma hawnekk, jiena qed nara fuq C1.

Qorti: Dak kien il-lokalita tal-incident, inti x`kont passiggier?

Xhud: No kont qed insuq warajha.

Qorti: Wara min please?

Xhud: Wara l-karozza li kienet involuta fl-incident.

Qorti: Il-karozza min kien qed isuqha qed tarafghu fl-awla?

Pros: U x' ġara wara?

Xhud: Ppruvajt nitkellem ma' dak li weġġa' bažikament rajt li huwa cognitive li għandu r-rispons so at that moment jekk mhux sejjer żbaljat is-sinjura tiegħu kienet iċċempel ambulanza digħi hemm fuq it-telefon u ħaddtilha il-mobile biex ngħinha biex biex incempel lill-ambulanza għax kienet qiegħda in a panic state.

Pros: Inti għedt kien hemm distanza ta' 2 karozzi jkun hemm xi karozzi oħra li waqqfu?

Xhud: Li nista ngħid qed mument kulma kont moħħni fil-dak li kien qiegħed inweġġa' pero li nista' ngħid wara qisu a couple of minutes li tellajt rasi kien hemm slow moving traffiku warajh anke xi karozzi weqfin warajja hi wkoll minħabba l-fatt li kont wieqaf fin-nofs.

Pros: M'għandix iktar mistoqsijiet.

Avu2: Kontro eżami Sur Fenech Bongu mela allura ngħid sew li inti l-inċident essaġġ ma rajtux imma rajt x' gara wara?

Xhud: Rajt l-aftermath tal-hit jiġifieri rajt l-ilma li nimmaġina kellu xi flixkun tal-ilma fidu rajt lil ma jtir u naħseb anke.

Avu2: Daqekk biss rajt inti?

Xhud: Ehe.

Avu2: Issa inti spjegajtilna li waqquft fuq il-post biex tara x' gara u ma ġarax ara ngħid`x sew li dak il-persuna ghedtilna ġuvnott ta' warajk kien jinsab ħafna iktar il-fuq mill-pelican crossing tiftakarha din?

Xhud: Ma nistax niftakar li kien hemm xi distanza notevoli.

Avu2: Pero ma kienx eżatt ħdejn il-pelican crossing naqblu?

Xhud: Eżatt eżatt le imma kien viċin ġafna nista' niftakar.

Avu2: Xejn iktar.

Tamsin Jane Pace, xehdet h ekk

Pros: Miss Pace you saw an accident?

Xhud: Yes.

Pros: Can you tell us when, where and the dynamics the accident?

Xhud: So it was in January last year, on the coast road.

Pros: You remember the date?

Xhud: The exact date, no, I'm afraid I can't remember the exact date. We were on our way to work I was on crutches Pauline had come to take me to work. And we were driving up the coast road, and we came across the traffic lights, which were green. And then we heard.

Qorti: You were in a vehicle?

Xhud: I was in Pauline's car.

Qorti: Who is Pauline's car?

Avu2: Kienet mal-imputata.

Xhud: I was in the car she was taking me to work Yes, because I was on crutches so she was taking me to work.

Qorti: And you`re saying that the lights were green and what happened?

Xhud: Yes, we heard a noise and we wondered what it was, and we stopped and we saw that someone was on the floor.

Pros: I am showing you C1 and C3 was it the same road?

Xhud: Yes, the coast road.

Pros: I'm showing you C8?

Xhud: Yes, that's the car and that's me in the car. I wasn't able to get out the car because I was on crutches.

Pros: At which stage you saw the other person?

Qorti: She already said they that heard a bump and they come out of the car. She couldn't come out of the car. But did you actually see the person on the floor?

Xhud: No, I didn't see them on the floor because it was a bit behind me and I couldn't manoeuvre very well. Because of the crutches, yes.

Qorti: So how did you know that it was a person?

Xhud: Because Pauline had looked in her mirror and said, I can see someone, behind uh huh, But I could, as I say, I could not get out of the car. And if I'd opened to try and get out the car, it would have been into the traffic.

Pros: Why do you remember, How come? Do you remember the colour of the lights?

Xhud: Because if they, if they'd been another colour, we would have stopped. If they were red, we would have stopped.

Pros: Anything else? Do you remember?

Xhud: No.

Qorti: Cross.

Pros: After your daughter saw the person from the mirror, what happened?

Xhud: She's not my daughter, She's a work colleague, a friend.

Pros: Your work colleague the friend what happened?

Xhud: She was aware that she bumped someone, she hit someone.

Qorti: She said something, she heard something hit the car. Then she saw in the mirror that it was a person.

Pros: What happened afterwards?

Xhud: Well, obviously she got out and ran and went back to see exactly what had happened.

Pros: Did it take a long while, a long distance to stop?

Xhud: No, as soon when she, when stopped, it was. We heard something we looked each other and said, what is that? She looked in her mirror and stopped.

Pros: Do you drive?

Xhud: Yes.

Pros: What manoeuvre did she do? Your friend?

Xhud: She was driving straight up the road.

Qorti: She's very clear in her evidence. She's extremely clear in her evidence. She said the lights were green. We kept on going. You asked her, why are you saying the lights were green, because if they were red, we would have stopped. We were moving. We heard boom. We didn't know what it was. We stopped. Well, the driver stopped. The driver looked in the mirror and she said something probably like, oh my God, there's a person in the road, I would imagine and the driver went out to see what had happened and the distance was not very great a I under standing?

Xhud: Yes exactly, it wasn't very great noo. In fact, you can see here it's not a very great distance in the picture here, you can see DOC C8.

Qorti: So you confirm that the car stopped there and was not moved until the police came coz those are photos by the police.

Xhud: No, we didn't move. The police told us to stop there.

Qorti: So the police found the vehicle where the vehicle had been stopped after the what you described?

Xhud: Yes, exactly the vehicle was not moved in any way, shape or form. In fact, We had to stay there until the hospital

until we were told to move by the police. We stayed in exactly the same spot.

Qorti: Anything else? Cross.

Adv: So Miss Pace, so am I correct in stating that the point of impact was on the right hand side of the car maybe I can show you a photo here.

Qorti: One moment, is it exhibited in atti that?

Xhud: Yes, on the driver's side on the right hand side.

Xhud: C7.
