As you have been charged with having on the 6 th April, 2023 between 14.00 hrs u 15.00 hrs in Triq il-Mina Hal Kirkop, Kirkop drove vehicle with registration number PQZ 180;

- 1. Without a driver's licence by the Authority of Transport in Malta. Sec. 15(1)(a)(3) chap . 65.
- 2. And through impruidence ,carelessness, unskillfulness in his art or profession, or non -observance of regulations and caused Adrian Pace involuntary slight injuries as certified by Dr. Ian Gauci M.D. of Paola Health Centre chap 9 Art 226(1)(c).

3. And through impruidence ,carelessness, unskillfulness in his art or profession, or non -observance of regulations and caused Leanne Pace involontary slight injuries as certified by Dr. Maria A. Zammit M.D. of Paola Health Centre chap 9 Art 226(1)(c).

The Prosecution requests that the mentioned person be disqualified from all his driving licenses

The Court is humbly requested that in case of guilt also deducts points from the driving license as indicated in Sl 65.18 Art 36B and in 65.18 Sixth Schedule

Having seen articles 226(1)(c) of Chapter 9 and 15(1)(a)(3) of Chapter 65 and Sl 65.18 Art 36B and in 65.18 Sixth Schedule of the Laws of Malta

Having seen all the witnesses produced by the prosecution Having seen that the accused did not give testimony Having seen all the documents, testimony and evidence in the proceedings

## **Considerations of this Court**

There is no witness to the dynamics of the accident and of the fact that the accused was driving a vehicle. The accused was not cautioned before he made his statement to the police and

therefore this cannot be taken into consideration. Therefore non of the charges have been proven.

# **Decide**

For these reasons and after having seen Articles Articles 226(1) (a) chap 9 15(1)(a)(3) Chap 65 and S.L. 65.18 Art 36B and in S.L. 65.18 Sixth Schedule. of the laws of Malta finds the accused **Md Maktum Hasan Sourav**,not guilty of the charges.
