Wendy Newman, xehdet hekk

Pros: Ms. Newman did you see any incident?

Wit: I didn't see any accidents the accident happened he landed in front of my car and the victim of the bike landed in front of my car.

Pros: What car was it?

Wit: What car I had Peugeot 308 at that time.

Pros: What was the number plate?

Wit: I don't remember of that car now, as I turned into the road I heard a scream.

Pros: When was it and where?

Wit: I don't remember of the Hotel on the corner of the Hotel.

Pros: Which locality?

Wit: In Bugibba or Qawra so from the seafront I turned right up to the road I'm not sure it was called Domen or something a big Hotel which was on the left and I was just turning and its there that happened I saw the body of the motorcyclist on the road.

Pros: You were driving on which side of the road?

Wit: I was turning right into the road.

Court: You were on the left?

Wit: Yeah yeah I was turning it was quite a wide road.

Court: And you found this person on the left in front of you when you turned the road?

Wit: He was in front of me so as I turned to the road I would say his body was being in the middle of the road, from I can remember now of the accident and then I just stopped I parked my car to the left and I went to him I was the first person that I get to him I held him in the same position he landed so he did not move because I was obviously he was in a lot of pain and as I was holding him the driver of the car she the driver of the car she moved up a bit already from the accident so I was already near the body when she came and then she came down and she held his head and I told her not to take the helmet off because of to keep the helmet on and leave it to the paramedics so she said that she knew not to take it off I`m sure that she told me that she was a nurse so she didn`t need to she knew not to take it off and then somebody I heard call the paramedics at the time position because she said that it was a one way she went up in she said ooh my god I taught it was a one way at the time she was holding his head the bike was still running I was I`m shouting somebody please try and turn the bike off cause it was still running and then I just waited for the paramedics come from then.

Pros: So the bike was in front of you?

Wit: It was to the right side of me it was to right side of th body he was the bike over here against the car.

Pros: And the other car which side was it?

Wit: She moved up to the Hotel got like a turning point in it so she`d pulled away and parked away, away from where the accident happened. The car it hit the motorbike had moved as I went to the body it was up round as it was going to the Hotel when I saw the car it was like to the left.

Pros: Do you remember on which part the accident happened?

Wit: Noo I didn't see the accident just the body on the floor.

Pros: No further questions.

Court: Cross.

Adv: So do you know th names of the roads?

Wit: OOhh I'm sorry I don't know?

Court: Were you coming from the coast?

Wot: I was coming from the coast from Bugibba away from Bugibba square so I was coming up and I turned right and there`s like lane that you go on the left and the lane comes on the left and I turned into the right and I saw the accident.

Adv: You were driving towards the Strand the Bugibba Strand the?

Wit: No no I come from Bugibba way and I so I had cross over the road to turn right I turned right into the road.

Court: From the coast?

Wit: From the coast road yes.

Adv: From the coast going up towards Dolmen Hotel?

Wit: Yes an di turned right.

Adv: And you`re saying that the bike was in front of you driving in front of you?

Wit: No no no he wasn`t in front he was on the floor when the accident it happened.

Adv: Ok I misunderstood, ok understood so the moment you came from the coast road lets call it that and you took a right went up a little bit of a hill and you found the motorcyclist on the floor?

Wit: Yes.

Adv: Ok so you didn't see the impact or anything?

Wit: No no.

Adv: Ok but then you said something that the vehicle moved a bit upwards did I understand correctly?

Wit: Yes yes I got him before she did she just moved up his body was,

Adv: So she moved the car?

Wit: Yes yes yes she moved a bit.

Adv: So when you arrived and the motorcyclist was on the floor you noticed that this vehicle do you remember the color can I suggest that it was like a dark red maroon?

Wit: To be honest I don't remember I have on my phone.

Adv: But you remember it was the car involved in the accident?

Wit: Yes.

Adv: And you saw the driver of this vehicle who you remember it was a she because I heard you say it?

Wit: Yes yes.

Adv: That moved the car upwards?

Wit: Yes.

Adv: Do you remember she moved the car upwards and to the side?

Wit: Yeah she pulled in there's an entrance to the Hotel she pulled up and just slightly to the left.

Adv: Were the police there in that point on time?

Wit: No because it just happened.

Adv: Thank you very much.
