Xhud: Yes.

Avu: What details can you give the court, please? All you know

about this case from what you saw?

Xhud: So I was driving behind the car in front of me, which was I

think Mr. Formosa is the name. And all of a sudden it crashed in front of me, he turned to the right and a vehicle

that was not visible before was all of a sudden.

Qorti: What do you mean he turned to the right?

Xhud: He turned into a into a street so he was driving.

Qorti: He was on the main road and turned into a side road so he

crossed the other lane?

Xhud: He crossed the other lane Yes, obviously, yes.

Avu: So how far behind Mr. Formosa's car were you?

Xhud: A good 30 metres, I guess. So it's a little bit higher level I

was a little bit higher, so I could see much more I was not just directly behind him, so I didn't even have to brake

while he was turning I was this far away.

Avu: What was his speed more or less?

Xhud: He actually halted as far as I could see he stopped the car

because he was waiting for another car to pass. There were apparently two cars. So he was waiting for one car to pass

and then he turned and then all of a sudden it crashed.

Avu: So when you say he was waiting for one car to pass, which

car are you referring to?

Xhud: There was the car that was coming from the other side on

the other lane exactly.

Avu: So before turning onto the right, he stopped?

Xhud: Yeah, pretty much so that's what I remembered.

Avu: And what about the other vehicle? I mean, did you notice

anything particular?

Xhud: No, it was. You couldn't see it It was basically behind the

second car, but it was dark and I'm pretty 99% sure that the

car didn't have the lights on.

Avu: The other car?

Xhud: Yes it might have been just starting from parking lanes

there I have no idea it was invisible.

Avu: So you're stressing that the other car did not have the lights

on?

Qorti: No he said he's almost 99% sure.

Xhud: I'm 99% sure that that's the only. That's the only thing that

I can come up with because it was really not there, I couldn't see it I saw him stopping, waiting for the other

car.

Qorti: The other car had lights on?

Xhud: Yes, the other guy had lights on I saw the other car passing

I didn't even as I said, I was far enough, far, far away

enough I didn't have to slow down even.

Qorti: So the car with lights on and the and The car in front of

you stopped to let it go by?

Xhud: Exactly.

Qorti: Then suddenly the crash occurred but you did not see a

second car and you arrived at the conclusion that probably

didn't have lights on.

Xhud: Yes.

Qorti: Coz you hadn't seen it.

Xhud: Yes, exactly.

Qorti: Like you saw the car before?

Xhud: Exactly I saw the car before perfectly So I didn't, I didn't. I had to then also break all of a sudden because I thought he would be gone before I even arrive. So he turns, the car in front of me, turns normally and I could just.

Qorti: He couldn't see it was not because there was something in the road that stopped him from seeing it. You arrived at the conclusion that the only logical answer was that because that vehicle's lights weren't on?

Xhud: Exactly the corner is not lit up at all. The corner.

Qorti: Yes, but the corner is not lit up is one thing.

Xhud: Yes, exactly.

Qorti: The car did not have a it's lights on is another.

Xhud: Yes. Yeah, I mean 100%. The corner is not lit up I just made it obvious, if the corner had been lit up, I guess if the street would have been lit properly in front of the school, then I think he would have seen it either and I would have seen the car coming as well. But it was invisible, it was

dark. It was a dark car as far as I remember. And there was no car for either of us to see.

Avu: So just to clarify, when you're referring to a car not having

the lights on, you're referring to the car coming?

Xhud: Yes, yes, exactly, the car.

Avu: And after the impact, what did you do?

Xhud: Well, I. I stopped and I tried to figure out what was going

on obviously two cars I think I checked on the car that was in front of me first, the second one as well, and then just basically gave not first aid, but help where I could. There was another person that was calling the ambulance and police and I basically was just there holding the guy's leg

up for 20 minutes until the ambulance arrived.

Xhud: Yeah, she was fine. She got out of the car, she stepped out

of the car, sat down and then. Then I started taking care of the other guy. As I said, there was a second person there

who was calling, then the ambulance.

Xhud: Yeah, yeah.

Avu: Did you see anything particular on the car?

Xhud: No, no, no, nothing, but that there were crash but nothing,

you know, like.
