The Court

Having seen the charges against Petru Dorin Neagoe born on the 05/06/1988 residing 80, Mon Cherie, Triq Cikku Bonaci, B`Kara ID No: 147756A.

As you have been charged with having on the 27th of April 2019 at about 4.30 hrs, at Rue D`Argens, Gzira. drove vehicle with registration no: DCA492;

- 1. You drove vehicle no CCJ762 in a dangerous manner;
- 2. You drove vehicle no CCJ762 in a negligent manner;

- 3. You drove vehicle no CCJ762 in a reckless manner;
- 4. Also through imprudence, negligence or, unskillfulness in your trade or profession, or trough non-observance of any regulation, caused any fire or any damage, spoil or injured when you collided with vehicle No Ken107 and you caused involuntary damage to the mentioned vehicle to the detriment of Kenneth Mifsud.
- 5. Moreover through imprudence, negligence, carelessness, unskillfulness in your art or profession, or trough non-observance of any regulations, you caused involuntary grievous bodily harm on the person of Kenneth Mifsud and produced the effects mentioned in article 218 of chap. 9. Laws of Malta, as certified by Dr. Alexander Grima (Reg. Med 4137) of Mater Dei Hospital.

The Prosecution requests that the mentioned person be disqualified from all his driving licenses.

The Court is humbly requested that in case of guilt, also deducts points from the driving licence, as indicated in S.L. 65.18 Art 36B and in S.L. 65.18 Sixth Schedule.

Jovana Vucic gave testimony regarding the accident in question She was a passenger with accused and stated that the vehicle she was in crossed the traffic lights when they were green .

Ronald Mifsud gave testimony regarding the fact that he was on the site of the accident after it occurred and he confirmed that he took photos Dok RM1 and RM2 at that time.

Petru Dorin Neagoe, testified as follows

Court: You swear to say the truth, the whole truth and nothing but the truth so help you God.

Wit: I swear.

Adv: Mr. Neagoe you know about which case we are speaking

here today you know the accident we have been speaking

of can you explain to the Court step by step what

happened?

Wit: Yes, in the morning of 19th April 2019 I was coming from

work with my colleagues in the car I don't his name one of them and Jovanavic they were inside the car with me we were coming from Level 22 where we were working and on Rue D'Ardens I had to make a stop before the traffic

lights to leave Ms. Jovana because she had to leave,

Court: You were driving up the hill or down?

Wit: Down the hill towards to towards Msida. After I left Miss

Jovana down I continue my road I saw that the traffic

lights, there were no car in front of me that the,

Court: Which traffic light?

Wit: The traffic lights on the road Rue D`Argens.

Court: Which ones I think?

Wit: They are the only ones.

Court: The ones that the end of the road?

Wit: The one that they cross.

Adv: Wait, so that we don't get confused, So you said you were

coming down the hill, so you were coming from Sliema

towards Msida?

Wit: Yes.

Adv: Explain which traffic lights?

Wit: So the traffic lights there, This one is the one that makes

the cross between Rue D'Argens Road and the road that's coming down from Manuel Island towards to San Gwann.

Court: OK, alright, there's the, this is this is the traffic lights.

There's there's this on the corner, this establishment right?

Wit: Yes, yes, yes. Yes.

Court: You talking about this one DOK P8?

Wit: Yes, so I saw that traffic lights is green so I continue my

road when I reached the traffic lights a car came from the

left side from down from Manuel Island.

Court: So you were coming down and from the left, coming up

from the from the sea?

Wit: Yes from on the side of the sea, from my left side. He

came out I saw him coming out I flash I horned I saw that he doesn't stop he was looking at me and he didn't have no reaction. He was just continuing straight. I tried to avoid the accident he hit my wheel, my front wheel he hit my

wheel,

Court: You stopped?

Wit: Me I tried to brake.

Court: You stopped at the light?

Wit: No, I didn't. I didn't stop. I didn't stop.

Court: The lights were green?

Wit: The lights were green for me.

Court: Always they were green for you?

Wit: Yes yes, so the lights were green, so I didn't have to

stop. I just continued the road. Now he came out from the

left side, hitting my wheel,

breaking my braking system and push me in the right side, all the cars from the right side that they work park after that I came out from the car I went towards to his car to see if he's OK. I asked Mr Andre, my colleague that he if he's OK, He said that he's OK So why came down from the car? And I went to his car to see how, now when I reach his car, I ask him if he's OK He said he didn't know what he was asking what happened, what happened? What happened? He was confused.

Adv: Who was confused?

Wit: The driver, Mr. Mifsud so after.

Court: So Mr Mifsud, the one in the car that came out from your left hand side?

Wit: Yes, yes, from the Peugeot, now after that I saw a lot of people coming, my colleague was coming, She came as well. She was one Jovanavic, she was the first one coming to the car she came obviously she came to me because I was her colleague, so she came to me to ask if I'm OK.

Court: And is there your car in this photo DOK P6?

Wit: Yes, this one, The Mercedes.

Court: Mark it with red please, ok And the other vehicle which

came out from your left is it in this photo?

Wit: Yes.

Court: You did an X right next to your car?

Wit: I did an arrow.

Court: Now can you mark the other car please?

Wit: Yes.

Court: So the larger black car is yours and the smaller of th other

party went fron the other side?

Wit: Yes.

Adv: Mela you are saying that after the accident you go to the

spot where Yovanna came to you?

Wit: Yes, and me, I was at the car of Mr.Mifsud. I was

checking to see how he is when when I lean towards to his car to see if he's OK I felt a hard smell of alcohol after that I told they came some people from the side I don't know who they are There was a Lady and the Man which opened the door and pull him out from the car, me telling them, explaining them that after an accident you can't touch the

victim, you have to leave it there because they can, they can harm him more. They didn't understood, they just took him out I don't know I didn't understand why there was no danger of fire There was no danger of nothing There was no leakage of the of petrol or something so everything after that the police came immediately. My car, because he had it, has a system of calling the ambulance and in case of collisions it was on call with the police. They already knew what happened with the accident and everything so I just tell them where we are. They said no, we know exactly where they are and the ambulance came first and took Mr Mifsud after it came the Seargt and they explain everything to the Seargt.

Adv:

Ok, When you were testifying, you said that due to the accident, when the other car hit your wheel, it broke your braking system. What do you mean?

Wit:

So obviously as you can see the there are some pictures where it shows the left wheel of my car.

Court:

If you have a picture where this show this, can you?

Wit:

It's P6. On P6 as you can see the left wheel of my of my car, the front wheel, it's broken and it's pushed inside, so it changed It changed my direction Plus it changed obviously me I tried to avoid him, so if he wouldn't hit my wheel, I could have avoided not to hit the other cars I could have avoided him as well.

Court:

So you are saying that because of the impact with the the vehicle that came out from your from my left side it

damaged your wheel in such a way that you could not control the vehicle totally?

Wit: Yes, and they remain without brakes, yes, because of the

the accident I think so it shows in the in the report that the brakes they were damaged, the pipes of the bricks where

the show, it shows in the report of the insurance.

Adv: You were driving the car what happened to the brakes?

Wit: I just remained without brakes, just the pedal went up, up,

down, after the heat it went straight to the floor so so

before I couldn't control it.

Court: So before the accident the brakes were lacking?

Wit: Of course the car was new I had it for 4 months so the car

brand new.

Adv: Who was on the main road? In this case?

Wit: Me I was driving in Rue D`Argens.

Court: So your vehicle went into other parked vehicles?

Wit: Yes, on another five cars from the side.

Adv: You sad that,

Court: What was your speed please?

Wit: It was around 45/50.

Adv: You said that after the accident you approached Mr.

Mifsud and you could smell alcohol?

Wit: Yes.

Adv: What was his behaviour after the incident?

Wit: Like he was, he was asking a lot what happened, what

happened. He didn't know what happened so he was not aware of the accident like a person I was working I was working in the club for nine years so I saw a lot of drunk

people and I know the behaviour is not that.

Adv: When you say behaviour of drunk people. What did you

see?

Wit: So I saw him like he was not able to control himself, for

example I'm not speaking about his because I understood

he I'm not an expert.

Adv: For example?

Wit: That he was not able to stay on his legs.

Adv: When you went to speak to Mr. Mifsud after the accident

was he alone in the car or was he with other people?

Wit: No he was alone.

Adv: No further questions.

Adv2: Cross, so I'm going to refer to the statement of various

other individuals that were present with you in the vehicle in the statement you gave tot he police, Am I correct to state that you were heading to the airport to take one of

your friends to the airport for a flight?

Wit: No nothere's a mistake.

Adv2: You were not heading to the airport?

Wit: No, I was not heading I was heading home and it was, it's

written in the report that on Mr Andre he he left the site because he had to go to the airport me I was driving him

home.

Adv2: Now when you were coming down in triq Rue D`Argens

it's a very long road road and you can see the traffic and

you said that you were the only vehicle there was no, there was speaking in front of you, correct?

Wit: Yes.

Adv2: And did you see the traffic lights from the beginning of of the road? Did you have a clear vision of the traffic light from when you were coming down triq Rue D`Argens?

Wit: Yes.

Adv2: And what was the the colour of the traffic light?

Wit: Green when I stopped. I don't understand the question.

Adv: What if you're if you're 250 metres away, you don't look at the traffic lights where when there are others before and when they had to stop it, when they had to stop someone to to to alight from the car.

Adv2: Mela, what was the colour of the traffic light?

Court: When he was going up to the lights, it was green. What the lawyer is asking you is before from before further up the road if you noticed, Was it always green or was it another colour?

Wit:

I think it was another colour I didn't notice me. I notice when I after I left Jovana and I started driving, I noticed the traffic lights before that I we were speaking inside the car we were speaking about the night while how it happened. So I didn't pay attention at the traffic lights because I was not going to pass the traffic lights until I stop. You know, it was not the first time that I stopped with my colleague to leave her home, that's why I didn't notice. I'm sorry.

Court: So you left you, You dropped her off in Rue D'Argens?

Wit: Yes, in Rue D`Argens.

Court: You dropped her off to Rue D`Argens and up to that point you weren't interested in the lights because you were going to drop your friend off?

Wit: Yes.

Adv2: And then when you drove off, you said you all you always saw the traffic lights green?

Wit: Yes, I saw even that was the reason that I told Jovana that I saw the traffic lights coming green and we said bye so I continued the road.

Adv2: And at which stage did you stop this person, Jovanna, and at which stage in Rue D`Argens? It was, it was in the beginning of the of the road?

Wit: No the distance, the distance that I saw from the traffic

lights I think so it's around 70 to 80 metres distance the 2nd Rd that goes on the left from the traffic lights up. It's

there are two roads. The first one.

Adv2: Is there, there's establishment this Savoy gardens?

Wit: After After the Savoy Gardens.

Adv2: Now when you came, when you were crossing the traffic

lights, you you maintained a constant speed Or did you slow your vehicle since you're passing through the traffic

lights?

Wit: Obviously I had to, so I was going from a full stop, oK

because I had the full stop when I when I left the Jovanna

and after I was accelerating the car so I so I passed.

Adv2: So you didn't slow when you were passing the traffic

lights?

Wit: 5:00 in the morning I'm doubted that someone will stop.

Adv2: Now, since you were accelerating your vehicle, do you

know the approximate speed you were driving?

Wit: Around 40 45 to 50, yes, yes kilometres per hour,

kilometres, kilometres. My car are in kilometres.

Adv2: Alright, now after the accident happened, you when you

came out of your, am I correct to state that there were a lot

of spillage in the road of oil, petrol and diesel?

Wit: No there were no fluids from what I saw when I came out.

There wasn't spillage.

Or no fluids? No, there was no fluids after when the police come and everything, obviously there was some spilling of

the liquids of my car I didn't went underneath to see

immediately so I could I can see.

Adv2: And it was your vehicle, right, who hit the other part

vehicles?

Wit: Yes, it was my vehicle.

Anthony Scicluna, testified as follows:

Court:

Wit: I swear. I am representing Café Jubilee.

Adv: Mr. Scicluna can you please can you please specify to the

court whether asserting Kenenth Mifsud with ID number

469687M was ever employed with the company?

Wit: Yes, he was.

Adv: Can you indicate the period when he was so employed?

Wit: 6 to 5 years ago over.

Adv: Is he still employed with ther company?

Wit: No.

Adv: When did he stop being so employed?

Wit: I have no idea but it was just before COVID maybe 2020.

Adv: Would you be able to produce the engagement form and

termination forms please?

Wit: No, I can't. He was not registered.

Court: Stop he is not giving evidence anymore, you have the right

not to give evidence because ypu can incriminate yourself.

Wit: I choose not to give evidence ok ok.

Dr Ingrid Zammit Young exhibited Dok IZY

Considerations of this court

There is insufficient evidence regarding whether the accused drove on from a traffic light when the light was red. Morover, there is no indication regarding that Dok P1 to P8, photos were confirmed on oath and by whom they were exhibited. Therefore, the degree of evidence is not beyond a reasobnable doubt as required in a criminal court.

Decide

For these reasons and after having seen 226(a) of Chapter 9 and 15(1)(a)(2)(3), of Chapter 65 of the Laws of Malta finds the accused Petru Dorin Nagoe is not guilty of the charges.
