Pros: Something happened over there I was about to finish my work.

Pros: Hold on date and time?

Wit: I was about to finish my work I just finish and park my van.

Court: And you parked where please?

Wit: Garage of Ecabs.

Court: Where did you park?

Wit: Garage of Ecabs St. Julians.

Court: Do you know the name of the road?

Wit: I'm not really know the exact street of.

Court: Ok you know the date?

Wit: Yes it was February 2, 2022.

Court: So what happened it was during the day during the evening?

Wit: In the evening.

Court: So it was dark?

Wit: Yes.

Court: Ok what happened?

Wit: I was about to finish my work going to submit the key the pouch and the money during my shift so I was crossing the road opposite from the garage opposite the office so while I was walking it was nothing I almost close to the edge of the pavement when suddenly I heard an acceleration of a car and hit me instantly.

Court: So you had already crossed the road?

Wit: Almost your honor when instantly it hit me in bumping it was too very fast.

Court: And the car so you were crossing the road and what direction did the car was coming?

Wit: It should come from the right side when I facing our office your honor it is on my right side.

Pros: Do you remember who was driving the car?

Wit: It was a lady.

Pros: Do you recognize her?

Wit: Yes yes during that time she was confronting me about the things that happen but I told her please call the ambulance please because I am bleeding because at that time so I am surviving my own self.

Pros: She was talking to you?

Wit: When I told her to call an ambulance she called and people are coming to get help at that time I don't know if I was going to die I have a 2 yr old son waiting for me at home and wife.

Pros: Do you remember which part of the vehicle she hit you?

Wit: I think it`s left side of the car the front.

Pros: With regards to your injuries?

Wit: I have procured of head from here to here.

Pros: How long you were far away from work?

Wit: I had only 8 hour.

Court: You went to work with these injuries?

Wit: No no.

Court: After the injuries when did you go back to work?

Wit: I think month of May.

Court: So took you months to go back to work?

Wit: Yes.

Court: From February to May?

Wit: Yes your honor.

Court: So over a month?

Wit: Yes over a month.

Court: Cross.

Adv: Do you have any evidence to submit regards to your injury?

Wit: Yes I have the certificates from the police and from the hospital and from the doctor.

Adv: And this particular part where the accident is being allured that happened is narrow so many steps do you need to take to cross from one part of the street to the other am I right in saying is narrow as a street?

Wit: It is not that narrow if you check.

Court: How many cars can 2 cars fix next to each other in it?

Wit: It is in different ways there is going down and the other one is going up in the center there is small pavement on the center.

Adv: A traffic island.

Court: So it is divided by a traffic island?

Wit: Yes your honor.

Adv: Could you see the car that you are allegedly hit you coming could you see it coming or the light of the car?

Wit: At that time when you are facing to the office there is no car during that time when I almost close to the edge of the

pavement there is I heard acceleration and that`s coming very fast I don`t know what to do.

Adv: And am I right in saying that you can cross this road very quickly and you were almost you said you were almost on the pavement?

Wit: Yes.

Adv: Ok and according to you where were you hit by the car?

Wit: You mentioned you had injuries in forehead did the car hit you in your forehead?

Wit: When I was hit by the car I fell down during that time I holding my a small bag inside the a small Thermos and it was not empty yet a little of water together with on the right hand so I think that one saved me also from the impact of the car.

Court: So the and it threw you on the floor?

Wit: When I was hit I was thrown to the floor.

Adv: I am suggesting that you lost your balance is that true?

Wit: No u didn`t loose my balance I was hit by the car.

Adv: Are there any crossing pedestrians nearby?

Wit: No no.
