The Court;

Having seen the application of JR

Respectfully submits;

That the parties married on the thirteenth of April of the year two thousand and fifteen [13.04.2015] at the Public Registry of Malta, as results from the attached copy of their marriage certificate, annexed and marked as **Doc. JR1**.

That from this marriage, the parties had no children.

That the parties have been legally separated from each other since January of the year two thousand and twenty-one [2021], by means of a contract in the acts of notary public Dr. Elena Farrugia LL.D, an authenticated copy of which contract is hereby attached and marked as **Doc. JR2**.

That there is no reasonable prospect for reconciliation between the parties, in view of the fact that apart from having been legally separated since January of the year 2021, they have since led completely separate lives, to the extent that the petitioner has even returned to live primarily in Serbia.

That there is no maintenance due between the parties, in view of a reciprocal renunciation resulting from the aforementioned contract in clause number five (5) thereof, and there are also no arrears due for maintenance of minors, since the parties had no children from this marriage.

That the petitioner is also submitting his own affidavit, annexed and marked as **Doc. JR3**, through which he confirms the facts stated herein.

Therefore, the petitioner respectfully requests that this Honorable Court:

- 1. **Pronounce** the dissolution of the marriage between the parties;
- Order the registrar of the Courts to, within the timeframe allowed by this Court, inform the Director of the Public Registry of the dissolution of the marriage of the parties so that it may be registered in the Public Registry.

Having seen the note of Dr Kirk Brincau noe – in the Maltese Language dated 18th June 2025;

Having seen that respondent had no objection to the granting of the divorce;

DECIDE:

Now, therefore, the Court;

Upholds the applicants' claim.

Declares the divorce of the marriage contracted between the parties on the 13th April 2015

Orders the Registrar of Courts to inform within ten (10) days the Director of the Public Registry to register the divorce in the Public Registry.

Without costs.
