

IN THE COURT OF MAGISTRATES (MALTA) AS A COURT OF CRIMINAL JUDICATURE

The Police

Vs

Santino Diego Sergio Stefano Boschetto

The Court Having seen that the accused:

Santino Diego Sergio Stefano Boschetto son of Alexander Petrovic and Alexandra nee' Boschetto born in Sweden on 26/01/1999 without a fixed address, Sweden identification document 722785;

And charge him with having on the 5th July 2025 at Dar Papa Frangisku, Birkirkara and/or in other parts of the Maltese Islands;

- 1. Without intent to kill or to put the life of Andre Carlos Spiteri in manifest jeopardy, shall cause slight harm to the body as certified by Dr. Aaron Okuns (Reg 8266) mentioned under (Art 214 in accordance of Art 221 of Chp 9 of the Laws of Malta)
- 2. In addition, Of, laying before the Executive Police an information regarding an offence knowing that such offence has not been committed, or shall falsely devise the traces of an offence in such a manner that criminal proceedings may be instituted for the ascertainment of such offence, mentioned under the (Chapter 9, Article 110 (2) of the Laws of Malta)
- 3. In addition, eads an idle and vagrant life (Art 338(W))
 The Court is requested, for the purpose of providing for the safety of Andre Carlos Spiteri or for the maintenance of public order or for the purpose of protecting the said person/s and his family from harassment or other conduct causing fear of violence, to issue a protection order against the accused in terms of Article 412C of Chapter 9 of the Laws of Malta, and in

the event of conviction, the Court is requested to provide for the safety of the injured

person/s and his family in terms of Articles 382A, 383, 384, 385, and 412D of Chapter 9 of the Laws of Malta.

This honourable Court is kindly requested that in case of guilt, sentence the accused to the payment, of the costs incurred in connection with the employment in the proceedings of any expert or referee.

Having seen that the charges were read under oath.

Havin seen that the second charge was withdrawn by the Prosecution.

Having seen the admission of guilt by the accused.

Having seen the examination of the accused.

Having seen articles 28A, 214, 221, 110(2), 338W, 382A, 383, 384, 385, 412C, 412D, of Chapter 9 of the Laws of Malta.

Having seen the acts and documentation of the case.

Considerations of this Court

The accused registered an admission of guilt at the very initial stages of these procedings and collaboratied with the Police.

Decide

For these reasons, and after having seen Articles 28A, 214, 221, 110(2), 338(w), 382A, 383, 384, 385, 412C, and 412D of Chapter 9 of the Laws of Malta, and noting that the 2nd charge was withdrawn and after having solemnly warned the accused of the consequences of the admission, collectively condemns the accused, Santino Diego Sergio Stefano Boschetto, to a term of two (2) years' imprisonment, suspended for a period of two (2) years in terms of Article 28A of Chapter 9 of the Laws of Malta, and the powers and consequences of said article have been duly explained. Furthermore, orders the issue of a Protection Order in terms of Article 412C of Chapter 9 of the Laws of Malta, which shall form an integral part of this judgment, for a duration of three (3) years against Santino Diego Sergio Stefano Boschetto, under the following conditions: that the accused is prohibited or restricted from approaching or following the movements of Andre Carlos Spiteri, that the accused is prohibited or restricted from accessing any premises wherein Andre Carlos Spiteri resides, works, or frequents, even if the accused has a legal interest therein and that the accused is prohibited from contacting or molesting Andre Carlos Spiteri in any manner, whether directly or indirectly. Should the accused, without lawful excuse, contravene any of the prohibitions or restrictions imposed upon him, he shall, upon conviction, be liable to a fine of seven thousand euros (€7,000), or to a term of imprisonment not exceeding two (2) years, or to both such fine and imprisonment.
