Il-Qorti,

Rat l-imputazzjonijiet miġjuba fil-konfront tal-imputat Richard Spiteri u ċioe` talli:

Fil-21 ta' Novembru, 2024 bejn il-hinijiet ta' l-14:45hrs u 15:30 hrs ġewwa 47, Triq il-Knisja, San Ġiljan:

Hebb għal Daniel Kuhlmann u kkaġunalu offiza ta' natura hafifa.

Rat id-dokumenti

Semgħet ix-xhieda;

Semgħet it-trattazzjoni tal-partijiet;

Ikkunsidrat,

Daniel Kuhlmann, il-parte leza, iddeskriva l-inkontru tiegħu mal-imputat:

"On the 21st of November, at 2.40, I moved to my new apartment. So I had to carry big boxes and a chair into my car. So I parked the car in the parking garage underneath my apartment block..... The address is Garden View, Apartment 4, (...) Court in St. Julians. Church Street. And, then I came down, after I grabbed my two boxes to my car and, there was waiting a guy behind his car, and he was very aggressive. Shouting at me that I had blocked his parking spot, underneath the garage, and therefore, he hit his own car, somewhere. I don't know. So he made me responsible for it, and he didn't stop and he came into me and tried to give me a head butt. But he stopped, just touching my head. And (...) provocation, that I didn't done anything. He kicked my leg, my thigh. And, so therefore, that is the situation. He attacked me..... I came down the elevator with my boxes and my chair. And I saw the guy and he told me that I am blocking his parking spot. I told him, sorry. I need to move my stuff into the car and I move the car away. So that you can park in. And he got more and more aggressive. I have video, I can show it. Aggressions."

Kuhlmann ma jippruvax iżżejjien il-verżjoni tiegħu u jixhed li l-brix fuq driegħu dawk ta' idejh seta garrabhom meta ħabat mal-ħajt peress li ma kienx hemm ħafna spazju bejn il-vettura u l-ħajt iżda kellu griegħi u tbengil fuq koxxtu:

"Difiza: Am I right to say as well, that my client tried to call you numerous times and was waiting for twenty minutes.

Xhud: No he didn't try. And it wasn't twenty minutes for sure.

Difiza: Am I right to say that the injuries that you suffered, you suffered them because you hit, you went into your car door. That is how you suffered the injuries.

Xhud: No.

Difiza: No. So you didnt hit your car door?

Xhud: No.

Qorti: You were going to say something. Give him chance to finish. He was about to say something whilst holding his left knee. Tell me.

Xhud: I was kicked in my left thigh. And the scratches on my arm.

Qorti: The scratches on you right elbow.

Xhud: Yes. They came from probably when I banged. Because he attacked me.

Qorti: When you moved back, yes.

Xhud: *I went back, yes, because that is the normal reaction if someone attacks you, you go back.*

L-imputat **Richard Spiteri** xehed li hu jikri garaxx fi blokka ta' xi hmistax il-garaxx u fil-jum l-incident sab karozza faċċata tal-garage tiegħu, hdejn il-bieb tal-lift, timblokkalu d-dhul fil-garage tiegħu. Prova jgħaddi bil-vettura tiegħu iżda spiċċa baraxx il-vettura tiegħu mal-ħajt. Jispjega:

“Xhud: Imbagħad ovojament, u domt nistenna. Mhux ħames minuti kif qal hu. Imma domt bejn kwarta u għoxrin minuta. Imbagħad, kif niżel hu, kif hareġ, ovojament jien kont mifqugħ, u offendejtu.

Qorti: Kont mifqugħ.

Xhud: Normali hux. Pero ma hebbejtx għalih. Mhux vera. U kif niżel, jien kont fil-karozza. U fetaħ waħda mill-bibien tiegħu, kif qal hu, kienet qiegħda mal-ħajt. U jien meta ħriġt mill-karozza u bdejt ngħajjat.

Difiża: Bħalma hemm f'dak il-vidjo li rajna.

Xhud: Aghar minn hekk, bdejt ngħajjat. U hu ħabat mal-bieba tal-karozza tiegħu stess. Kellu l-bieba miftuħa u ħabat mal-bieba tal-karozza tiegħu stess. Ma missejtux.”

Il-Qorti rat il-video *seduta stante* u fih jinstema il-parte leża jsaqsi lill-imputat *“Why did you hit me?”*. Madanakollu Spiteri jkompli jichad li hu għamel xi forma ta' kuntatt mal-parte leża u jgħid li jekk wegga dan sehħ għax ħabat mal-bieba tal-vettura tiegħu stess.

“Prosekutur: Hekk hu. Inti rajt il-vidjo u inti smajt li huwa qal, Why did you hit me?”

Xhud: Smajt iwa.

Prosekutur: U għalfejn qallek hekk taħseb?

Xhud: Biex jipproduci l-vidjo fil-Qorti, apposta.

Qorti: Mela la kont taf hekk, għaliex ma rrispondejtux, Where did I hit you?

Xhud: Għax dhalt fil-karozza Sinjura. Erga' dawwar.

Qorti: Iwa rajtek diehel jien. Għalhekk qed (...) Għax jekk jigi xi hadd jgħidli you hit me u ma nkunx I hit him. Imbagħad forsi nohroġ, I hit him!

Xhud: Ma ridtx nibqa' ntawwal l-affarijiet. Ridt naqbad u nipparkja halli hu jitlaq u neħles hux. Ħa noqgħod intawwal.”

Mistoqsi jekk ippruvax jagħmel kuntatt mal-parte leża li kien ħalla karta bin-numru tat-telefon fuq il-windscreen jgħid li prova jagħmel kuntatt billi ċempillu diversi drabi iżda ma kellux prova ta' dan. Iżid *"Fil-karozza kelli tifel rieqed ta' sentejn u nofs, u 'l ommu. Ħa mmur niġġieled ma' bniedem ikbar minni?"*.

Fuq dawn ir-riżultanzi proċesswali l-Qorti tqis li l-prosekuzzjoni ippruvat il-każ tagħha li l-parte leża soffra offiżi ħfief u ċioe *"Large bruise"*.

Decide

Għal dawn il-motivi, wara li rat l-artikolu 221(3) tal-Kodiċi Kriminali, issib l-imputat ħati tal-imputazzjoni miġjuba kontrih u tikkundannah għal ammenda ta' tmienja w ħamsin Euro (€58).

Ai termini tal-Artikolu 382A tal-Kodiċi Kriminali qed toħroġ Ordni ta' Trażżin kontra l-imputat favur Daniel Kuhlmann għall-perjodu ta' tlett (3) snin millum.
