Ra I-Avviz li fih l-atturi talbu l-hlas ta' Lm383.35c (tlett mijha u tlieta u tmenin lira Maltin u hamsa u tletin centezmu) bhala danni wara l-incident tat-traffiku msemmi fl-istess Avviz.

Ra r-Risposta fejn il-konvenuta qalet li ma kienetx responsabili ghall- incident.

Kopja Informali ta' Sentenza

Ikkunsidra li wara l-incident il-Pulizija li nvestiga l-incident kiteb il-versjonijiet tal-partijiet kif gej:

L-attrici qalet: "I was driving down from St Andrews Road and car number AAA 985 came from the left side of the road and the collision occurred. At that moment I was going to the direction of Spinola whilst the other vehicle was going to The Gardens".

Il-konvenuta qalet: "I was driving in the same direction slowed down to allow a vehicle to pass and as soon as I drove car number JBD 573 collided onto my vehicle. I was going to the direction of The Gardens".

Rachel Maurizio l-attrici qalet fix-xhieda tagħha:

"I was driving towards Spinola... I noticed the defendants car stationary on my left facing towards Paceville before the accident happened. Then all of a sudden I found her right in front of me."

Fix-xhieda tagħha l-konvenuta qalet : "I was driving from the direction of St Andrews and wanted to go to The Gardens. I saw that there were no cars coming from Regional Road. First I put on my indicator to indicate that I wanted to turn towards the left..... Then I put my right indicator. Then I started to drive towards the road which leads to The Gardens. I had still the right indicator indicating my intention to go in that direction. As I was moving towards where I wanted to go I slowed down because there were cars coming from the opposite direction. I slowed down waited till at least two or three cars passed by. Then I started driving and at that moment plaintiff crashed into my car...prior to the collision I did not see Rachel Maurizio's car....I was facing the entrance to The Gardens when the accident occurred.I had no damages at the back of my car".

Illi mix-xhieda, mill-iskizz u mir-rapport tal-Pulizija jirrizulta li l-konvenuta riedet taqsam il-lane tat-traffiku biex tkompli fid-direzzjoni tal-Gardens. Illi l-konvenuta għalhekk kellha l-obbligu li tara x'hemm warajha qabel ma tbiddel il-lane. Illi jirrizulta li l-konvenuta naqset li tagħmel hekk ma ratx li kien hemm il-karozza tal-attrici fuq il-lemin tagħha u

ghalhekk grat il-habta. Il-konvenuta kienet negligenti ghaliex naqset milli zzomm ‘a proper look out’ u naqset li tassikura li tista tbiddel id-direzzjoni tagħha mingħajr ostakolu għal traffiku iehor. It-Tribunal jagħmel referenza għas-sentenzi ‘Il-Pulizija Vs G. Sapiano deciza Qorti ta’ I-Appell Kriminali XXIX .iv. 558 u Il-Pulizija Vs J. Bartolo – Qorti ta’ I-Appell Kriminali Vo. XXXVII .iv. 868 – is-sinjal li wieħed jaġhti jridu jsiru fil-hin u fil-lok opportun biex ikollhom l-effett tagħhom... il-fatt li wieħed jixxgħel l-indicator ma jaġthih xi dritt li jaġħmel li jrid – qabel ma tbiddel id-direzzjoni għandek thares fil-mera sabiex tara hux gej traffiku minn warajk haga li l-konvenuta ma jirrizultax li għamlet.

Għaldaqstant il-konvenuta għandha tigi ddikjarata unikament responsabbi għall-incident in kwistjoni. Id-danni ma gewx kontestati u jidhru ragjonevoli.

Għaldaqstant jichad ir-Risposta tal-konvenuta, jilqa’ t-talba attrici bl-imħax legali mid-data tan-notifika tal-ittra ufficjali kontra l-konvenuta.
