Ir-rikorrent ippremetta li l-intimati kienu gew inibiti b'mandat mahrug fl-10 ta' Novembru, 1995.

Illi b'degriet moghti mill Prim Awla fid-9 ta' Mejju, 1997 il-gestjoni tal-lukanda San Julien ghaddiet f'idejn sekwestratarju gudizzjarju.

Illi recentement l-intimati, bi ksur ta' dawn l-ordnijiet, krew ir-Reef Bar li jifforma parti minn dina l-lukanda lil Stephen England.

Ghalhekk ir-rikorrenti talbu li n-vista tal-premess dina l-Qorti tordna li jittiehdu proceduri ta' disprezz fil-konfront ta' Resort Hotels Ltd u tad-diretturi taghha Philip O. Gatt u Mark Gatt.

Risposta

Fir-risposta tieghu **Philip Gatt** pro et noe (fol. 13) rrisponda li l-kumpanija Resort Hotels Ltd ghandha identita' legalment indipendenti mid-diretturi taghha ghalhekk dawn ghandhom jigi liberati mill-osservanza tal-gudizzju.

Fil-mertu t-talba tar-rikorrenti hija semplicement allegazzjoni nfondata, billi ebda wiehed mill-intimati ma dahal f'kuntratt lokatizju referut mir-rikorrenti, u di piu' in vjolazzjoni tad-degriet moghti mill-Qorti. Se mai r-rikorrenti ghandhom jesebixxu kwalsiasi dokument li jista b'xi mod jaghti hjiel li sar dak allegat.

Mark Gatt (fol. 15) irrisponda li hu personalment mhux responsabbili ghal xi allegat disprezz.

PROVI

Stephen England fl-affidavit tieghu stqarr li:

In March 1998 I signed an operations agreement with Resort Hotels Ltd. The company was represented by Mark Gatt who is the son of Philip Gatt. In terms of this agreement I am operating the Reef Bar at the San Julian Hotel, Dragonara Road, St Julians. On signing the agreement I paid the sum of LM20,000 as consideration, to Resort Hotels Ltd. I am also paying a daily sum of LM 45 as daily rent to Resort Hotels Ltd. The contract is for a period of five years... At the time I signed the agreement I was not aware that there was a court order which provided for the running of the San Julian Hotel by a court appointed official and that the company was prohibited from leasing or entering into agreements with respect to the hotel. I also state that neither Philip Gatt nor Mark Gatt ever mentioned anything in this respect.. I also know that there is a restaurant at the San Julian Hotel which is being run at the moment by a Maltese chap. Previously an Italian national was operating the restaurant.

Dwar is-sottomissjoni tal-intimati li personalment m'humiex responsabbili ghal allegat disprezz, il-Qorti tirrileva li l-indoli tal-procedura prezenti hija wahda tali li tirrikjedi li l-persuni responsabbili jkunu mharrkin personalment ankorke' relativament ghal agir jew operat maghmul taht l-isem tas-socjeta' li taghha huma diretturi (ara f'dan is-sens is-sentenza App Demanuele vs Azzopardi et dec 27.6.97).

Ghalhekk hemm lok ghas-segwentu provvediment.
