**Isa' Ture'**

The Court;

Having seen the charges brought against Ise Ture' aged 19, a national of Ivory Coast, son of Amedi and Meymuma, born in Gram Bissam on the 3<sup>rd</sup> August, 1988, with identity documents and known by Immigration Identification No. 05U-021;

With having at Ta' Kandja on the 11<sup>th</sup> July, 2006 at about 12:00 noon with intent to commit a crime, manifested such

intent with overt acts which were followed by the commencement of the execution of such crime, that is a to escape from any place of confinement or of punishment, when such escape was effected by violence on the person or with breach of such place, when he was a person lawfully confined and such an escape was from a place appointed for his custody;

With having on the same date, time, place and circumstances caused injuries of slight nature on PS 297 Judas Taddeo Baldacchino, a person lawfully charged with a public duty, while in the act of discharging his duty, or with the act to intimidate or unduly influence him in the discharge of such duty as certified bly Dr. Ronnie Farrugia M.D. of St. Luke's Hospital;

With having on the 11<sup>th</sup> July, 2006at about 1:00pm at the Qormi Health Centre caused injuries of slight nature to PC 83 Emanuel Sciberras a person lawfully charged with a public duty, while in the act of discharging his duty, or with the act to intimidate or unduly influence him in the discharge of such duty as certified bly Dr. Ronnie Farrugia M.D. of St. Luke's Hospital;

With having on the same date, time, place and circumstances with intent to commit a crime, manifested such intent with overt acts which were followed by the commencement of the execution of such crime, that is being a person under sentence by attempting to escape, when was a person lawfully confined;

Having seen the transmission of the attorney general of the 12 of March 2007 for the accused to be tried by this court for breach of articles of 41(1), 151, 152, 95(1), 214, 221(1) and (c), 533 of Chapter 9 of the Laws of Malta and having seen the no objection of he accused for this case to be tried summarily in terms of art 370(3) Chapter 9 of the Laws of Malta;

Having heard the evidence and having heard the plea of guilt of the accused;

Informal Copy of Judgement

Having seen all the records of the case, finds the accused guilty as charged;

Having seen articles 41(1), 151, 152, 95(1), 214, 221(1) and (c) of Chapter 9 of the Laws of Malta;

Condemns the accused to a term of imprisonment of nine months (9) from today. The amount of time served by the accused in preventive custody shall be subtracted from this period of nine months.
