## The Court;

After seeing the charges brought against:

Ahmed Dahir Abdulkadir sive Abdi Qaadir Ahmed of 25 years, son of Ahmed and Anaub, born in Somalia on the 27<sup>th</sup> October 1986, residing no fixed address in Malta (last known address 'Dar il- Qawsalla', Valley Road, B'Kara, of unknown passport No. unknown, bearing ID 0052016(A);

Informal Copy of Judgement

For Having on the 29<sup>th</sup> August 2009 in 'Dar il- Qawsalla', Valley Road, B'Kara, and in other places on these Islands;

1) assaulted member of the security, Alexandra Moran (of JF Company) with a knife and for Public Officer in her capacity as Care worker Gertrude Catania with a sharp pointed object (knife) ai termini of Article 95, 96 (a) 338 (ee) of Chapter 9 of the Law of Malta;

2) for having a knife without a license from the Commissioner of Police;

3) in his course of conduct causes another to fear that violence will be used against him or his property or against the person or property of any of his ascendants Amina, Descendants, brothers or sisters or any person;

4) in his course of conduct is in question ought to know that it will cause another person Amina to fear that violence will be used against him on any occasion if a reasonable person in possession of the same information would think the course of conduct would cause the other so to fear on that occasion;

5) voluntarily disturbing public order and Peace;

Considers:

After having seen the Articles 95, 96 (a), 338(ee), 251A, 251B, 338(dd) of Chapter 9 of the Laws of Malta; And Articles 5, 6, and 7 of Chapter 480 of the Laws of Malta;

After having heard the evidence and the documents exhibited;

After having seen the accused admit the charges brought against him, which admission was confirmed by him after having been given due time to reconsider in accordance with the law; Informal Copy of Judgement

After having heard the victim declare in Court that she is forgiving the accused for the aggression committed on her;

After having heard the accused's plea and after having given the time prescribed by Law for the accused to consider his plea, this Court finds the said accused guilty as charged and condemns him eight (8) months imprisonment suspended for one (1) year in accordance of the Article 28A of Chapter 9 of the Law of Malta.

The Court explained in clear words the terms of the judgement to the accused.
