#### The Court;

After seeing the charges brought against:

Mohammed Sangare of 29 years, Nationality Ivory Coast, son of Abdalla and Jumacruma, born at Abgan on the 10<sup>th</sup> November 1980, residing at Hal Far Open Centre, Police Boat number 07N-001

And

Suleman Baddie 26 years of age, Nationality Gambia, son of Saitou and Fatmha, born at Banjun on the 24<sup>th</sup> of November 1983, residing at Hal Far Open Centre, Police Boat number 08ll-021

#### And

Ibrahim Mumuni 22 years of age, Nationality Niger son of Mumuni and Fatha, born at Niger, residing at Hal Far Open Centre, Police Boat number 07EEE.059;

### For Having:

- 1) on the 25<sup>th</sup> October 2009 and/ or the previous days in Malta, forged altered or tempered with a passport/s or used or had in their possession a passport/s which they knew to be forged, altered or tempered with three (3) Italian Passports, three (3) identity card (travelling documents) and three (3) Italian Residence Permits. Chap. 61 Sec. 5.
- 2) Also charge them with having on the same date and circumstances while in Malta, knowingly made use of a forged documents being the above mentioned passports/ identity cards and residence permits. Chap 61 Sec.5:
- 3) Also charge them with having on the same date and circumstances and/ or the previous days in Malta, made used of a false return, false statement or false representation and/ or furnished the principal immigration officer with false information. Chap 217 Sec. 32 (1c);
- 4) Mohamed Sungare alone was found and declared a Recidivist after being found guilty of another similar offence and charged accordingly by the Magistrate Court (Malta) Dr.A. Mizzi LL.D on the 1<sup>st</sup> of April 2009 and Chapter 9 sec 49, 50, 289.

#### Considers:

After having seen Article 5 of Chapter 61 of the Laws of Malta:

Article 32(1c) of Chapter 217 of the Laws of Malta; And Articles 49, 50, 289 of Chapter 9 of the Laws of Malta:

After having seen the accused admit the charges brought against them, which admission was confirmed by them after having been given due time to reconsider in accordance with the law;

After having heard the evidence and the documents exhibited;

After having heard the accused's plea and after having given the time prescribed by Law for the accused to consider their plea;

This Court finds the said accused guilty as charged and condemns Mohamed Sungare nine (9) months imprisonment and Suleman Baddie and Ibrahim Mumuni six (6) months imprisonment.

The Court explained in clear words the terms of the judgement to the accused.
