Having seen the charges brought against accused in that:

On December 2009 and the months after, while in Malta, landed or embarked from Malta without being in possession of a passport and without having furnished to the Principal Immigration Officer the prescribed information and such other information as the Principal Immigration Officer may have deemed proper to require, and this in violation of article 28 of Chapter 217 of the Laws of Malta.

Samoussou Abubaker alone has been charged for having

On the 4th May 2010 and the months previous, charged with having been in possession of a passport issued to another person and also received a passport transferred to him by any other person and this in violation of Article 3 of Chapter 61 of the laws of Malta.

Having seen the documents exhibited;

Having seen the guilty plea filed by accused Agu Collins and Samoussou Aboubaker which guilt pleas was reaffirmed after the Court gave them adequate time to reconsider same;

Considers;

That in view of the guilty plea filed by accused Agu Collins and Samoussou Aboubaker the Court finds them guilty as charged.

Kopja Informali ta' Sentenza

That in considering the punishment to be inflicted the Court is taking into consideration the guilty plea filed by accused Agu Collins and Samoussou Aboubaker at this early stage of the proceedings and their cooperation with the police.

Consequently the Court with regard to the accused to Samoussou Abubaker after having seen Section 28 of Chapter 217 of the Laws of Malta with regards to accused Agu Collins and Section 3 of Chapter 61 of the Laws of Malta find both accused guilty as charged and in view of the above made considerations and after having seen Section 22 of Chapter 446 of the Laws of Malta discharges both accused on condition that they do not commit another crime within one (1) year from today.

The Court warns both persons found guilty of the consequences according to law should they commit another crime within this period of conditional discharge.

The Court orders that a copy of the sentence together with the acts be forwarded to the Attorney General according to law.
