The Police (Inspector Jason Agius) vs Kenneth David Clements

The Court;

Having seen the charges brought forward against **Kenneth David Clements**, 35 years of age, son of Patrick and Dorren *nee*' Sayer born in Colchester UK on the 7<sup>th</sup> November 1975, residing in Room 282 Riu Seabank Hotel Triq il-Marfa Mellieha and holder of British passport no. 457607116;

With having on the 2<sup>nd</sup> August 2010 at about 21:30hrs whilst at the Malta International Airport Gudja volantarily caused an injury of a grievous nature on the person of Ciro Troncone as certified by Dr. Martin Mallia M.D. in

breach of articles 214 and 216 of Chapter 9 of the Laws of Malta;

On the same date and circumstances wilfully disturbed the public good order and the ublic peace by cries and fighting in breach of article 338 (dd) of the Laws of Malta;

On the same date and circumstances atached or used force agianst the person of Ciro Troncone with intent to insult, annoy or to cause him an injury in breach of article 339 (1) (d) of Chapter 9 of the Laws of Malta.

On the same date and circumstances by words insulted or threatened Ciro Troncone in breach of article 339 (1) (e) of Chapter 9 of the Laws of Malta;

The Court is kindly requested to provide for the security of Ciro Troncone and bound by a guarantee by Kenneth David Clements not to molest Ciro Troncone under the provision of article 383 (1) of Chapter 9 of the Laws of Malta;

Having seen the consent of the attorney general and the obligation of the accused for he case to be tried summarily;

Having heard the plea of guilt, find the accused guilty as charged;

Having senn articles 214 and 216(1) (b), 338 (dd) and 339 (1) (d) of the Laws of Malta;

Having seen the clear conduct sheet of the accused;

Condemns the accused to aterm of imprisonment of one (1) year from today, which term shall not elapse unless the accused commits any other offence punishable with imprisonment within a period of two years from today in terms of Article 28A of Chapter 9; Kopja Informali ta' Sentenza

Binds the accused with a guarantee of €240 fro a term of one (1) yearfrom today whereby the accused shall not molest in any manner Ciro Troncone according to article 383 of Chapter 9;

The Court explained to the accused his obligations arising from this judgement
