The Court;

Having seen the charges brought against **Jordan Leli Brown** son of Emmanuel Camilleri and Karen nee' Brown, born in England on the 22<sup>nd</sup> of November, 1992, residing at number 7, Fontana Flats, Triq San Gorg, Safi and holder of passport number 307973017;

1. Accused that on the night between the 21<sup>st</sup> and 22<sup>nd</sup> August, 2010 at Qrendi rendered himself as an accomplice on a crime by commanding others to commit the crime or instigated the commission of the crime by

means of bribes, promises, threats, machinations, or culpable devices, or by abuse of authority or power, or gave instructions for the commission of the crime or procured the weapons, instruments or other means used in the commission of the crime, knowing that they are to be so used or in any way whatsoever knowingly aids or abets the perpetrator or perpetrators of the crime in the acts by means of which the crime is prepared or completed or incited or strengthened the determination of others to commit the crime, or promises to give assistance aid or reward after the fact.

2. And on the same date, time and place committed theft of firearms (4 shotguns), jewellery items and cash money amongst other objects to the detriment of family Busuttill which theft is qualified by value exceeding €2329.37 and by means, place and time.

3. During the month of August, 2010 at Qrendi and other places in Malta conspired with one or more persons in Malta or outside Malta for the purpose of committing any crime in Malta liable to the punishment of imprisonment;

4. During the month of August, 2010 and the following months in Malta, knowingly received or purchased any property which has been stolen, misapplied or obtained by means of any offence, whether committed in Malta or abroad, or knowingly took part, in any manner whatsoever, in the sale or disposal of the same.

Having heard the plea of guilt registered by the accused in the first sitting of the 3<sup>rd</sup> November 2010;

Having seen all the documents of the case;

Finds the accused guilty on all charges except the charge relating to receiving stolen property since this is an alternative charge and abstains from taking further cogniscance of this charge;

Informal Copy of Judgement

Having seen articles 42 (a), 261 (b) (e) (f), 263, 269, 270, 278(3), 48A of Chapter 9 of the Laws of Malta;

Having seen the clean conduct sheet of the accused;

Commits the accused to a probation order under the supervision of a probation officer for a period of three (3) years from in terms of section 7 of Chapter 446 of the Laws of Malta;

The Court explained to the accused his obligations arising out of this judgement;

Since the prosecution did not have the consent of the attorney general for this case to be tried summarily by this Court as a Court of Criminal Judicature, the Court orders that these acts be transmitted to the attorney general in the time stipulated by law. Orders that a copy of this judgement be transmitted also to the Director Probation Services.
