Illi l-kunsens tal-konvenuta kien ivvizzjat ukoll minhabba l-eskluzjoni pozittiva taz-zwieg innifsu jew ta' wiehed jew aktar mill-elementi essenzjali tal-hajja mizzewga, u tad-dritt ghall-att taz-zwieg u dan ai termini tal-artikolu 19 [1f] tal-Kap. 255 tal-Ligijiet ta' Malta;

Illi l-konvenut irrifjuta li jikkonsma z-zwieg u dan ai termini tal-artikolu 19 A [1] tal-Kap. 255.

Illi minhabba r-ragunijiet premissi, iz-zwieg bejn il-kontendenti huwa null u bla effett fil-ligi.

I J, l-unika persuna verament midhla tal-attrici tixhed hekk dwar is-sitwazzjoni:

“I remember that on the wedding day we went out to lunch after the ceremony in St. Julians and after the lunch I thought that she was leaving with him, though to my surprise, everything changed at the last minute and A came back home with me. She never ever left home and remained living with me all the time. He never ever slept here and A slept here daily. I do not know anything about their sex life though she says that she never ever had sex with him and that her marriage was never consummated”.

L-attrici nnifisha tghid hekk:

“By time after, about six months, he spoke of marriage and I thought that this would bring an end to my worries about my stay here in Malta so I obliged. He said that I would live in his place in Valletta so in fact I also changed my Identity Card to this address so that everything would be according to law. He, however, never ever took me to see this place and in fact till today I have never seen it. He used to live with his sister in Gzira and even there he never took me. I am just repeating what he used to tell me. I remained living with I J all throughout my stay here in Malta.

Well the day arrived when we got married at the Public Registry on the 19th December 2003. I must admit, however, that there was no marriage at all because immediately he changed his mind and in fact, after the marriage ceremony we went to lunch to celebrate in a restaurant in St. George's Road, St. Julians. With us there was my witness G H who was the nanny of the child of I J and I J. Today, G is today living in the UK and has taken up the residence there. After the lunch, Frank decided that I should go back with I until the place in Valletta was ready and that he would come to see me regularly. I immediately thought there was something wrong but I

wanted to give it all a chance. He made no effort at all and in fact hardly ever came to see me. I remained working just like before and my only consolation was my daily discussions with I J. I J is the managing Director of the company that employed me. She too is single and thus we became friends.

Frank never provided a home for me and thus we always lived seperately, we never had any sex. We just had a very platonic relationship. Our marriage was never consummated”.
