

COURT OF MAGISTRATES (MALTA) AS A COURT OF CRIMINAL JUDICATURE

Mohamed Abdullahi Abdulnasir

The Court:

Having seen the charges brought against **Mohamed Abdullahi Abdulnasir** 20 years of age, of Somalian nationality son of Mohamed and Milky nee' Ahmed born in Somalia, on the 1st January 1990, and residing in Hangar Open Centre, Hal Far, Limits of Zurrieq. Holder of Maltese ID Card No **60277A**

Having with several acts committed, even at different times constitute violation of the same provision of the law, and are committed in pursuance of the same design during the months of January 2011 and February 2011,

- a) on the 29th January, 2011 at Hamrun between 16:30Hrs and 20:30Hrs committed theft from vehicle bearing registration number LCL 695, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owners, by time and by the nature of things stolen and this in accordance to Art 18, 261(c),(f),(g), 267, 270, 271(g) and 279(a) of Chapter 9 of the Laws of Malta;
- b) on the same date, time, place and circumstances wilfully commit any spoil, damage or injury to or upon any movable or immovable property belonging to any other person that is on vehicle bearing registration number LCL-695 to the detriment of its owner which amount of the damage exceed one hundred and sixteen euro and forty-seven cents (€116.47) but do not exceed one thousand and one hundred and sixty four Euro and sixty-nine cents (€1164.69) and this in accordance of Art 325(b) of Chapter 9 of the Laws of Malta.
- c) on the 2nd February 2011, at Hamrun committed theft from vehicle bearing registration number HBG 495, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owners, by time and by the nature of things stolen and this in accordance to Art 18, 261(c),(f),(g), 267, 270, 271(g) and 279(a) of Chapter 9 of the Laws of Malta;
- d) between the 10th February 2011 and 11th February 2011 at Marsa committed theft from vehicle bearing registration number GAM 524, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owners, by time and

by the nature of things stolen and this in accordance to Art 18, 261(c),(f),(g), 267, 270, 271(g) and 279(a) of Chapter 9 of the Laws of Malta;

- e) on the 14th February 2011 at Valletta committed simple theft not exceeding than two hundred and thirty-two Euros and ninety-four cents (€232.94) from a retail outlet styled Tommy Hilfiger and this in accordance to Art 284 of Chapter 9of the Laws of Malta;
- f) on the 15th February 2011, at Marsa committed theft from vehicle bearing registration number JBB997, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owners, by time and by the nature of things stolen and this in accordance to Art 18, 261(c),(f),(g), 267, 270, 271(g) and 279(a) of Chapter 9 of the Laws of Malta;
- g) during the month of January 2011 at Hangar Open Centre, Hal Far, Limits of Zurrieq committed theft of a digital camera, various clothing and the sum of 310€, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owner, and time and this in accordance to Art 18, 261(c), 267, 270, 279(a) of Chapter 9 of the Laws of Malta
- h) during the months of January 2011 and February 2011 at Marsa Open Centre, committed theft of two laptops, which theft is aggravated by amount not exceeding two thousand and twenty-nine Euros and thirty-seven cents (€2329.37) but more than two hundred and thirty-two Euros and ninety-four cents (€232.94) to the detriment of same owner, and time and this in accordance to Art 18, 261(c), 267, 270, 279(a) of Chapter 9 of the Laws of Malta
- i) during the months of January 2011 and February
 2011 from Valletta committed several simple thefts not

exceeding than two hundred and thirty-two Euros and ninety-four cents (€232.94) from different unknown retail outlet to the detriment of same owners and this in accordance to Art 284 of Chapter 9of the Laws of Malta

- j) on the 15th February 2011 at Marsa willfully commit any spoil, damage or injury to or upon any movable or immovable property belonging to any other person that is on vehicle bearing registration number FBX 109 to the detriment of its owner which amount of the damage exceed one hundred and sixteen euro and forty-seven cents (€116.47) but do not exceed one thousand and one hundred and sixty four Euro and sixty-nine cents (€1164.69) and this in accordance of Art 325(b) of Chapter 9 of the Laws of Malta.
- k) in these Islands between the months of January 2011 and February 2011 knowingly received or purchased any property which has been stolen, misapplied or obtained by means of any offence, whether committed in Malta or abroad, or shall knowingly take part, in any manner whatsoever, in the sale or disposal of the same, and this in terms of section 334 of Chapter 9 of the Laws of Malta.

Having seen the consent of the attorney general for this case to be tried with summary proceedings and having seen the no objection of the accused for the case to proceed with the same procedure;

Having heard the plea of guilt of the accused;

Having seen the records of the case;

Finds the accused guilty as charged.

Having seen the clean conduct sheet of the accused;

Having seen articles 18, 261(c), (f), (g), 267, 270, 271(g), 279, 280, 284, 325(b) and 334 of Chapter 9 of the Laws of Malta;
