Lucas Gozdikrewicz

The Court,

Having seen that the accused Lucas Gozdikrewicz, holder of Polish Passport No AS2022110;

Was charged with having on the night between the 8th and 9th February 2011, sometime between 00.00 hrs and 04.00 hrs in Qawra, St. Paul's Bay, Malta:
Reviled of threatened or caused bodily harm to persons

Reviled of threatened or caused bodily harm to persons that is PS935 and PC1280, lawfully charged with a public duty while in the act of discharging their duty or because of their having discharged such duty with the intent to

intimidate or unduly influence them in the discharge of duty (Ch 9 of the Laws of Malta, Article 95);

Also on the same place, date, time and circumstances assaulted or resisted by violence or active force not amounting to public violence that is PS935 and PC1280 lawfully charged with a public duty when in the execution of the law or of a lawfully order issued by a competent authority (Ch 9 of the Laws of Malta, Article 96);

And also on the same place, date, time and circumstances uttered obscene or indecent words in public (Ch 9 of the Laws of Malta, Article 338 (bb) and 342);

also on the same place, date. time and circumstances disobeyed the lawful orders of authority or of any person that is PS935 and PC1280 entrusted with a public service, or hindered or obstructed such persons in the exercise of their duties, or otherwise unduly interfered with the exercise of such duties, either by preventing other persons from doing what they are lawfully enjoined or allowed to do, or frustrating or undoing what has been lawfully done by other persons, or in any other manner whatsoever (Ch 9 of the Laws of Malta, Article 338(ee)):

And also on the same place, date, time and circumstances caused slight injuries on the person of PC1280 which injuries were certified by Dr Ramon Scerri MD Reg No 1986 at the Mosta Health Centre (Ch 9 of the Laws of Malta, Article 221); and

Also on the same place, date, time and circumstances willfully disturbed the public good order or the public peace and order (Ch 9 of the Laws of Malta, Article 338(dd)).

After seeing charges;

After seeing evidence;

After seeing Articles 95, 96, 338(bb), 342, 338(ee), 221 and 338(dd) of Chapter 9 of the Laws of Malta; and

After hearing examination of the accused whereby he pleaded guilty to all the charges brought against him, and the confirmation by the accused of such plea when given the appropriate time to reconsider his position, finds accused Lucas Gozdikrewicz guilty of all the charges brought against and by virtue of Article 22 of Chapter 446 of the Laws Malta frees him with the condition that he does not commit another offence within two (2) years from today.

Finally explained in simple words the repercussions if this order is not complied with.
