POLICE INSPECTOR LOUISE CALLEJA VS PETER LESLIE HAIR

The Court,

Having seen the charges brought against the accused Peter Leslie Hair, son of late Peter Wisart and later Barbara Ann nee' Cairns, born Errol Pertshire, Scotland on the 1st of July 1948, residing at Heather, St.Thomas Street, Fgura and holder of Maltese Identification Card bearing the number 50798(M).

Charged with having on the 21st of January 2010 and in the preceding months, on these Islands, as a citizen or

permanent resident of Malta, whether inMalta or outside Malta, acquired or were in possession of an indecent photograph, film, video recording or electronic image of a minor and that some of these indecent photographs, films, video recording or electronic images show minors who have has not completed the age of nine years and this in breach of Article 208A (1B) and (1C) and 208A (3) of Chapter 9 of the Laws of Malta.

Having heard the evidence tendered on oath;

Having heard the guilty plea registered by the accused;

Having heard the confirmation of the said guilty plea by the accused after the Court accorded the accused a reasonable time for reconsideration;

Having heard the oral submissions of the parties;

Deliberates:

On the strength of his own guilty plea, the Court finds the accused **Peter Leslie Hair**, guilty as charged, and after having seen Article 208A (1)(b), (1)(c), (3), 28A and 28G of Chapter 9 of the Laws of Malta, Article 7(5) of Chapter 446 of the Laws of Malta, **condemns the accused to a period of twelve (12) months imprisonment suspended for a period of two (2) years.**

In addition, the Court is issuing a **Supervision Suspended Order against the accused, for a period of eighteen (18) months**, under the supervision of the Director of Probation Services or any other Probation Officer so nominated.

Furthermore the Court is issueing a Treatement Order against the accused, for the duration of two eighteen (18)

months, under the medical care of Psychologist Roberta Holland who shall be responsible for the Treatement Plan which best suits the requirements of the accused, such that however there shall be, at least, one (1) therapeutic session per month for the proscribed period above mentioned.

Furthermore, the Court orders the confiscation and the destruction of the illegal pornographic material found in the possession of the accused and which has been seized in these proceedings.

The Court orders that a copy of this judgement be notified to Director of Probation Services and Psychologist Roberta Holland.
