

COURT OF MAGISTRATES (MALTA) AS A COURT OF CRIMINAL JUDICATURE

The Police (Inspector Nikolai Sant) vs Ingrid Kalviste

The Court;

Having seen the accused Ingrid Kalviste of 25 years of age, born in Estonia on the 28th July 1986 daughter of Sulev and Maret nee' Intz with no fixed address and holder of Estonian Passport numbered K3142358 was arraigned before it and charged with having:

Between the 15th of August 2011 and the 16th of August 2011 between 23.30 hrs (of the 15/08/2011) and 4.15hrs (of the 16/08/2011) on these islands:-

1. Volontarily caused slight injuries on the person of PC 80 Stephen Mercieca, as certified by Dr. Bjorn Buhagiar M.D of the Floriana Health Centre,

- 2. Caused voluntarily damages on Police Van bearing registration number GVP544 and in a cell at the Police General Headquarters in Floriana, damages which do not exceed one thousand one hundred Euros and sixty four euros and sixty nine cents (1,64.69)
- 3. Accused her further with having on the same date, time, place and circumstances assorted or resisted by violence or active force not amounting to public violence, PS1335 Duncan Schembri, PC80 Stephen Mercieca, Pc502 Clifford Frendo, PC600 David Mizzi, WPC 185 Vanessa Mula Debono and WPC311 Stephanie Saliba lawfully charged with a public duty when in the execution of the law or of a lawfully order issued by a competent authority.
- 4. On the same date, time, place and circumstances reviled, threatened or caused bodily harm to PS1335 Duncan Schembri, PC80 Stephen Mercieca, Pc502 Clifford Frendo, PC600 David Mizzi, WPC 185 Vanessa Mula Debono and WPC311 Stephanie Saliba, a person lawfully charged with a public duty, while in the act of discharging their duty or because of their having discharged such duty, or with intent to intimidate or unduly influence them in the discharge of such duty.
- 5. On the same date, time, place and same circumstances did not obey the lawful police orders given by the above mentioned officers;
- 6. On the same date, time, place and same circumstances breach the public peace and order;
- 7. On the same date, time, place and same circumstances loitered in a public place whilst holding in her hands or on herself a glass container.

The court may, in case of guilt, where it deems it expedient, in order to provide for the safety of the above mentioned officers, and for the keeping of the public peace to apply Article 383 of Chapter 9 of the laws of Malta.

Having seen all the acts of the proceedings including the Attorney General's consent dated 24th of August 2011(exhibited a. folio 19 of the proceedings) for this case to be treated summarily.

Having heard the accused declare that he has no objection that this case is heard summarily.

Having heard the accused plead guilty to the charges brought against her, notwithstanding the fact that the Court warned her of the consequences of her guilty plea and after having afforded her sufficient time within which to withdraw her guilty plea.

Having heard the guilty plea of the accused to the charges brought against her the Court has no alternative but to declare the accused guilty of all the charges brought against her.

The Court after having seen sections 221(1), 325(1)(b), 96(a), 95(1), 338(ee), 338(dd) and 17 of Chapter 9 of the Laws of Malta as well as Article 7 of Chapter 63 of the Laws of Malta, finds the accused guilty of all the charges brought against her and condemns her eighteen(18) months imprisonment which in terms of Section 28A of Chapter 9 of the Laws of Malta are being suspended for a period of three(3) years from today.

In terms of Section 28H of the Criminal Code, the Court orders the accused to pay the sum of two hundred sixty euros (€260) to the Commissioner of Police which amount has to be paid within two(2) weeks from today.
