Bl-azzjoni odjerna s-socjeta' attrici titlob li l-konvenut f'ismu proprio u ghan-nom u in rappresentanza tas-socjeta' Allegro Andante Limited jigi ikkundannat ihallasha s-somma ta' €2,780.99, rapprezentanti bilanc minn somma akbar mislufa bis-sahha ta' ftehim datat 16 ta' Marzu 2005, anness mar-Rikors promotur bhala Dok. « A ».

Mill-imsemmi ftehim datat 16 ta' Marzu 2005 jirrizulta li : (i) is-socjeta' Allegro Andante Limited, kif hemm rapprezentata mill-konvenut, obligat ruhha *to purchase from the Company (ossia s-socjeta' attrici) or its subsidiaries or associated Companies, the products sold or distributed by the Company specified in the Schedule annexed hereto and marked Schedule « A », hereinafter referred to as the « Products », for resale in the Establishment ... to purchase from the Company for resale in the Establishment a minimum of Nine Thousand One Hundred and Eighty Malta Liri (Lm9,180) worth of products per annum ... to promote the Products through the prominent display thereof ;* (ii) is-socjeta' attrici *in consideration of the undertakings provided by the Operators under Clause 1 above, ... grants on loan to the Operators the sum of Four Thousand Seven Hundred and Fifty Malta Liri (Lm4,750) (hereinafter referred to as « The Loan ») to be repaid in accordance with Clause 4 hereof...* ; (iii) il-ftehim kellu validità ta' tlett snin b'effett
