Today, the 13th of February 2012

The Court,

Having seen that the accused Darren Ryan Michael Storey, holder of passport number 454516403:

Was charged with:

1. with several acts committed even if at different times and constitute same violations or provisions of the law, and which were committed in pursuance of the same

design committed on the 12th February between 3:00a.m. and 4:00a.m. in several streets in Birzebbuga, willfully committed any spoil, damage, or injury to or upon any movable or immovable property belonging to various persons, that is, damage to a number of parked vehicles, a wooden front door and a statue, which damage globally exceeds one thousand and one hundred and sixty-four Euros and sixty one cents (€1,164.69);

2. Also for having on the same date, time, place and circumstances disobeyed the lawful orders of any authority or of any person entrusted with a public service, or hindered or obstructed such person in the exercise of his duties, or otherwise unduly interfered with the exercise of such duties, either by preventing other persons from doing what they are lawfully enjoined or allowed to do, or frustrating or undoing what has been lawfully done by other persons, or in any other manner whatsoever;

3. also for having on the same date, time, place and circumstances willfully disturbed the public good order or the public peace.

4. also for having on the same date, time, place and circumstances disturbed the repose of the inhabitants by rowdiness or bawling, or in any other manner;

5. also for having on the same date, time, place and circumstances even though in a state of intoxication, publicly uttered any obscene or indecent words, or made obscene acts or gestures;

6. also for having on the same date, time, place and circumstances in any public place or place open to the public, was found drunk and incapable of taking care of himself.

Having seen all presented documents, including the consent of The Attorney Generali so that proceedings be dealt with summarily;

Informal Copy of Judgement

Seen examination of accused whereby he pleaded guilty to all charges brought against him, and the confirmation of such plea after given the faculty to reconsider his position;

After seeing Articles 325(a), 338(ee), (ff), (dd), (bb) and (m) of Chapter 9; and

Having seen that the amount of damages amounts to two thousand and five hundred and fifty Euro (€2,450) from which the amount of one thousand (€1,000) has already been paid.

Therefore finds the accused Darren Ryan Michael Storey guilty of all the charges brought against him and by virtue to Article 22 of Chapter 446 frees the accused on condition that he does not commit another offence within three (3) years and condemns him to pay the remaining one thousand four hundred and fifty Euro (€1,450) within six (6) months to be directly credited into the account of Francis Barbara 4001698062 BOV.

Finally, explained in simple words the repercussions if said order is not abided with.
