Rostas Mircea -Remus Anghel Zabar

The Court;

Having seen the charges brought against:

**Rostas Mircea-Remus**, 37 years of age, son of Radu and Stella *nee*' Notar, born in Romania on the 31<sup>st</sup> May, 1974 and residing at 'Kosi Farm', Count Salvatore Manduca Street, Mtarfa and holder of Maltese identity card number 63694A;

**Anghel Zabar**, 30 years of age, son of Bazil and Lodoviga *nee*' Liguran, born in Romania on the 22<sup>nd</sup>

December, 1980 and residing at 'Kosi Farm', Count Salvatore Manduca Street, Mtarfa and holder of Maltese identity card number 66367A;

## To Rostas Mircea-Remus:

With having committed several acts by them, even if at different times, which constitute violations of the same provision of the law, and which were committed in pursuance of the same design, on the 11<sup>th</sup> August, 2011 at about eleven o' clock in the evening (23.00 hrs), whilst at The Strand, Sliema;

1. Committed theft of several mobile phones, which theft is aggravated by value, which exceeds the amount of two hundred and thirty-two euro and ninety-four cents ( $\in$ 232.94) but does not exceed two thousand and three hundred and twenty-nine euro and thirty-seven cents ( $\notin$ 2,329.37), and by time, to the detriment of several persons;

2. Also on the same date, time, place and circumstances in a public place importuned several persons to beg alms;

### To Anghel Zabar only:

1. On the 11<sup>th</sup> August 2011, at about half past eleven at night (23.30hrs), whilst in Sliema, reviled, or threatened, or caused a bodily harm to any person lawfully charged with a public duty, being Ps 1354 C. Coppola and Pc 711 R. Magro, while in the act of discharging their duty or because of their having discharged such duty, or with the intent to intimidate or unduly influence them in the discharge of such duty;

2. Also for having on the same date, time and circumstances publicly uttered any obscene or indecent words, or made obscene acts or gestures, or in any other manner offended the public morality, propriety or decency;

3. Also on same date, time and circumstances wilfully disturbed the public good order or the public peace with shouting;

Having heard the plea of guilt;

Having seen the records of the case;

Having asked the accused if they sufficient time to think about his plea of guilt and whether they were aware of the penalties tied to these charges for which questions the accused answered in the affirmative and confirmed their plea of guilt;

Finds the accused guilty as charged;

Having seen section 28 (a) et seq of Chapter 9 of the Laws of Malta;

Condemns the accused Rostas Mircea-Remus to a term of imprisonment of two (2) years which term shall not elapse within a period of three and a half (3 1/2) years from today and as far as the accused Anghel Zabar to a term of imprisonment of two (2) years which term shall not elapse within a period of four (4) years for today.

The Courts orders that these acts are to be transmitted to the attorney general according to law since the prosecution did not have the consent for this case to be tried summarily.
