The Police (Ins. Luke Bonello) (Ins. Godwin Scerri) vs Mimmi Amanda Pernilla Bjorkland

The Court;

Having seen the accusations brought against **Mimmi Amanda Pernilla Bjorkland** of 16 years, born in Ekenas Finland on the 14<sup>th</sup> June 1995, residing at Giorgianis Room number 223, St. Augustine Street, St. Julians holder of Finish Passport number PA1210854;

With having on the 3<sup>rd</sup> May 2012 at about 03:00am, whilst being in St. Julians:

1) Reviled, or threatened, or caused bodily harm to any person lawfully charged with a public duty, while in Informal Copy of Judgement

the act of discharging their duty or because of them having discharged such duty, or with intent to intimidate or duly influence them in the discharge of such duty;

2) Furthermore, with having on the same date, time and place, assault or resist by violence or active force not amounting to public duty when in the execution of the law or of a lawful order issued by a competent authority;

3) Furthermore, with having on the same date, time and place, caused injuries of sloight nature on the person of PC 901 Chris Attard, as certified by Dr. Maureen Bezzina holder of medical register number 5271;

4) Furthermore, with having on the same date, time and place, used force agiaonst PC 901 Chris Attard with intent to assault, annoy or hurt him or others;

5) Furthermore, with having on the same date, time and place, wilfully disturbs the public good order or the public peace;

6) Furthermore, with having on the same date, time and place, disobeyed the lawful orders of any authority or of any person entrusted with a public service;

7) Furthermore, with having on the same date, time and place,, was found drunk and incapable of taking care of herself;

1. received a passport transferred to him by any other person (Art 3 (b) of Chapter 61 of the Laws of Malta)

2. made use, or attempted to make use of a passport issued to any other person (Art 4 of Chapter 61 of the Laws of Malta)

3. in relation to any information to be given under or for purposes of Immigration Act, made or caused to be made any false return. False return or false representation (Art 32(1)(c) of Chapter 217 of the Laws of Malta) Informal Copy of Judgement

4. rendered himself a recidivist in terms of Art 49 and 50 of Chapter 9 of the Laws of Malta.

Having heard the plea of guilt;

Having seen the records of the case;

Having seen the consent of the attorney general for this case to be tried summarily according to article 370(4) Chapter 9 of the Laws of Malta;

Finds the accused guilty as charged;

Having seen articles 95(1), 96, 221, 339(1)(d), 338 (dd) (ee) (ff) of Chapter 9 of the Laws of Malta;

Having seen the clean conduct sheet of the accused;

Discharges the accused with the condition that she does not commit any other offense within a priod of one (1) year from today in terms of article 22 of Chapter 446 of the Laws of Malta;
