

## COURT OF MAGISTRATES (MALTA) AS A COURT OF CRIMINAL JUDICATURE

## Marko Zukic of 26 years, son of Gojko and Stojanka nee` Sucur born in Serbia on the 3<sup>rd</sup> of March, 1986, residing at Mellieha holder of Serbian passport with number SRB009544174

The Court;

Having seen charges brought against accused who was charged with having on the 2<sup>nd</sup> August 2012 at about 05:30am, whilst being at St. Julians:

1. Without intent to kill or to put the life of Alberto Gonvalves Amorim and Luciano Cesar Leite in manifest jeopardy caused the mentioned Alberto Gonvalves Amorim and Luciano Cesar Leite grievous injuries. 2. Furthermore with having on the same date, time, place and circumstances, without intent to kill or to put the life of Lilian Ronsoni Mendes and Carina Daniela Gomes Da Silva in manifest jeopardy caused the mentioned Lilian Ronson Mendes and Carina Daniela Gomes Da Silva slight injuries.

3. Furthermore with having on the same date, time, place and circumstances used force against Albert Gonvalves Amorim, Luciano Cesar Leite, Lilian Ronsoni Mendes and Carina Daniela Gomes Da Silva with intent to insult, annoy or hurt them or others.

4. Furthermore with having on the same date, time, place and circumstances operated as a private guard agency or acted as a private guard or offered his services as such, without having the relative licence from the Commissioner of Police.

5. Furthermore with having on the same date, time, place and circumstances, during an accidental affray, during which Alberto Gonvalves Amorim, Luciano Cesar Leite, Lilian Ronsoni Mendes and Carina Daniela Gomes Da Silva suffered bodily harm he had active part against the injured persons.

Having seen documents exhibited;

Having seen the Attorney General's consent dated 28<sup>th</sup> June, 2011, for the case to be dealt summarily by this Court;

Informal Copy of Judgement

Having heard accused plead guilty to the charges brought against him which guilty plea was reaffirmed after the accused was given adequate time to reconsider same.

Having heard submissions regarding the punishment to be inflicted;

Considers;

That in view of the guilty plea filed by the accused the Court finds him guilty as charged.

That in considering the punishment to be inflicted the Court is taking into consideration the early guilty plea filed by the accused and his clean criminal record.

Consequently the Court after having seen sections 214, 215, 288, 218(1)(a)(b), 237(b), 221, 17(h) of Chapter 9 of the Laws of Malta, and articles 5 and 25(b) of Chapter 389 of the Laws of Malta finds accused guilty as charged and condemns him to a period of two (2) years imprisonment which period of imprisonment after having seen article 28A of Chapter 9 of the Laws of Malta is being suspended for three (3) years from today and also condemns him to pay a fine of one hundred euros (€100).

The Court is warning the convicted person of the consequences according to law should he commit another crime during the period of this sentence.

The Court after having seen article 28H of Chapter 9 of the Laws of Malta orders the convicted person to pay injured party Luciano Cesar Leite the sum of one thousand euros ( $\in$ 1,000) and this within six (6) months from today.
