The Court,

Rat l-imputazzjonijiet li permezz taghom Valeriu Pileandra ta' 29 sena, iben Auriel u Mariona nee' Chiriac, imwieled nhar it-8 ta' Ottubru, 1984 gewwa Romania, residenti Flt 2 Nina Flts Triq l-Istasja, Swieqi u detentur ta' numru tal-karta ta' l-identita' numru 61313(A).

Gie akkuzat talli;

Nhar l-20 ta April 2013, bejn il-15.50hrs u 18.00hrs, gewwa is-Swieqi u f'dawn il-gzejjer:

1. Talli ghamel hsara ghad detriment ta Augustin Cotea l-ammont tal-hsara ma jkunx jiskorri elf mija u erbgħa u sittin euro u disgħa u sittin centezmu (1,164.69), imma jkun izjed minn mija u sittax-il euro u sebgha u erbghin centezmu (116.47) u

2. Talli mingħajr il-hsieb li joqtol jew li jqiegħed il-hajja ta' Marian Duminica f'periklu car, ikkaguna hsara hafifa fil-gisem jew fis-sahha tiegħu.

3. u talli volontarjament il-bon-ordni jew il-kwiet pubbliku.

Heard evidence.

Seen the acts of the Case and exhibited documents.

Seen the Attorney General's consent exhibited as Doc SDA1 and noted that accused Valeriu Pileandra has no objection that his Case be dealt with summarily.

Noted that in today's Sitting there appeared witness Augustin Cotea who declared that he does not wish to give evidence in this Case since he is accused in another Case regarding this incident and furthermore declared that he is renouncing to the criminal action against the accused wherever applicable.

Noted that in today's Sitting accused pleaded guilty to the third (3.) charge brought against him.

The Court warned accused in the most solemn manner as to the consequences of his admission of guilt and gave him some time to decide whether to confirm his admission of guilt or not, and having been asked whether he confirms his admission of guilt or not, the accused confirmed that he is pleading guilty to the third (3.) charge brought against him.

Seen Section 338 (dd) of Chapter 9 of the Laws of Malta.

Informal Copy of Judgement

Regarding the first (1.) charge brought against accused Valeriu Pileandra finds said accused not guilty of this charge since not sufficiently proven and therefore acquits said accused of this charge.

Regarding the second (2.) charge brought against accused Valeriu Pileandra declares exhaustion of proceedings owing to the renunciation by complainant Augustin Cotea.

Regarding the third (3.) charge brought against accused Valeriu Pileandra finds said accused guilty of this charge on admission of guilt and condemns said accused to the punishment of fifty eight Euro (Euro 58) fine (ammenda).
